The FTC opposed the Merger as anticompetitive and, in June 2017, the parties abandoned the Merger and instead entered into an asset purchase agreement for the purchase of certain Rite Aid stores by Walgreens. Our clients were Rite Aid investors who purchased Rite Aid common stock in reliance on Walgreens' public statements about the FTC's review of the Merger. Trial is scheduled to begin in June 2024.</p> <p>Walgreens – through its litigation counsel at Weil, Gotshal & Manges LLP ("Weil") – has proffered Benjamin Gris as a proposed expert in the Walgreens Civil Action. Mr. Gris is the former head of the FTC's Mergers II Division, and held that position during the time the Merger was pending. He left the FTC in 2018 and currently serves as a partner at Shearman & Sterling.
