FEMALE ANNOUNCER: The NutriMost Ultimate Fat Loss System is transforming people's lives.

16 viruses and other microbes, resulting in a complete
17 transformation of your body in less than 40 days.

18 DR. RAY WISNIEWSKI: NutriMost is unlike
19 anything else. Other programs aren't part of the
20 solution, they're part of the problem. Let's take a look
21 at the obesity trends put out by the United States
22 Government. As you can see, in 1990, most states had
23 more than 10 to 14 percent obesity. Yet, by 1993, we had

9 seemed like the first week and then the second week I was
10 like losing like three pounds a day, then four pounds
11 a day and then it slowed up some. But, yeah, it was just
12 -- it was coming off like that. And it was noticeable
13 after the second week. Yeah. And then I felt a lot

15 My name is Joe and so far I've lost about 70

23 cholesterol, sleep apnea. He was on tons of medications.

19 doctor-supervised, guaranteeing results.

20 Step one, hydrating and cleansing your body
21 with pure alkaline water works to restore your body to
22 healthy levels of acidity.

23 DR. RAY WISNIEWSKI: The NutriMost Ultimate Fat
24 Loss System utilizes specialized technology that brings
25 water into the cell that's strongly anti-oxidant, that

1 oxygenates and alkalizes the body, which energizes the
2 cells and helps bring the body into a healing and fat-
3 burning state.

4 FEMALE ANNOUNCER: Second, we implement a plan
5 of nutritional detoxification.

6 DR. RAY WISNIEWSKI: See, your body is
7 incredibly intelligent. It protects itself by storing
8 chemicals and toxins in fat. So, in order to release and
9 burn that fat, you have to detoxify the body, both
10 systemically and at the cellular level. See, the thing
11 is, when you can get rid of the toxins, that allows the
12 body to be able to release the fat to be burned since

3 NutriMost resonant frequency technology.

4 DR. RAY WISNIEWSKI: We all gain weight
5 differently due to our hormones. See, some carry weight
6 in their belly, some in their buttocks, others in their
7 arms and their legs. NRF technology is the key to
8 solving your body's specific imbalances. NRF stands for
9 NutriMost resonant frequency technology. Our NRF scan
10 finds your ultimate fat-burning zone by utilizing
11 electrical impedance resonant frequency technology with
12 galvanic skin response. Your NRF scan can determine and
13 create unique formulas that are specific for your body.
14 These formulas are more unique than your fingerprint. It
15 is so customized and specific that no two people are ever
16 the same.

17 The technology is really amazing, which is why
18 I think it is one of the greatest breakthroughs in
19 natural health care. Let me explain how this technology
20 works. If you had an allergy to pollen, in the presence
21 of pollen, your cells would have a cellular response.
22 See, everything in life has a resonant frequency. If we
23 would take the resonant frequency of pollen and subject
24 that to those same cells, those cells would have the
25 exact same cellular response as if it was pollen. So, in

1 other words, without pollen present, we could produce the
2 exact same response, the exact same experience.

3 The technology takes a baseline of the
4 frequency of any particular substance of the body, then

5 vitamins and minerals. There's a detox formula for

10 FEMALE ANNOUNCER: Step four of the NutriMost
11 approach is our proprietary system to reset your
12 hypothalamus and weight set point so you never gain the
13 weight back.

14 DR. RAY WISNIEWSKI: When you combine the
15 NutriMost Ultimate Fat Loss System protocols with NRF
16 technology, you are not only able to get into that
17 optimum fat-burning zone, but your body is also able to
18 enter into an optimal healing zone, known as autophagy.
19 AUTOPHAGY is where your body innately knows to eliminate
20 the bad, degenerated cells and replace them with good,
21 healthy cells, allowing the body to heal and regenerate
22 from a number of health challenges, including acid
23 reflux, thyroid conditions, diabetes, psoriasis, eczema,
24 high blood pressure, high cholesterol, sleep apnea,
25 asthma, fatty liver, lupus and other health and

1 autoimmune challenges. NRF technology allows us to enter
2 that perfect healing zone and fat-burning zone, allowing
3 us to target your abnormal fat.

4 You have three types of fat. You have your
5 normal fat reserves that are readily used for muscle and

15 cravings, why you'll feel great and be energized.
