

My name is Alisen Huske + I am a 3<sup>rd</sup> yr. Medical Student at Wash. U. in St. Louis. I 100% support the Fairness to Contact Lens Consumers Act of 2003 both as a contact lens wearer and as a soon-to-be physician. First and foremost, a patient is entitled to his/her prescription free of extra charges + entitled to choose from whom to buy contacts or glasses. There is no medical reason why a patient must fill his/her prescription at a particular pharmacy versus another + the same should be true of contacts. Patient follow-up can be achieved by limiting # of refills or time in which a script may be filled. I recently saw the ophthalmologist for a renewal of my contact script (2/10/04). I was told that I could have my script after I returned 1 week later for my follow-up visit for the trial lenses I was given (I've been with the same script + lenses for last 8 years) I had my follow-up visit as instructed + then was told I must purchase my 1<sup>st</sup> box of contact with that same doctor's office before I could have my script. The Dr. tried to say it was for the purpose of "follow-up"; I said "I've had my follow-up, my eyes are okay, right?", yes, they were. This
