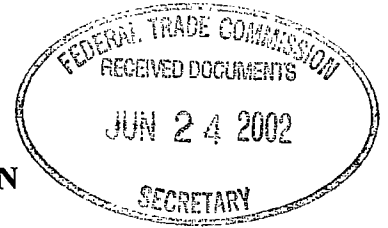



**MSC.SOFTWARE CORPORATION'S AND COMPLAINT COUNSEL'S  
JOINT MOTION TO AMEND THE SECOND REVISED SCHEDULING ORDER**


