6	(Music playing.)
7	ON SCREEN: The Debbie & Kevin Show
8	KEVIN TRUDEAU: Welcome to the Debbie & Kevin
9	Show. I'm Kevin Trudeau.
10	DEBBIE FLET: And I'm Debbie Flet (phonetic).
11	KEVIN TRUDEAU: We have a great show today. If
12	you have pain, pain
13	DEBBIE FLET: Which we all do.
14	KEVIN TRUDEAU: Well, we all have pain. If you
15	have pain or know someone that has pain, stay with us.
16	We have Darrell Stoddard, who's the author of Pain-Free
17	For Life. He's also the founder of the Pain Research
18	Institute and he has discovered the cause of pain. Now,
19	if you can discover the cause of pain, whether it's lower
20	back pain, knee pain, arthritis pain, any type of pain
21	that you've experienced, headaches, migraines, if you
22	know the cause of pain, then potentially, you could find
23	a cure for pain.
24	Darrell Stoddard has put together Pain-Free For
25	Life and has discovered and put together a system that

can get rid of pain, not just temporarily, but 1 2 potentially permanently eliminate pain. 3 Darrell, thanks for being on the show. DARRELL STODDARD: Thank you, Kevin. 4 KEVIN TRUDEAU: Glad to finally meet you. 5 DARRELL STODDARD: Nice to meet you. 6 7 DEBBIE FLET: Thanks, Darrell. 8 DARRELL STODDARD: Thank you. KEVIN TRUDEAU: Now, I interviewed you on my 9 radio show, the Kevin & Kim Show, and we talked about how 10 11 you discovered this -- or I quess did you discover the cause of pain or did you just find it out? 12 13 DARRELL STODDARD: I didn't really discover the cause of pain. I verified the Chinese definition of 14 15 pain. ON SCREEN: Darrell Stoddard 16 17 Inventor & Pain Specialist 18 DARRELL STODDARD: It's something that the 19 Chinese have known for 2,000 years that Western medicine has never properly investigated. And the Chinese say 20 pain is caused by the blockage of chi or the stagnation 21 22 of blood. Well, Western medicine thinks that's just 23 Oriental mysticism. But it's a quantifiable, measurable 24 phenomenon. 25 Chi is the endogenous electrical signals in

living tissue that can be measured and quantified. 1 Where 2 there's pain, there's always more electrical resistance, 3 which indicates the blockage of the chi, as the Chinese have said for 2,000 years. So, I've just found a way to 4 scientifically verify the Chinese definition of pain. 5 Ι didn't discover it, the Chinese did 2,000 years ago. 6 KEVIN TRUDEAU: Now, you founded the Pain 7 8 Research Institute? DARRELL STODDARD: That's correct. 9 KEVIN TRUDEAU: And you developed a simple tape 10 11 _ _ DARRELL STODDARD: 12 Yes. 13 KEVIN TRUDEAU: -- that can be applied to the skin that eliminates pain. 14 15 DARRELL STODDARD: That's correct. KEVIN TRUDEAU: Now, how does that work? 16 DARRELL STODDARD: Well, it is a space age 17 18 conductive mylar that connects the broken circuits that 19 cause the pain. I treated pain electrically by stimulating the body to try and reconnect the broken 20 circuits that cause the pain. I did auricular therapy, 21 22 which is stimulating acupuncture points in the ear to 23 reconnect the broken circuits, but wasn't successful in enough of the time to really, really be pleased with what 24 I was doing. 25

And then I woke up in the middle of the night 1 2 and I thought, I know what pain is, pain is broken electrical connections between cells and living tissue. 3 And I thought if I can find something to connect or 4 something -- a good conductor to connect those broken 5 circuits, I would be able to permanently eliminate the 6 pain and help the people that I hadn't been able to help 7 8 before and I -- so, I found a company that makes this space age conductive mylar and we had an FDA-approved 9 adhesive put on it and made it into a tape and got a 10 11 patent on it, and that was the beginning of Biotape. DARRELL STODDARD: My qualifications are, I 20 have measured the electrical resistance at the site of 21 22 pain in more than 18,000 patients and I can say without 23 any qualification, without any hesitation, pain is when 24 there is more electrical resistance, which is just what

stagnation of blood. The stagnation of blood is 1 2 dehydration. It's so simple. 3 DEBBIE FLET: How do we measure something like this, Darrell? 4 DARRELL STODDARD: Well, you can measure the 5 electrical resistance between two points on the body with 6 this instrument that I have used. 7 8 DEBBIE FLET: Right. DARRELL STODDARD: And I can show you on your 9 palm, everybody conducts on their palm. 10 11 DEBBIE FLET: Oooh, I'm beeping. 12 DARRELL STODDARD: See, she's conducting there. 13 DEBBIE FLET: Right. 14 DARRELL STODDARD: But maybe on her calf, she might not be or on the back of her hand. 15 DEBBIE FLET: Ooh. 16 17 DARRELL STODDARD: See, she's not conducting as 18 well there. So, she's a little bit dehydrated. 19 DEBBIE FLET: That makes sense. I'm actually thirsty as we speak. 20 (Laughter.) 21 22 DARRELL STODDARD: Yes. 23 DEBBIE FLET: Right. So, I mean, is it just 24 the machine and where does the Biotape come into it? 25 DARRELL STODDARD: Well, we -- what I do when I

see patients clinically, I find where the connections are
 broken.

3 DEBBIE FLET: Okav. DARRELL STODDARD: And then I apply the Biotape 4 and it permanently connects the broken signals. 5 DEBBIE FLET: So, it conducts down the tape? 6 DARRELL STODDARD: Yes, that's correct. 7 8 DEBBIE FLET: Right. KEVIN TRUDEAU: Now, this is a study -- this is 9 10 a study or a paper that you presented. 11 DARRELL STODDARD: Yes. This is a paper that was published in a medical journal. 12 13 KEVIN TRUDEAU: Okay. Now, as I was reading this before -- and this is why I had you on my radio show 14 15 -- some of the people that are in this published paper, that was published in a medical journal --16 DARRELL STODDARD: Yeah, the case studies. 17 18 KEVIN TRUDEAU: These are case studies. Low 19 back pain so severe, she couldn't stand or walk, used 20 magnets for a week. The magnets did nothing. Biotape relieved pain immediately and patient could stand and 21 22 walk. 23 DEBBIE FLET: Wow. 24 KEVIN TRUDEAU: So, this was an instant result. 25 DARRELL STODDARD: Yes, yes. This was -- this

was really an interesting case. This patient came to me in a wheelchair, couldn't stand or walk, and she had a large magnet on her back for 10 days that they have sold so many of. In fact, I have the corporate report for the company that makes those magnets. They have sold \$11 billion worth of those magnets.

Well, until she had had the magnet on there and
it hadn't done anything, and as soon as we -- as soon as
I put the tape on, she stood up and walked out.

DARRELL STODDARD: He's a refrigerator magnet and here's some Biotape. This is the adhesive side of the Biotape. The surface of the Biotape is skin -- is flesh-colored, but this is the adhesive side of the Biotape. Here's the Biotape. You see it conducts electricity --

DARRELL STODDARD: It's a mystery why magnets 1 2 Nobody can really give you good answers why work. 3 magnets may help pain. But we know exactly why Biotape helps pain. 4 KEVIN TRUDEAU: 5 So, this is the Biotape here? DARRELL STODDARD: That's right. 6 7 KEVIN TRUDEAU: So, if a person has pain, let's 8 say a headache --That's right. 9 DARRELL STODDARD: 10 KEVIN TRUDEAU: -- or arthritis pain or knee 11 pain or lower back pain or any pain in their body, they just peel this off --12 13 DARRELL STODDARD: That's right. 14 KEVIN TRUDEAU: They can cut it, right --15 DARRELL STODDARD: That's right. KEVIN TRUDEAU: -- to the size they need? 16 17 DARRELL STODDARD: Um-hum. 18 KEVIN TRUDEAU: And they just apply it to the skin. 19 20 DARRELL STODDARD: Where they hurt, that's 21 correct. 22 KEVIN TRUDEAU: Where they hurt. So, you can 23 cut it to the size you want? 24 DARRELL STODDARD: Yeah. Yeah, see, this side is flesh-colored and the underneath side is (inaudible). 25

KEVIN TRUDEAU: Okay. So, let's say that you 1 2 had a headache. 3 DARRELL STODDARD: Okav. KEVIN TRUDEAU: Actually, Debbie, you just got 4 into a car crash the other day. 5 I did actually. I'm just sitting 6 DEBBIE FLET: here with this stiff shoulder thinking, this sounds 7 8 perfect. DARRELL STODDARD: Okay, so --9 DEBBIE FLET: But I do have a very stiff --10 11 KEVIN TRUDEAU: She has pain in her shoulder. DEBBIE FLET: Yeah. 12 13 DARRELL STODDARD: We'd need to put it across here and across here. 14 15 KEVIN TRUDEAU: Okav. 16 DEBBIE FLET: Right. 17 KEVIN TRUDEAU: Okay. And then how soon before 18 she would see or feel results? 19 DARRELL STODDARD: Very often it's immediate. If she's not dehydrated, she will feel results almost 20 21 immediately. 22 KEVIN TRUDEAU: Okay. And let me continue on 23 with some of these. Very painful frozen shoulder, 24 Biotape applied, received near 100 percent instant relief. 25

DARRELL STODDARD: 1 Yes. 2 KEVIN TRUDEAU: Is that common where people see 3 an instant elimination of pain? DARRELL STODDARD: More often than you would 4 It really is. 5 believe. KEVIN TRUDEAU: Back pain and headaches from an 6 7 auto accident. Here we go. 8 DEBBIE FLET: Right. KEVIN TRUDEAU: Unable to work for 18 months, 9 lumbar spinal surgery scheduled in one week, pain reduced 10 11 85 percent with application of tape, pain completely gone next day, surgery canceled. 12 13 DARRELL STODDARD: That's right. Wow, that's amazing. 14 DEBBIE FLET: 15 DARRELL STODDARD: And that patient is still His pain was so severe that he hadn't been able to 16 well. work for three years and it caused a divorce. He came to 17 18 me, 85 percent of his pain was gone. Wasn't it 85 19 percent? 20 KEVIN TRUDEAU: Eighty-five percent, yeah. Before he left the room. 21 DARRELL STODDARD: 22 So, he canceled his back surgery Sunday morning. I saw 23 him on a Saturday night. Eighty-five percent of his pain 24 was gone before he left the room and Sunday morning, 100 percent of his pain was gone. Monday, he canceled the 25

surgery that he was going to have on his lower back the 1 2 next Friday and hasn't needed another treatment since, 3 and that's been --DEBBIE FLET: Wow. 4 DARRELL STODDARD: What was the date on that? 5 KEVIN TRUDEAU: That was -- there isn't a date 6 7 on this one. DARRELL STODDARD: There should have been --8 there should be a date on it, I thought. 9 KEVIN TRUDEAU: No, there's not a date on that 10 11 one. DARRELL STODDARD: No, there may not be a date 12 13 on it. But that's been about five years ago and I ran He's now managing a department in a --14 into him. 15 KEVIN TRUDEAU: Still no pain? DARRELL STODDARD: That's right. 16 17 DEBBIE FLET: Wow. 18 DARRELL STODDARD: He's managing a department. 19 KEVIN TRUDEAU: So, you believe this is the actual cause of pain. 20 DARRELL STODDARD: 21 Yes. 22 KEVIN TRUDEAU: And up until now, people take 23 what for pain, aspirin, ibuprofen, Tylenol? 24 DEBBIE FLET: Drugs basically. DARRELL STODDARD: That's right. 25

1 KEVIN TRUDEAU: Pretty much drugs.

2 DEBBIE FLET: Yeah.

3 KEVIN TRUDEAU: They also use skin things, like 4 Super Blue Stuff has been on television for a long time. 5 There's a bunch of other roll-ons, all different types of 6 products to "eliminate" pain. What do those products do? 7 How do they work?

DARRELL STODDARD: Well, the pain medication --8 and this is the real, real flaw in the Western medical 9 approach to pain is the only thing we know how to do is 10 11 shut off the pain signal. Because we've never defined what pain is, we can't correct what causes pain. 12 That's 13 why they just talk about pain management. You can't talk about healing pain because how do you know whether 14 somebody's healed or not if you don't know what caused 15 the pain in the first place? 16

KEVIN TRUDEAU: Um-hum.

18 DEBBIE FLET: Right.

17

19DARRELL STODDARD: And that's the big problem20with the Western approach to pain.

21 KEVIN TRUDEAU: So, all of these -- all of 22 these other products then, the electrical signal between 23 the tissues is still impeded?

24 DARRELL STODDARD: Yes.

25 KEVIN TRUDEAU: But what it is is the pain

stops going to the pain? 1 2 DARRELL STODDARD: Yeah, the brain just doesn't 3 know that the connections are broken. KEVIN TRUDEAU: It doesn't know it's --4 DEBBIE FLET: Right. 5 DARRELL STODDARD: That's -- pain medication 6 7 just shuts off the pain signal. That treats the pain 8 signal. That doesn't treat the cause of the pain. 9 KEVIN TRUDEAU: But this --DARRELL STODDARD: 10 Yes. 11 DEBBIE FLET: So --12 KEVIN TRUDEAU: -- corrects the cause? 13 DARRELL STODDARD: Corrects the cause of the pain. 14 KEVIN TRUDEAU: Which means it could be gone 15 forever? 16 That's right. 17 DARRELL STODDARD: 18 DEBBIE FLET: So, obviously, you have to wear 19 the tape for a certain amount of time and then that 20 connection is cured. DARRELL STODDARD: 21 Yes. 22 DEBBIE FLET: So, when you take the tape off, 23 it continues to be painless. 24 DARRELL STODDARD: Yes. We correct the broken electrical signals on the surface of the skin 25

immediately, but sometimes for it to be completely
 healed, it has to stay on.

3 DEBBIE FLET: All right. Theoretically, the body DARRELL STODDARD: 4 knows how to heal itself. When it doesn't, it's because 5 the signal can't get through to tell those cells how to 6 repair. And with the tape, we not only connect the 7 broken circuits on the surface, but we allow for a signal 8 to go through for those cells to repair for permanent 9 healing to take place. 10

KEVIN TRUDEAU: Here's another case study.
 DEBBIE FLET: Wow.

13 KEVIN TRUDEAU: Pain so severe in low back, the 14 patient couldn't walk. Biotape applied. There was 15 almost immediate miraculous relief. Pain relieved again 16 with Biotape when the patient (sic) started to return.

DARRELL STODDARD: That's correct. 12 13 KEVIN TRUDEAU: The type of water to drink to make sure they get hydrated. 14 DEBBIE FLET: We have a caller and this person 15 is someone you've actually worked with, I believe. 16 So, let's go to our caller. 17 18 KEVIN TRUDEAU: Hi, what's your first? 19 JELAINE: Jelaine. 20 KEVIN TRUDEAU: Hi, how are you? 21 JELAINE: Great. KEVIN TRUDEAU: Tell us about your results with 22 23 the Biotape. 24 I just recently had both knees JELAINE: replaced and I was in such severe pain, I couldn't sleep 25

Well, I got her home and I couldn't --4 I couldn't treat her in the hospital because she was 5 under their care instead of mine. But the day she got 6 7 home, I treated her across the incision and I put the --8 I put the Biotape across the incision --
