
**RESPONDENTS' MOTION TO COMPEL ADVOCATE HEALTH CARE TO

Respondents Evanston Northwestern Healthcare and ENH Medical Group (collectively "Respondents") respectfully submit this Motion to Compel Advocate Health Care ("Advocate") to Produce Documents Requested by Subpoenas Duces Tecum in accordance with Commission Rule § 3.38(a)(2).
