21	Plaintiff, the Federal Trade Commission ("FTC" or "Commission"),		
22	through its undersigned attorneys, for its Complaint alleges:		

1. Plaintiff brings this action under Section 13(b) of the Federal Trade Commission Act ("FTC Act"), 15 U.S.C. § 53(b), to secure a permanent injunction, restitution, disgorgement, and other equitable relief against Sagee U.S.A. Group, Inc., a California corporation, its wholly-owned subsidiary Sagee U.S.A. Group, Inc., a Nevada corporation, and Xiao Hua Li ("Defendants") for engaging in unfair or deceptive acts or practices in connection with the

advertising, marketing, and sale of products purporting to treat, prevent, or cure such conditions as dementia, Alzheimer's Disease, and various brain disorders, in violation of Sections 5(a) and 12 of the FTC Act, 15 U.S.C. §§ 45(a) and 52.

JURISDICTION AND VENUE

This Court has jurisdiction over this matter pursuant to 15 U.S.C.
 §§ 45(a), 52, and 53(b), and 28 U.S.C. §§ 1331, 1337(a), and 1345.

3. Venue in this District is proper under 15 U.S.C. § 53(b) and 28 U.S.C. § 1391(b) and (c).

PLAINTIFF

12 4 Plaintiff, the Federal Trade Commission, is an independent agency of 13 the United States Government created by statute. 15 U.S.C. §§ 41-58. The 14 Commission enforces Section 5(a) of the FTC Act, 15 U.S.C. § 45(a), which 15 prohibits unfair or deceptive acts or practices in or affecting commerce. The Commission also enforces Section 12 of the FTC Act, 15 U.S.C. § 52, which 16 prohibits false advertisements for food, drugs, devices, services, or cosmetics in 17 or affecting commerce. The Commission may initiate federal district court 18 proceedings to enjoin violations of the FTC Act and to secure such equitable 19 relief, including restitution, as may be appropriate in each case. 15 U.S.C. 20 § 53(b). 21

DEFENDANTS

Defendant Sagee U.S.A. Group, Inc., a California corporation
 ("Sagee-California"), has its principal place of business at 18688 E. San Jose
 Ave., City of Industry, CA 91748. At all times relevant to this Complaint, acting
 alone or in concert with others, Sagee-California has manufactured, marketed,
 distributed, and sold Sagee to consumers throughout the United States. Sagee-

California is a wholly-owned subsidiary of Sagee U.S.A. Group, Inc., a Nevada corporation.

6. Defendant Sagee U.S.A. Group, Inc., a Nevada corporation ("Sagee-Nevada"), is incorporated in and resides in the District of Nevada.

7. Defendant Xiao Hua Li is an officer of Sagee-California and a coowner of Sagee-Nevada. COMMERCE

8. The acts and practices of Defendants alleged in this Complaint have been in or affecting commerce, as "commerce" is defined in Section 4 of the FTC Act, 15 U.S.C. § 44.

DEFENDANTS' COURSE OF CONDUCT

9. Since at least 2002, Defendants have advertised, labeled, offered for sale, sold, and distributed Sagee, a product purporting to treat, prevent, or cure such conditions as dementia, Alzheimer's Disease, and various brain disorders. Defendants primarily advertise and offer Sagee for sale through Chinese and Vietnamese-language newspapers, radio, and television stations. Their sales campaign has also included an Internet website, www.sagee.com.

SAGEE

10. Sagee is a dietary supplement in capsule form that purports to contain Ginseng Root, Red-Rooted Sage Root, Safflower, Lycium Berries Fruit, Dong Quai Root, Schisandra Fruit, Fo-Ti Root, Polygala Root, Sichuan Lovage Root, and Persica. The label directs consumers to take 3 capsules twice daily. The

retail price for a bottle of 90 capsules (a 15-day supply) is \$49.50, and the wholesale price is \$35.00, with some discounts for purchases of multiple bottles. Defendants' total gross sales of the product were \$1,139,190, for the period November 2002 through June 2003.

DEFENDANTS' ADVERTISEMENTS FOR SAGEE

11. To induce consumers to purchase Sagee, Defendants havedisseminated or caused to be disseminated newspaper, radio, television, andInternet advertisements, including but not limited to the attached Exhibits A andB. These advertisements contain, among other things, the following statementsand depictions:

a. "Sagee" can activate the dormant neural cells, and promote the migration from damaged brain cells to healthy ones. DEFENDANTS' VIOLATIONS OF THE FTC ACT

12. Section 5(a) of the FTC Act, 15 U.S.C. § 45(a), prohibits unfair or deceptive acts or practices in or affecting commerce. Section 12(a) of the FTC

Act, 15 U.S.C. § 52(a), prohibits the dissemination of any false advertisement in or affecting commerce for the purpose of inducing, or which is likely to induce, the purchase of food, drugs, devices, services, or cosmetics. For the purposes of Section 12 of the FTC Act, 15 U.S.C. § 52, Sagee is a "food" or "drug" pursuant to Section 15(d) of the FTC Act, 15 U.S.C. § 55(d). As set forth below, Defendants have engaged in such unlawful practices in connection with the marketing and sale of Sagee.

COUNT I

Unsubstantiated Disease Claims for Sagee

13. Through the means described in Paragraph 11, Defendants have represented, expressly or by implication, that Sagee:

Repairs damaged brain cells;

b. Improves memory, concentration, attentiveness, and response times;

c. Slows down the brain's aging process and relieves agingrelated conditions of the brain;

d. Treats or alleviates insomnia, migraine headaches, neuroticism, schizophrenia, tinnitus, autism, Alzheimer's Disease, cerebral embolism, cerebral hemorrhage, epilepsy, Parkinson's Disease, senile dementia, and stroke; and

e. Increases the brain activity and learning ability of people with mental handicaps.

14. Defendants did not possess and rely upon a reasonable basis that
substantiated the representations set forth in Paragraph 13 at the time the
representations were made. Therefore, the making of the representations set forth
in Paragraph 14 constitutes a deceptive practice, and the making of false
advertisements, in or affecting commerce, in violation of Sections 5(a) and 12 of

COUNT II

False Clinical Studies Claims for Sagee Through the means described in Paragraph 11, Defendants have 15. represented, expressly or by implication, that: Scientific studies prove that Sagee revitalizes and rejuvenates a. the brain: and Scientific studies prove that Sagee stimulates brain cells to h. regenerate, thereby repairing damage caused to brain cells by injury and disease. 16. In truth and in fact, Scientific studies do not prove that Sagee revitalizes and a. rejuvenates the brain; and Scientific studies do not prove that Sagee stimulates brain cells b. to regenerate, thereby repairing damage caused to brain cells by injury and disease. Therefore, Defendants' representations as set forth in Paragraph 15 are false or misleading and constitute a deceptive act or practice, and the making of false advertisements, in or affecting commerce, in violation of Sections 5(a) and 12 of the FTC Act, 15 U.S.C. §§ 45(a) and 52.

CONSUMER INJURY

17. Consumers throughout the United States have suffered and continue to suffer substantial monetary loss and may suffer physical injury as a result of Defendants' unlawful acts and practices. In addition, Defendants have been unjustly enriched as a result of their unlawful practices. Absent injunctive relief by this Court, Defendants are likely to continue to injure consumers, reap unjust

THIS COURT'S POWER TO GRANT RELIEF

18. Section 13(b) of the FTC Act, 15 U.S.C. § 53(b), empowers this Court to grant injunctive and such other relief as the Court may deem appropriate to halt and redress violations of the FTC Act. The Court, in the exercise of its equitable jurisdiction, may award other ancillary relief, including, but not limited to, recission of contracts and restitution, and the disgorgement of ill-gotten gains, caused by the Defendants' law violations.

PRAYER FOR RELIEF

WHEREFORE, Plaintiff FTC, pursuant to Section 13(b) of the FTC Act, 15 U.S.C. § 53(b), and the Court's own equitable powers, requests that this Court:

1. Permanently enjoin and restrain Defendants from violating Sections 5(a) and 12 of the FTC Act in connection with the advertising or sale of food, drugs, dietary supplements, devices, cosmetics, or other products, services, or programs.

2. Award such equitable relief as the Court finds necessary to redress injury to consumers resulting from the Defendants' violations of Sections 5(a) and 12 of the FTC Act, including, but not limited to, rescission of contracts and restitution, and the disgorgement of ill-gotten gains; and

3. Award Plaintiff the costs of bringing this action, and such other equitable relief as the Court may determine to be just and proper.
