Complaint

Plaintiff, the Federal Trade Commission ("FTC"), for its Complaint alleges:

1. The FTC brings this action under Section 13(b) of the Federal Trade Commission Act ("FTC Act"), 15 U.S.C. § 53(b), to obtain permanent injunctive relief, rescission or reformation of contracts, restitution, the refund of monies paid, disgorgement of ill-gotten monies, and other equitable relief for Defendants' acts or practices in violation of Sections 5(a) and 12 of the FTC Act, 15 U.S.C. §§ 45(a) and 52, in connection with the advertising, marketing and sale of various pest-control products, which purportedly treat and prevent bed bug and head lice infestations.

JURISDICTION AND VENUE

- 2. This Court has subject matter jurisdiction pursuant to 28 U.S.C. §§ 1331, 1337(a), and 1345, and 15 U.S.C. §§ 45(a) and 53(b).
- 3. Venue is proper in this district under 28 U.S.C. § 1391(b) and 15 U.S.C. § 53(b).

INTRADISTRICT ASSIGNMENT

4. Defendants have advertised their products in the County of San Francisco.

PLAINTIFF

- 5. The FTC is an independent agency of the United States Government created by statute. 15 U.S.C. §§ 41-58. The FTC enforces Section 5(a) of the FTC Act, 15 U.S.C. § 45(a), which prohibits unfair or deceptive acts or practices in or affecting commerce. The FTC also enforces Section 12 of the FTC Act, 15 U.S.C. § 52, which prohibits false advertisements for food, drugs, devices, services, or cosmetics in or affecting commerce.
- 6. The FTC is authorized to initiate federal district court proceedings, by its own attorneys, to enjoin violations of the FTC Act and to secure such equitable relief as may be appropriate in each case, including rescission or

reformation of contracts, restitution, the refund of monies paid, and the disgorgement of ill-gotten monies. 15 U.S.C. § 53(b).

DEFENDANTS

- 7. Defendant Springtech 77376, LLC ("Springtech 77376") also doing business as Cedarcide.com and Cedarcidestore.com, is a Texas limited liability company with its principal place of business at 612 Spring Cypress Road, Spring, Texas 77373. Springtech 77376 transacts or has transacted business in this district and throughout the United States. At times material to this Complaint, acting alone or in concert with others, Springtech 77376 has advertised, marketed, distributed, or sold pest-control products to consumers throughout the United States.
- 8. Defendant Cedarcide Industries, Inc. ("Cedarcide Industries") is a Texas corporation with its principal place of business at 612 Spring Cypress Road, Spring, Texas 77373. Cedarcide Industries transacts or has transacted business in this district and throughout the United States. At times material to this Complaint, acting alone or in concert with others, Cedarcide Industries has advertised, marketed, distributed, or sold pest-control products to consumers throughout the United States.
- 9. Defendant Chemical Free Solutions LLC ("Chemical Free Solutions") is a Texas limited liability company, with its principal place of business at 612 Spring Cypress Road, Spring, Texas 77373. Chemical Free Solutions transacts or has transacted business in this district and throughout the United States. Since March 2012, acting alone or in concert with others, Chemical Free Solutions has advertised, marketed, distributed, or sold pest-control products to consumers throughout the United States.
- Defendant Cedar Oil Technologies Corp. ("Cedar Oil
 Technologies") is a Texas corporation, with its principal place of business at
 2119 Old Ox Road, Spring, Texas 77373. Cedar Oil Technologies transacts or

has transacted business in this district and throughout the United States. At times material to this Complaint, acting alone or in concert with others, Cedar Oil Technologies has advertised, marketed, distributed, or sold pest-control products to consumers throughout the United States.

Defendant Dave Glassel is the owner, president, and director of 11. Springtech 77376, Cedarcide Industries, and Cedar Oil Technologies. He is an owner of Chemical Free Solutions and, through Cedar Oil Technologies, has acted as a manager of Chemical Free Solutions. At all times material to this Complaint, acting alone or in concert with others, he has formulated, directed, controlled, had the authority to control, or participated in the acts and practices of the corporate defendants, including the acts and practices set forth in this Complaint. Glassel has been responsible for the development, preparation, and placement of the advertisements and other marketing materials described below. He also has been responsible for the corporate defendants' efforts to obtain evidence to substantiate statements made in those advertisements and marketing materials. Glassel knew or should have known that the acts and practices alleged herein were occurring and were deceptive. Glassel, in connection with the matters alleged herein, transacts or has transacted business in this district and throughout the United States.

COMMERCE

12. At all times material to this Complaint, Defendants have maintained a substantial course of trade in or affecting commerce, as "commerce" is defined in Section 4 of the FTC Act, 15 U.S.C. § 44.

DEFENDANTS' BUSINESS ACTIVITIES DEFENDANTS' PRODUCTS

13. Since at least 2007, and continuing thereafter, Defendants have manufactured, advertised, promoted, offered for sale, sold, or distributed a line of pest-control products under the "BEST *Yet!*" brand to consumers throughout the

United States. Consumers have purchased these products through a variety of means, including but not limited to, directly from the Defendants by phone, through their website, www.cedarcidestore.com, and through www.amazon.com.

- 14. BEST *Yet!* purportedly consists of a liquid solution whose active ingredient is cedar oil.
- 15. Defendants' BEST Yet! "Get Rid Bed Bugs" Infestation product line includes the BEST Yet! Non Toxic "Get Rid Bed Bugs" spray (also known as "BEST Yet! Biting Insect Spray"), the BEST Yet! "Get Rid Bed Bugs" kit, the BEST Yet! "Get Rid Bed Bugs" fogger kit, and the BEST Yet! Hotel-Motel Natural Organic Bed Bug Eradication Kit. Defendants have marketed these products to individual consumers for personal use, and also to business consumers for use in larger buildings, such as hotels and rental properties.
- 16. Defendants' BEST *Yet!* "Head Lice Treatment" product line includes the BEST *Yet!* Louse Eradication Fluid and the BEST *Yet!* Head Lice Treatment Kit. Defendants have marketed these products to individual consumers for personal use, and also to school districts for public use.
- 17. The price of BEST *Yet!* products has ranged from \$29.95 to \$3,394.95.

DEFENDANTS' ADVERTISEMENTS

- 18. To induce consumers to purchase BEST *Yet!* products, Defendants have created, prepared, disseminated, or caused to be disseminated, by means such as the radio, the Internet, and their product labels and inserts, advertisements, including, but not limited to, the attached Exhibits A to N. These materials contain, among other things, the following statements:
 - a. "One Out of Five Americans" radio advertisement (Exhibit A, transcript, and Exhibit B, CD containing ad)

VIOLATIONS OF THE FTC ACT

- 19. Section 5(a) of the FTC Act, 15 U.S.C. § 45(a), prohibits "unfair or deceptive acts or practices in or affecting commerce."
- Misrepresentations or deceptive omissions of material fact constitute 20. deceptive acts or practices prohibited by Section 5(a) of the FTC Act.
- 21. Section 12 of the FTC Act, 15 U.S.C. § 52, prohibits the dissemination of any false advertisement in or affecting commerce for the purpose of inducing, or which is likely to induce, the purchase of food, drugs, devices, services, or cosmetics. For the purposes of Section 12 of the FTC Act, 15 U.S.C. § 52, BEST Yet! as marketed for the treatment of head lice in humans is a "drug" as defined in Section 15(c) of the FTC Act, 15 U.S.C. § 55(c).

Count I

Unsubstantiated Bed Bug Claims

Through the means described in Paragraph 18, Defendants have 22. Complaint Page -10-

- preventing bed bug infestations;
- c. Scientific studies do not prove that Best *Yet!* is more effective than synthetic pesticides at stopping and preventing bed bug infestations; and
- d. The EPA has not warned consumers to avoid all synthetic or chemical pesticides for the treatment of bed bug infestations. In fact, the EPA recommends a combination of techniques known as integrated pest management (IPM) an approach that includes prevention, monitoring, and limited use of chemical pesticides. The EPA, however, has warned consumers that they should never use, or allow anyone else to use, a pesticide indoors that is intended for outdoor use, as indicated on the label.
- 27. Therefore, the making of the representations set forth in Paragraph 25 constitutes a deceptive act or practice, in or affecting commerce, in violation of Section 5(a) of the FTC Act, 15 U.S.C. §§ 45(a).

Count III

Unsubstantiated Head Lice Claim

- 28. Through the means described in Paragraph 18, Defendants have represented, directly or indirectly, expressly or by implication, that:
 - a. BEST Yet! is effective in stopping head lice infestations;
 - b. BEST *Yet!* is effective in preventing head lice infestations;
 - c. BEST *Yet!* is effective in killing head lice eggs;
 - d. BEST *Yet!* dissolves the glue that binds head lice eggs (nits) to hair; and
 - e. BEST *Yet!* is effective in killing head lice and their eggs in a single treatment.
- 29. The representations set forth in Paragraph 28 were not substantiated

at the time they were made.

30. Therefore, the making of the representations set forth in Paragraph 28 constitutes a deceptive act or practice, and the making of false advertisements, in or affecting commerce, in violation of Sections 5(a) and 12 of the FTC Act, 15 U.S.C. §§ 45(a) and 52.

Count IV

False Head Lice Claim

- 31. Through the means described in Paragraph 18, Defendants have represented, directly or indirectly, expressly or by implication, that:
 - a. Scientific studies prove that Best *Yet!* is effective in stopping a head lice infestation; and
 - b. Scientific studies prove that BEST *Yet!* is effective in preventing head lice infestations.
 - 32. In truth and in fact:
 - a. Scientific studies do not prove that Best *Yet!* is effective in stopping a head lice infestation; and
 - b. Scientific studies do not prove that BEST *Yet!* is effective in preventing head lice infestations.
- 33. Therefore, the making of the representations set forth in Paragraph 31 constitutes a deceptive act or practice, and the making of false advertisements, in or affecting commerce, in violation of Sections 5(a) and 12 of the FTC Act, 15 U.S.C. §§ 45(a) and 52.

Count V

False Claims Regarding Defendants'

Affiliation with the Federal Government

- 34. Through the means described in Paragraph 18, Defendants have represented, directly or indirectly, expressly or by implication, that:
- a. Best *Yet!* was invented for the United States Army at the

- request of the United States Department of Agriculture ("USDA"); and
- b. The USDA has acknowledged Best *Yet!* as the number one choice of bio-based pesticides.
- 35. In truth and in fact:
 - a. Best *Yet!* was not invented for the United States Army at the request of the USDA; and
 - b. The USDA has not acknowledged Best *Yet!* as the number one choice of bio-based pesticides. In fact, at the time Defendants made this claim, Defendants were not active participants in the USDA's BioPreferred® program.

 Moreover, Best *Yet!* has neither been (1) identified by the USDA as a product for preferred federal purchasing under the BioPreferred® program, nor (2) certified to meet or exceed the USDA's stated biobased content standards by an independent third party lab.
- 36. Therefore, the making of the representations set forth in Paragraph 34 constitutes a deceptive act or practice, in or affecting commerce, in violation of Section 5(a) of the FTC Act, 15 U.S.C. § 45(a).

CONSUMER INJURY

37. Consumers have suffered and will continue to suffer substantial injury as a result of Defendants' violations of the FTC Act. In addition, Defendants have been unjustly enriched as a result of their unlawful acts or practices. Absent injunctive relief by this Court, Defendants are likely to continue to injure consumers, reap unjust enrichment, and harm the public interest.

THIS COURT'S POWER TO GRANT RELIEF

38. Section 13(b) of the FTC Act, 15 U.S.C. § 53(b), empowers this

Court to grant injunctive and such other relief as the Court may deem appropriate to halt and redress violations of any provision of law enforced by the FTC. The Court, in the exercise of its equitable jurisdiction, may award ancillary relief, including rescission or reformation of contracts, restitution, the refund of monies paid, and the disgorgement of ill-gotten monies, to prevent and remedy any violation of any provision of law enforced by the FTC.

PRAYER FOR RELIEF

Wherefore, Plaintiff FTC, pursuant to Section 13(b) of the FTC Act, 15 U.S.C. § 53(b), and the Court's own equitable powers, requests that the Court:

- a. Enter a permanent injunction to prevent future violations of the FTC Act by Defendants;
- b. Award such relief as the Court finds necessary to redress injury to consumers resulting from Defendants' violations of the FTC Act, including, but not limited to, rescission or reformation of contracts, restitution, the refund of monies paid, and the disgorgement of ill-gotten monies; and
- c. Award Plaintiff the costs of bringing this action, as well as such other and additional relief as the Court may determine to be just and proper.
