RESPONDENT'S MOTION FOR EXTENSION OF TIME
IN WHICH TO HOLD CLOSING ARGUMENTS

Pursuant to Federal Trade Commission Rule of Practice 4.3(b), Respondent Impax Laboratories, Inc. respectfully moves for a one-day extension of the deadline in which to hold closing arguments in this matter. For the reasons stated herein, Respondent requests that the Court schedule closing arguments to occur on February 15, 2018. Complaint Counsel does not object to Respondent's motion and are available on February 15.

Federal Trade Commission Rule of Practice 3.41(b)(6) requires that closing arguments are scheduled within five days of the parties' reply briefs and replies to proposed findings of fact. Pursuant to the Commission's January 19, 2018 Order Regarding Scheduling, concurrent reply briefs and proposed reply findings of fact are to be filed on or before Wednesday, February 7, 2018. Unfortunately, Respondent's in-house counsel has a conflict and will be unable to travel to Washington in the subsequent five days. The parties have conferred about this scheduling issue and, by this motion, Respondent respectfully requests that the Court extend the deadline for closing arguments by one day and set closing arguments for February 15, 2018.

The parties do not seek to move any of the deadlines for filing reply briefs or replies to

proposed findings of fact.
