**RESPONDENT'S UNOPPOSED MOTION FOR ISSUANCE OF DEPOSITION  
SUBPOENAS *AD TESTIFICANDUM* TO GOVERNMENTAL AGENCIES UNDER  
RULE OF PRACTICE 3.36**

Respondent Axon Enterprise, Inc. brings this unopposed motion pursuant to Federal Trade Commission Rule of Practice 3.36, 16 C.F.R. § 3.36, to request the issuance of subpoenas *ad testificandum* to the following officials and personnel currently or formerly associated with law enforcement agencies:

- 1) Daniel Brodie, Lieutenant with Internal Affairs at the Alameda County Sheriff's Office;
- 2) Dan Gomez (retired), former Lieutenant at the Los Angeles Police Department;<sup>1</sup>
- 3) Juan Perez (retired), former Director of the Miami Dade Police Department;
- 4) Josephine Murphy, Deputy Inspector at the New York City Police Department;
- 5) Chief Anthony Tasso, Commanding Officer, Information Technology Bureau at the New York City Police Department;
- 6) George Speaks, Deputy Director of Public Safety at the Columbus Police Department;

<sup>1</sup> At least two of the individuals referenced in this Motion have retired or no longer work at the relevant governmental agency. Although Rule 3.36 requires permission for the issuance of subpoenas only to "officials or employees of governmental agencies," Axon includes individuals who previously were, but no longer are, employees of such agencies out of an abundance of caution.

- 7) Jeri Williams, Chief of the Phoenix Police Department;
- 8) Nick Zajchowski, Strategic Advisor at the Seattle Police Department;
- 9) Randy Browning, Information Technology Manager at the City of Durham Police Department;
- 10) Jason Campbell, former Administration Bureau Chief of the Long Beach Police Department, or such other representative of the Long Beach Police Department as Complaint Counsel may identify on its Supplemental Witness List;
- 11) George Reynoso, Head of the Body Worn Camera Program at the Long Beach Police Department;
- 12) Jim Campion, former Deputy Finance Director for the City of Phoenix;
- 13) Paul Figueroa, Captain at the Oakland Police Department;
- 14) Martin Garland, Lieutenant at the Aurora Police Department;
- 15) Santiago Pastoriza, Procurement Contracting Officer at the Procurement Department for Miami-Dade County;
- 16) Jeff Rinaldo, Captain at the Buffalo Police Department;
- 17) Lieutenant Lilly Hotard or such other representative from Jacksonville Sheriff's Office as Complaint Counsel may identify on its Supplemental Witness List.

All of these individuals are included in Complaint Counsel and/or Respondents' Preliminary or Supplemental Witness Lists. Complaint Counsel has also requested the issuance of subpoenas *ad testificandum* to three of the same individuals: Daniel Brodie, George Speaks, and Nick Zajchowski. Unsigned versions of Respondent's requested subpoenas are attached as Exhibits B-R. Complaint Counsel does not oppose Respondent's request to issue these subpoenas *ad testificandum* and the requests satisfy Rule 3.36.

**ARGUMENT**

Pursuant to Rule 3.36(b) of the Commission's Rules of Practice, a party seeking the issuance of a subpoena for the appearance of a governmental employee in the United States must show that:

- (1) the information sought is reasonable in scope;
- (2) if for the purposes of discovery, the material falls within the limits of discovery under § 3.31(b)(1), or if for an adjudicative hearing, the material is reasonably relevant; and
- (3) the material cannot reasonably be obtained by other means. 16 C.F.R. § 3.36(b).

All requirements are met here, so the Motion should be granted. *See In the Matter of Cabell Huntington Hosp., Inc.*, Docket No. 9366, 2016 WL 232552 (F.T.C. Jan. 14, 2016) (granting Motion for Issuance of Subpoenas *Ad Testificandum*); *In the Matter of Intel Corp.*, Docket No. 9341, 2010 WL 2544424, at \*1-4 (F.T.C. June 9, 2010) (same).

*First*, the scope of the testimony requested in the subpoenas *ad testificandum* is reasonable. Each individual is listed as a witness by either Axon or Complaint Counsel. The testimony sought will relate to Requests for Proposals ("RFPs") issued, bids received in response to RFPs, and agreements related to Body Worn Cameras ("BWCs") and Digital Evidence Management Software ("DEMS"). Testimony will also focus on Axon's acquisition of Viewu and any effect of that acquisition on the Agencies' use of BWCs or DEMS, as well as the pricing, competition, and the market for those or substitute products. Further, testimony will relate to customer experiences with Axon, Viewu, and other suppliers of BWCs or DEMS, including any product deficiencies or problems as well as any efficiencies or improvements to products, or changes in pricing, as a result of Axon's acquisition of Viewu. Axon expects that each witness will have information relating to

these topics, which bear directly on the claims and defenses raised in this action. Thus, the testimony sought is reasonable in scope.

*Second*, the material sought is “reasonably expected to yield information relevant to the allegations of the complaint, to the proposed relief, or to the defense of any respondent,” 16 C.F.R. § 3.31(c)(1), and is also reasonably relevant. The named representatives from the relevant Agencies have specific and direct knowledge regarding the topics on which Axon seeks testimony. Each representative has been listed, either by Axon or Complaint Counsel, as potential witnesses to testify. Thus, their testimony can be reasonably expected to yield relevant information.

*Third*, the testimony cannot be reasonably obtained by other means. Each witness is the sole repository of his own personal knowledge relating to the topics noted above.

In sum, the requested subpoenas *ad testificandum* meet all the requirements of Rule 3.36(b) of the Commission’s Rules of Practice.

### **CONCLUSION**

For the reasons stated above, Axon respectfully requests that its Unopposed Motion for Issuance of Subpoenas *Ad Testificandum* be granted.
