- Our perennial pursuit of learning, through hearings and workshops and rigorous 6(b) studies;
- Our commitment to educating businesses and consumers, as demonstrated by our rich body of business and consumer education materials;
- The common law of consumer privacy and data security we have built from scratch and that we continue to refine, including by fashioning new types of injunctive relief (the 2019 Facebook Order Violation Settlement is a great example) and demanding protections for sensitive data (check out our recent case against Kochava, a data broker);
- Our real-time responses to consumers' most pressing needs, as exemplified by our swift response to Covid-19 frauds and scams;
- Our continued challenges to monopolization attempts that would deprive consumers of the benefits of competition, including our victorious litigation against "Pharma Bro" Martin Shkreli and our ongoing cases against Surescripts and pesticides manufacturers;
- Our continued success in challenging unlawful hospital mergers;
- Our commitment to thoroughly vetting deals, even as HSR filings hit record levels;
- Our engagement in competition advocacy that spreads the gospel of competition to federal, state, and local governments, particularly with respect to occupational licensing issues, certificates of need, and certificates of public advantage;

- Our commitment to sound enforcement premised on legal precedent and economic learning, as exemplified in the 2020 DOJ/FTC Vertical Merger Guidelines;
- The compassion we displayed for each other during the upheaval of 2020, perhaps best reflected in David Robbins' update e-mails;
- The adaptability and focus we displayed throughout the Covid-19 pandemic, pivoting overnight to working remotely in March 2020 (thank you, amazing IT folks!) and pursuing our mission with a vengeance even as we navigated the "new normal" of full-time telework; and
- Our dedication to the FTC mission when the volume of work seems endless and the accolades run dry.

Many thanks to all of you for making my tenure as a Commissioner such a vibrant, informative, and rewarding experience.
