Re: Unsubstantiated claims for Coronavirus treatment or prevention

To Whom It May Concern:

This is to advise you that in December 2020, FTC staff reviewed your website at https://www.alphahormones.com, and your social media websites at https://www.facebook.com/AlphaHormones/ and https://www.instagram.com/alphahormones/, where you promote products and services available at Alpha Hormones, including Thymosin Alpha-1. We have determined that you are unlawfully advertising that certain products or services treat or prevent Coronavirus Disease 2019 (COVID-19).

Some examples of Coronavirus prevention or cure claims on your websites include:

• "Boost Your Immune System Against COVID-19

We all want to stay healthy during these challenging times. Without an immune system, we would have no way to fight harmful pathogens that make us sick, such as viruses, bacteria, parasites or fungi. It is difficult to fight off disease with a weakened immune system, which is why it's important to do everything you can to boost your immune system.

BOOST YOUR IMMUNITY WITH THYMOSIN ALPHA-1

Sometimes your immune system may need a little extra help. We compound this peptide therapy to help keep your immune system strong.

"Has anybody heard of peptide therapy?

Thymosin Alpha-1 (TA-1) is administered subcutaneously similar to insulin. It is approved in 35 countries and has over 80 clinical trials in over 230,000 patients. It can be prescribed to optimize the performance of your immune health and improve general wellness by preventing viral infections such as the common cold or the flu.

Even though TA-1 is not as well known as using Hydroxycholoroquine [sic] and Azithromycin (these two drugs have possible adverse effects to your heart) to treat COVID-19, it's well tolerated. TA-1 is generally safe and effective to use on patients. It is used along with conventional medicine in the ICU to treat COVID-19 all around the world. It is proven to be a promising therapy that can give hope to patients and family members during this challenging time."

In addition, in the Instagram post, you responded to the comment, "how can one do that?" with the statement: "We have an excellent peptide to boost your immune system and help fight COVID-19, it's called Thymosin Alpha – 1!"

It is unlawful under the FTC Act, 15 U.S.C. § 41 *et seq.*, to advertise that a product or service can prevent, treat, or cure human disease unless you possess competent and reliable scientific evidence, including, when appropriate, well-controlled human clinical studies, substantiating that the claims are true at the time they are made. For COVID-19, no such study is currently known to exist for the product or service identified above. Thus, any coronavirus-related prevention or treatment claims regarding such product or service are not supported by competent and reliable scientific evidence. You must immediately cease making all such claims.

You are also advised to review all other claims for your products and services and immediately cease making claims if they are not supported by competent and reliable scientific evidence.
