
RESPONDENT'S NOTICE OF COMPLIANCE



AMENDMENT TO CROSS AGENCY AGREEMENT

WHEREAS, Daramic LLC, formerly Daramic, Inc. ("Daramic") and Hollingsworth & Vose Company ("H&V") are parties to that certain Cross Agency Agreement dated March 31, 2001, as renewed by that certain Cross Agency Agreement - Renewal dated as of March 23, 2006 (collectively, the "Agreement"); and

WHEREAS, the Agreement expired by its terms on March 23, 2009; and

WHEREAS, the Agreement provides that the restrictions set forth in Sections 4(a) and 4(b) of the Agreement (the "Restrictions") remain in effect until March 22, 2014.

NOW THEREFORE, the parties hereby agree as follows:


The Restrictions, including all related terms and definitions, are hereby terminated and declared null and void with respect to North America and to actual and potential customers within North America.

Except as amended or modified by this Amendment, all of the other terms, conditions and provisions of the Agreement shall remain in full force and effect. This Amendment shall be effective as of April 28, 2010.
