Dear Ms. Sabo:

I write regarding your letter dated March 28, 2012, modifying the return dates in the subpoenas *ad testificandum* issued on March 1, 2012 for investigational hearings for Sergey Brin, Larry Page and Eric Schmidt. Specifically, I write to reiterate Google's position and understanding regarding the modifications of these subpoenas and the process for conducting these investigational hearings as discussed with FTC staff.

First, Google will not at this time be making Messrs. Brin, Page and Schmidt available for testimony beyond the respective individual days referenced in your letter.

Second, Google believes that FTC staff will not need more than one day of testimony from these three senior executives to address the subjects covered by the Commission's investigation. We understand that FTC staff presently believes that additional testimony may be warranted beyond a single day, and reserves the right to request that the investigational hearings be left open at the conclusion of the hearings and request that Google make these executives available for additional testimony at a future date. As noted, we do not believe that this will be

Third, Google reserves all of its rights to oppose the taking of further testimony beyond the specific individual days set forth in your letter, including but not limited to petitioning the Commission to quash these subpoenas and opposing any action initiated by the Commission in federal court to compel further testimony. As discussed with FTC staff, Google has agreed to make these individuals available on the individual days set forth in your letter on the condition that Google not be required to waive or otherwise relinquish any of its rights to oppose a request for a second day of testimony, and Google similarly recognizes that the FTC's modification of the subpoenas does not waive its right to seek additional testimony from these individuals.

We look forward to continuing to work with you and FTC staff on these matters as your investigation proceeds. If you have any questions or wish to discuss this matter further, please contact me at (202) 434-5901.

#### Dear Susan and John:

I am writing concerning Google's schedule for the investigational hearing of Larry Page in the above-captioned matter. As you recall, Mr. Page was originally scheduled to testify on June 1, 2012, in Palo Alto, California. After my staff had already flown to California for the hearing, they were informed that Mr. Page was ill, and would be unavailable to testify on the agreed-upon date. Mr. Page was then rescheduled to testify on June 29, 2012, in Washington, D.C. On June 22, 2012, my staff was informed that Mr. Page was still ill, and again would be unable to testify on the newly rescheduled date.

Based on your representation that Mr. Page's timetable for recovery was uncertain, my staff agreed not immediately to reschedule another hearing date. Instead, you agreed to provide periodic reports to my staff regarding Mr. Page's readiness to testify. As of mid-September, we understood that Mr. Page was still ill, had not resumed any public speaking engagements, and remained unable to testify.

We now understand – based on our review of press reports – that Mr. Page has resumed his public speaking engagements. Given these recent developments, and the fact that we have
