ORDER

Based upon a signed and submitted Stipulation of the parties (Doc. 16), acting by and through their respective counsel of record,

IT IS HEREBY ORDERED as follows:

(1) Kushly Industries, LLC and Cody Alt have represented and stipulated that “Kushly” branded CBD products have been marketed online using only the website <https://kushly.com> and the following social media accounts:

4 (2) Kushly Industries, LLC and Cody Alt have stipulated to the authenticity and
5 admissibility in any future litigation with the FTC concerning cached versions of Kushly
6 Industries, LLC’s website found on the Internet Archive (<https://archive.org>) or web
7 captures of Kushly Industries, LLC’s website, including cached versions or web captures
8 of the blog previously featured on Kushly Industries, LLC’s website, or social media feed
9 made by FTC personnel;

10 (3) Kushly Industries, LLC and Cody Alt, subject to the limits of his personal
11 knowledge, admit, for the purposes of any future litigation with the FTC, that during the
12 time period of February 1, 2018, until September 9, 2020, Kushly Industries, LLC
13 represented, either on its website or through its social media accounts identified above, that
14 “Kushly” branded CBD products:

- 15 - may ease sore joints;
- 16 - may help muscles heal fast;
- 17 - may help treat chronic pain;
- 18 - may improve sleep and help treat sleep disorders, including insomnia and
19 narcolepsy;
- 20 - may help treat headaches;
- 21 - may help treat psychiatric disorders, including depression, bipolar disorder,
22 anxiety, post-traumatic stress disorder, and anorexia nervosa;
- 23 - may help treat cancer;
- 24 - may help treat multiple sclerosis;
- 25 - may help lower blood pressure;
- 26 - may help treat addiction;
- 27 - may help treat chronic drowsiness;
- 28 - may boost your energy levels;

- 1 - may help treat Parkinson's disease;
- 2 - may help treat chronic tremors;
- 3 - may help treat psychosis;
- 4 - may enhance your mood;
- 5 - may boost your cognition, improve your memory, and enhance your
- 6 creativity;
- 7 - may help treat Alzheimer's Disease;
- 8 - may enhance stamina;
- 9 - may help treat epilepsy;
- 10 - may stimulate appetite;
- 11 - may help regulate oily skin or hydrate your skin;
- 12 - may help heal bruises, rashes, or wounds or treat skin infections;
- 13 - may help treat acne, psoriasis, and eczema;
- 14 - may help treat arthritis;
- 15 - may help treat muscle spasms;
- 16 - may help treat tendonitis;
- 17 - may help reduce wrinkles or improve skin elasticity;
- 18 - may help treat PMS-related anxiety and depression;
- 19 - may help treat pain resulting from Endometriosis;
- 20 - may help treat nausea;
- 21 - may help treat dysmenorrhea; and


22 (4) Based upon the stipulations above concerning the admissibility, authenticity,
23 and content of the identified website and social media accounts, Kushly, LLC and Kushly
24 Industries, LLC shall be excused from producing documents in response to Document
25 Request Nos. 1 and 2 of the Federal Trade Civil Investigative Demand issued to Kushly,
26 LLC on May 6, 2020.

27 **IT IS FURTHER ORDERED** that, in light of these stipulations, the Court's
28 August 10, 2020 Order to Show Cause (Doc. No. 5) is **DISCHARGED**.
