21 Plaintiff, the Federal Trade Commission ("FTC" or "Commission"), through its  
22 undersigned attorneys, alleges as follows:

- 23 1. Plaintiff brings this action under Section 13(b) of the Federal Trade Commission Act  
24 ("FTC Act"), 15 U.S.C. § 53(b), to secure a permanent injunction, rescission of contracts,  
25 restitution, disgorgement of ill-gotten gains, and other equitable relief against defendant  
26 for engaging in deceptive acts or practices and disseminating false advertisements in  
27

1 connection with the advertising and sale of purported weight loss and breast enhancement  
2 products, in or affecting commerce, in violation of Sections 5(a) and 12 of the FTC Act,  
3 15 U.S.C. §§ 45(a) and 52.

4 **JURISDICTION AND VENUE**

- 5 2. This Court has jurisdiction over this matter pursuant to 15 U.S.C. §§ 45(a), 52, and 53(b),  
6 and 28 U.S.C. §§ 1331, 1337(a) and 1345.
- 7 3. Venue in the United States District Court for the Southern District of California is proper  
8 under 15 U.S.C. §§ 45(a), 52, and 53(b) and 28 U.S.C. §§ 1391(b) and (c).

9 **THE PARTIES**

10 4. Plaintiff, the Federal Trade Commission, is an independent agency of the United States  
11 Government created by statute. 15 U.S.C. §§ 41-58. The Commission enforces Section  
12 5(a) of the FTC Act, 15 U.S.C. § 45(a), which prohibits unfair or deceptive acts or  
13 practices in or affecting commerce. The Commission also enforces Section 12 of the  
14 FTC Act, 15 U.S.C. § 52, which prohibits false advertisements for food, drugs, devices,  
15 services, or cosmetics in or affecting commerce. The Commission may initiate federal  
16 district court proceedings to enjoin violations of the FTC Act and to secure such equitable  
17 relief, including rescission of contracts, restitution, and disgorgement of ill-gotten gains,  
18 as may be appropriate in each case. 15 U.S.C. § 53(b).

19 5. Defendant Latin Hut, Inc. ("Latin Hut"), which also does business as Maya Sales  
20 Corporation, is a California corporation with its principal office or place of business at  
21 1425 30<sup>th</sup> Street, Suite A, San Diego, California 92164. At all times relevant to this  
22 complaint, acting individually or in concert with others, defendant Latin Hut has  
23 marketed and sold dietary supplements, devices, and other products to consumers.  
24 Defendant Latin Hut transacts or has transacted business in this district.

25 **COMMERCE**

26 6. The acts and practices of defendant alleged in this complaint have been in or affecting  
27

1 commerce, as "commerce" is defined in Section 4 of the FTC Act, 15 U.S.C. § 44.

2 **DEFENDANT'S COURSE OF CONDUCT**

3 7. Since about 2001, defendant has advertised, offered for sale, sold, and distributed dietary  
4 supplements, devices, and other products to consumers nationwide. Defendant's products  
5 have included, but are not limited to, the following:

- 6 a. Parche Para Bajar Peso, a purported weight loss transdermal patch containing  
7 fucus vesiculosus (seaweed), garcinia cambogia, and guarana, among other  
8 ingredients. Defendant has offered and sold a one-month supply of Parche Para  
9 Bajar Peso for \$59.95, plus shipping and handling.
- 10 b. Iman de Grasa/Fat Absorber, a purported weight loss dietary supplement  
11 containing chitosan, gota kola, and kelp, among other ingredients. Defendant has  
12 offered and sold a one-month supply of Iman de Grasa/Fat Absorber for \$19.95,  
13 plus shipping and handling.
- 14 c. Total Bust, a purported breast enhancement dietary supplement containing saw  
15 palmetto berry, dong quai root, damiana leaf, and wild yam, among other  
16 ingredients. Defendant has offered and sold a one-month supply of Total Bust for  
17 \$69.95, plus shipping and handling.

18 8. Defendant has advertised its products throughout the United States through Spanish-  
19 language print advertisements in national Hispanic magazines, such as Cosmopolitan en  
20 Español, Cristina La Revista, and Vanidades, through catalogs, via the Internet, and  
21 through other means. Consumers have been able to purchase the products by calling a  
22 toll-free telephone number or by ordering over the Internet.

23 **Parche Para Bajar Peso**

24 9. Defendant has disseminated, or caused to be disseminated, advertisements for Parche  
25 Para Bajar Peso, including, but not necessarily limited to, the catalog advertisements  
26 attached as Exhibits A and B. These advertisements contain the following statements  
27

1 (translated from the original Spanish to English), among others:

2 a. **PARCHE ALLOWS YOU TO LOSE WEIGHT NATURALLY!**

3 Proven in a clinical trial of 135 people

4 -Exhibit A, Maya Catalog

5 b. People can lose 3 to 5 pounds a week.

6 -Exhibit A

7 c. Your appetite will be controlled and your metabolism will activate to lose fat.

8 -Exhibit A

9 d. People can lose up to 1 to 3 pounds a day.

10 -Exhibit B, Maya Catalog

11 **Iman De Grasa/Fat Absorber**

12 10. Defendant has disseminated, or caused to be disseminated, advertisements for Iman de  
13 Grasa, including, but not necessarily limited to, the Internet and catalog advertisements  
14 attached as Exhibits C and D. These advertisements contain the following statements  
15 (translated from the original Spanish to English), among others:

16 a. The CHITOSAN tablets extract the fat content from your foods and make you  
17 avoid absorbing the fat in your body. Take some CHITOSAN tablets before  
18 eating pizza, hamburger or any other fatty food and forget getting fat.

19 b. **TABLETS ABSORB THE FAT AND ELIMINATE IT NATURALLY**

20 c. Converts all your foods into dietetic foods.

22 e. **FAT ABSORBER** tablets have the capacity to absorb fat that you have not  
23 digested and allows you to eliminate it naturally. That way you can eat **PIZZAS,**  
24 **HAMBURGERS,** or any **FRIED FOOD,** your body won't assimilate the fat.

25 **Total Bust**

26 11. Defendant has disseminated, or caused to be disseminated, advertisements for Total Bust,  
27

1 including, but not necessarily limited to, the catalog and print advertisements attached as  
2 Exhibits E through H. These advertisements contain the following statements (translated  
3 from the original Spanish to English), among others:

4 a. **WITHOUT SURGERY OR DRUGS**

5 **100% natural** formula

6 Without side effects

7 Promotes the generation of new tissue in the bust

8 Growth of the bust and

9 Great firmness

10 Permanent results

11 -Exhibit E, Maya Sales Catalog

12 b. Who is this product for? All women who want to have a bigger and firmer bust  
13 from puberty to around menopause. Especially those woman who are left with  
14 flaccid and drooping breasts after pregnancy, this product is a miracle. It doesn't  
15 matter how many children you have had . . . you can recover the freshness,  
16 firmness, and roundness that you had and also increase the size of your breasts up  
17 to 3 inches. For those women who never had a large bust, this is their opportunity

#### 5 DEFENDANT'S VIOLATIONS OF THE FTC ACT

6 12. Section 5(a) of the FTC Act, 15 U.S.C. § 45(a), prohibits unfair or deceptive acts or  
7 practices in or affecting commerce. Section 12(a) of the FTC Act, 15 U.S.C. § 52(a),  
8 prohibits the dissemination of any false advertisement in or affecting commerce for the  
9 purpose of inducing, or which is likely to induce, the purchase of food, drugs, devices,  
10 services, or cosmetics. For purposes of Section 12 of the FTC Act, 15 U.S.C. § 52, the  
11 Parche Para Bajar Peso is a "drug" or "device" as defined in Section 15 of the FTC Act,  
12 15 U.S.C. § 55, and Total Bust and Iman de Grasa/Fat Absorber are each a "food" or  
13 "drug" as defined in Section 15 of the FTC Act, 15 U.S.C. § 55.

#### 14 COUNT I

##### 15 Parche Para Bajar Peso: False Claims

16 13. Through the means described in Paragraph 9 above, defendant has represented, expressly  
17 or by implication, that:

- 18 a. The Parche Para Bajar Peso causes substantial weight loss, for example, 3-5  
19 pounds per week; and
- 20 b. A clinical trial proves that the Parche Para Bajar Peso causes weight loss.

21 14. In truth and in fact:

- 22 a. The Parche Para Bajar Peso does not cause substantial weight, for example, 3-5  
23 pounds per week; and
- 24 b. A clinical trial does not prove that the Parche Bara Bajar Peso causes weight loss.

25 Therefore, defendant's representations set forth in Paragraph 13 above are false or  
26 misleading and constitute deceptive acts or practices, and the making of false  
27 advertisements, in or affecting commerce, in violation of Sections 5(a) and 12 of the FTC  
28

1 Act, 15 U.S.C. §§ 45(a) and 52.

2 **COUNT II**

3 **Parche Para Bajar Peso: Unsubstantiated Claims**

4 15. Through the means described in Paragraph 9 above, defendant has represented, expressly  
5 or by implication, that:

6 a. The Parche Para Bajar Peso increases metabolism; and

7 b. The Parche Para Bajar Peso suppresses appetite.

8 16. Defendant did not possess and rely upon a reasonable basis that substantiated the  
9 representations set forth in Paragraph 15 above at the time the representations were made.  
10 Therefore, defendant's representations set forth in Paragraph 15 above constitute  
11 deceptive acts or practices, and the making of false advertisements, in or affecting  
12 commerce, in violation of Sections 5(a) and 12 of the FTC Act, 15 U.S.C. §§ 45(a) and  
13 52.

14 **COUNT III**

15 **Iman de Grasa/Fat Absorber: False Claim**

16 17. Through the means described in Paragraph 10 above, defendant has represented,  
17 expressly or by implication, that Iman De Grasa causes weight loss by blocking the  
18 absorption of a substantial portion or amount of dietary fat.

19 18. In truth and in fact, Iman De Grasa does not cause weight loss by blocking the absorption  
20 of a substantial portion or amount of dietary fat. Therefore, defendant's representation set  
21 forth in Paragraph 17 above is false or misleading and constitutes a deceptive act or  
22 practice, and the making of false advertisements, in or affecting commerce, in violation of  
23 Sections 5(a) and 12 of the FTC Act, 15 U.S.C. §§ 45(a) and 52.

24 **COUNT IV**

25 **Iman De Grasa/Fat Absorber: Unsubstantiated Claim**

26 19. Through the means described in Paragraph 10 above, defendant has represented,  
27  
28

1 expressly or by implication, that Iman De Grasa prevents weight gain.

2 20. Defendant did not possess and rely upon a reasonable basis that substantiated the  
3 representation set forth in Paragraph 19 above at the time the representation was made.  
4 Therefore, defendant's representation set forth in Paragraph 19 above constitutes a  
5 deceptive act or practice, and the making of false advertisements, in or affecting  
6 commerce, in violation of Sections 5(a) and 12 of the FTC Act, 15 U.S.C. §§ 45(a) and  
7 52.

## 8 **COUNT V**

### 9 **Total Bust: Unsubstantiated Claims**

10 21. Through the means described in Paragraph 11 above, defendant has represented,  
11 expressly or by implication, that Total Bust:

- 12 a. Increases breast size up to 3 inches and/or 2 cup sizes;
- 13 b. Increases breast size in more than 85% of users;
- 14 c. Enlarges, firms, and lifts breasts, including post-pregnancy; and
- 15 d. Permanently enlarges and firms the breasts.

16 Defendant did not possess and rely upon a reasonable basis that substantiated the  
17 representations set forth in Paragraph 21 above at the time the representations were made.  
18 Therefore, defendant's representations set forth in Paragraph 21 above constitute  
19 deceptive acts or practices, and the making of false advertisements, in or affecting  
20 commerce, in violation of Sections 5(a) and 12 of the FTC Act, 15 U.S.C. §§ 45(a) and  
21 52.

## 22 **CONSUMER INJURY**

23 22. Consumers throughout the United States have suffered and continue to suffer substantial  
24 injury as a result of defendant's unlawful acts or practices. In addition, defendant has  
25 been unjustly enriched as a result of its unlawful acts or practices. Absent injunctive  
26 relief by this Court, defendant is likely to continue to injure consumers, reap unjust

1 enrichment, and harm the public interest.

2 **THIS COURT'S POWER TO GRANT RELIEF**

3 23. Section 13(b) of the FTC Act, 15 U.S.C. § 53(b), empowers this Court to grant injunctive  
4 and such other relief as the Court may deem appropriate to halt and redress violations of  
5 the FTC Act. The Court, in the exercise of its equitable jurisdiction, may award other  
6 ancillary relief, including rescission of contracts, restitution, and disgorgement of ill-  
7 gotten gains, to prevent and remedy injury caused by defendant's law violations.

8 **PRAYER FOR RELIEF**

9 WHEREFORE, Plaintiff Federal Trade Commission, pursuant to Section 13(b) of the  
10 FTC Act, 15 U.S.C. § 53(b), and the Court's own equitable powers, requests that this Court:

11 (1) Permanently enjoin defendant Latin Hut from violating Sections 5(a) and 12 of the  
12 FTC Act, as alleged herein, including committing violations in connection with the advertising,  
13 offering for sale, or distribution of food, drugs, dietary supplements, devices, cosmetics, or other  
14 products, services, or programs;


15 (2) Award such equitable relief as the Court finds necessary to redress injury to  
16 consumers resulting from defendant's violations of the FTC Act, including, but not limited to,  
17 rescission of contracts, restitution, and disgorgement of ill-gotten gains; and

18 (3) Award Plaintiff such other equitable relief as the Court may determine to be just and  
19 proper.






