**RESPONDENTS' FIRST AMENDED ANSWER**


Pursuant to the Federal Trade Commission's Rules of Practice ("FTC Rules"), 16 C.F.R. §§ 3.15 and 3.22, counsel for Respondents, Evanston Northwestern Healthcare Corporation ("ENH") and ENH Medical Group, Inc. ("ENHMG") (collectively "Respondents"), move for leave to file the enclosed Respondents' First Amended Answer.

Respondents filed an answer to Counts I and III of the Complaint on March 17, 2004. Also on March 17, 2004, Respondents filed a motion to dismiss Count II of the Complaint. Under FTC Rule § 3.12, Respondents were not required to file an answer to Count II at that time.

Respondents' Motion to Dismiss Count II was denied on June 2, 2004. Respondents seek leave to file the attached First Amended Answer, which only differs from the answer filed by Respondents' on March 17, 2004, in that it includes answers to paragraphs 28-30 and 32 of the Complaint. Complaint Counsel has indicated that it has no objection to this motion.
