COMPLAINT FOR PERMANENT INJUNCTION AND OTHER EQUITABLE RELIEF PURSUANT TO SECTION 13(b) OF THE FEDERAL TRADE COMMISSION ACT

Plaintiff, the Federal Trade Commission ("Commission"), through its undersigned attorneys, alleges as follows:

Plaintiff FTC brings this action under Section 13(b) of the Federal Trade Commission
 Act ("FTC Act"), 15 U.S.C. § 53(b), to secure a permanent injunction, rescission of

contracts and restitution, disgorgement of ill-gotten gains, and other equitable relief against the Defendants for engaging in deceptive acts or practices and false advertisements for dietary supplements marketed for weight loss and sexual dysfunction, in or affecting commerce, in violation of Sections 5(a) and 12 of the FTC Act, 15 U.S.C.  $\S$  45(a) and 52.

#### JURISDICTION AND VENUE

- This Court has jurisdiction over this matter pursuant to 15 U.S.C. §§ 45(a), 52, and 53(b), and 28 U.S.C. §§ 1331, 1337(a) and 1345.
- Venue in the United States District Court for the District of Maine is proper under 15
   U.S.C. § 53(b) and 28 U.S.C. §§ 1391(b) and (c).

### **THE PARTIES**

- 4. Plaintiff, the Federal Trade Commission, is an independent agency of the United States Government created by statute. 15 U.S.C. §§ 41-58. The Commission is charged, *inter alia*, with enforcement of Sections 5(a) and 12 of the FTC Act, 15 U.S.C. § 45(a) and 52, which respectively prohibit unfair or deceptive acts or practices in or affecting commerce, and false advertisements for food, drugs, devices, services, or cosmetics in or affecting commerce. The Commission may initiate federal district court proceedings, through its attorneys, to enjoin violations of the FTC Act and to secure such other equitable relief, including rescission of contracts and restitution, and disgorgement of ill-gotten gains, as may be appropriate in each case. 15 U.S.C. § 53(b).
- Defendant VisionTel Communications, LLC ("VisionTel"), which also does business as
   Vision Laboratories, is a Maine limited liability corporation with its principal office or

place of business at 51 Dow Highway, Suite 11, Eliot, Maine 03903. VisionTel transacts or has transacted business in this district.

- 6. Defendant Michael McNaboe ("McNaboe") is the President of VisionTel and the sole owner of MJ Mgmt. At all times relevant to this Complaint, acting alone or in concert with others, he has formulated, directed, controlled, had the authority to control or participated in the acts and practices of VisionTel, including the acts or practices set forth herein. His principal office or place of business is the same as that of VisionTel. McNaboe transacts or has transacted business in this district.
- 7. Defendant David Amato ("Amato") is a Vice-President of VisionTel and the sole owner of MAD Marketing. At all times relevant to this Complaint, acting alone or in concert with others, he has formulated, directed, controlled, had the authority to control or participated in the acts and practices of VisionTel, including the acts or practices set forth herein. His principal office or place of business is the same as that of VisionTel. Amato transacts or has transacted business in this district.
- 8. Defendant Robert Dall ("Dall") is a Vice-President of VisionTel and the sole owner of LLAD Mgmt. At all times relevant to this Complaint, acting alone or in concert with others, he has formulated, directed, controlled, had the authority to control or participated in the acts and practices of VisionTel, including the acts or practices set forth herein. His principal office or place of business is the same as that of VisionTel. Dall transacts or has transacted business in this district.
- 9. Defendant MJ Management ("MJ Mgmt.") is a Maine corporation with its principal office or place of business at 13 Cliff Street, Scarborough, Maine 04074. MJ Mgmt.

owns 23.5% of VisionTel. At all times relevant to this Complaint, acting alone or in concert with others, MJ Mgmt. has formulated, directed, controlled or participated in the acts and practices of VisionTel, including the various acts and practices set forth herein. MJ Mgmt. transacts or has transacted business in this district.

- Defendant MAD Marketing, Inc. ("MAD Marketing") is a Maine corporation with its principal office or place of business at 46 Woodland Road, Cape Elizabeth, Maine 04107. MAD Marketing owns 23.5% of VisionTel. At all times relevant to this Complaint, acting alone or in concert with others, MAD Marketing has formulated, directed, controlled or participated in the acts and practices of VisionTel, including the various acts and practices set forth herein. MAD Marketing transacts or has transacted business in this district.
- 11. Defendant LLAD Management, Inc. ("LLAD Mgmt.") is a Maine corporation with its principal office or place of business at 532 Mitchell Road, Cape Elizabeth, Maine 04107. LLAD Mgmt. owns 23.5% of VisionTel. At all times relevant to this Complaint, acting alone or in concert with others, LLAD Mgmt. has formulated, directed, controlled or participated in the acts and practices of VisionTel, including the various acts and practices set forth herein. LLAD Mgmt. transacts or has transacted business in this district.

#### COMMERCE

12. The acts and practices of Defendants alleged in this complaint have been in or affecting commerce, as "commerce" is defined in Section 4 of the FTC Act, 15 U.S.C. § 44.

## DEFENDANTS' COURSE OF BUSINESS

13. Since 1999, Defendants VisionTel, MJ Mgmt., MAD Marketing, LLAD Mgmt, McNaboe, Amato, and Dall (collectively, the "VisionTel Defendants") have engaged in the labeling, advertising, offering for sale, sale, and distribution of products to the public. The VisionTel Defendants have promoted dietary supplements, including Chito-Trim, TurboTone, Impulse Female Herbal Blend, and Maximus Male Herbal Blend, through print, radio, and television advertisements, program-length television commercials ("infomercials"), the Internet, and other means. Consumers have ordered these products by calling a toll-free telephone number and by ordering over the Internet.

## **Chito-Trim**

- 14. Starting in or about January 2000, and continuing at least until in or about 2002, the VisionTel Defendants marketed and sold Chito-Trim, a purported weight loss dietary supplement consisting primarily of chitosan and vitamin C.
- The VisionTel Defendants have offered a one-month supply of Chito-Trim for \$59.95.
   Since January 2000, gross sales of Chito-Trim have exceeded \$3 million.
- 16. To induce consumers to purchase Chito-Trim, the VisionTel Defendants have disseminated, or caused to be disseminated, television and radio advertisements and telemarketing scripts, including but not limited to the attached Exhibits A through D. These advertisements contain, among other things, the following statements and representations:
  - a. Chito-Trim is the drug free dietary supplement containing high potency natural ingredients proven to trap unwanted fat, guaranteeing safe effective weight loss. Studies suggest that the active ingredients in Chito-Trim work to attract fat like a magnet, forcing your body to pass it out of your system naturally, giving you the

benefits of dieting without the hassle of calorie counting. Thousands of people have already experienced fast effective weight loss without restrictive dieting or strenuous exercise. You can too! If you want to lose weight and have a lean, sexy body call now!

#### TurboTone

17. Starting in or about January 2002, and continuing at least until in or about early 2003, the VisionTel Defendants marketed and sold TurboTone, a purported weight loss dietary supplement containing vitamin E, magnesium, chromium, vanadium, glucosol, gymnema sylvestre leaf, garcinia cambogia fruit extract, phaseolamin, citrus aurantium extract, Korean ginseng root extract, caffeine, and various herbs.

- The VisionTel Defendants have offered a one-month supply of TurboTone for \$59.95.
   Since January 2002, gross sales of TurboTone have exceeded \$469,000.
- 19. To induce consumers to purchase TurboTone, the VisionTel Defendants have disseminated, or caused to be disseminated, print and radio advertisements, and telemarketing scripts, including but not limited to the attached Exhibits E through J. These advertisements contain, among other things, the following statements and representations:
  - a. Cindy: ... It's all because of TurboTone, this amazing new weight loss supplement that's burned off my excess body fat and gotten me lean, without me having to kill myself at the gym or starve! I can eat cheesecake, fries, doughnuts, lasagna ... all my favorites! With TurboTone, it's almost like I'm working out and burning off fat 24 hours a day even when I'm sleeping!

  - b. The powerful, all-natural ingredients in TurboTone work with your body to naturally boost your metabolism, giving you the benefits of exercise without the time-consuming hassle or the unhealthy strain! And with your boosted metabolism you'll be burning fat and calories 24 hours a day!

Just a few tablets of TurboTone a day will give you the weight loss results you want safely and naturally, while at the same time help sculpt and tone your body. TurboTone is perfect for you if you want to be able to eat what you want and lose weight and get firm without calorie-counting or long strenuous workouts. -Exhibit F, :60 radio ad.

If you want to lose weight and have a lean, sculpted, sexy body without having to exercise all day or give up your favorite foods, TurboTone is perfect for you. -Exhibit G, print advertisement.

Wish you could lose up to 5 pounds per week without feeling hungry all the time? Now you can with TurboTone, the revolutionary new highest potency weight loss dietary supplement clinically proven to make you feel full while it burns off body fat, so you get the slim, sexy, sculpted body you've always wanted. -Exhibit H, :60 radio ad.

#### **Impulse Female Herbal Blend**

20. Starting in or about January 2000, and continuing at least until in or about July 2003, the VisionTel Defendants have marketed and sold Impulse Female Herbal Blend, a purported treatment for female sexual dysfunction. Impulse Female Herbal Blend has contained androstenediol, 1-arginine, tribulus terrestris extract, dong quai extract, muira puama, and other ingredients. In or about January 2003, the product formulation was changed to omit androstenediol. Androstenediol is an androgen that can convert to testosterone or estrogen in the human body.

21. The VisionTel Defendants have offered a one-month supply of Impulse Female Herbal Blend for \$59.95. Since January 2000, gross sales of Impulse Female Herbal Blend have exceeded \$3 million.

22. To induce consumers to purchase Impulse Female Herbal Blend, the VisionTel Defendants have disseminated, or caused to be disseminated, radio, print, infomercial and Internet advertisements, and telemarketing scripts, including but not limited to the attached Exhibits K through Q. These advertisements contain, among other things, the following statements and representations:

a. Introducing Impulse, the revolutionary new all-natural formula for adult women that helps boost your level of arousal, replenish your natural moisture, and intensify sexual pleasure.

MALE ANNOUNCER: Introducing Impulse, an all-natural, nonprescription supplement uniquely designed for a woman's body to safely and effectively restore your sexual urge and enjoyment, guaranteed....

Impulse works by increasing the blood flow to the genital area improving sensitivity and lubrication. It also increases desire and urge by allowing your body to maintain the correct hormonal balance naturally.

#### **Maximus Male Herbal Blend**

23. Starting in or about January 2000, and continuing at least until in or about July 2003, the VisionTel Defendants have marketed and sold Maximus Male Herbal Blend, a purported treatment for male sexual dysfunction containing yohimbine derived from African yohimbe bark extract, tribulus standardized extract, l-arginine, avena sativa, stinging nettle, muira pauma, and other ingredients. The recommended daily dosage for Maximus Male Herbal Blend has contained 4 mg. of yohimbine.

- 24. The VisionTel Defendants have offered a one-month supply of Maximus Male Herbal Blend for \$59.95. Since January 2000, gross sales of Maximus Male Herbal Blend have exceeded \$23 million.
- 25. To induce consumers to purchase Maximus Male Herbal Blend, the VisionTel Defendants have disseminated, or caused to be disseminated, radio, print, infomercial, and Internet advertisements, including but not limited to the attached Exhibits P and R through W. These advertisements contain, among other things, the following statements and representations:
  - a. In the past, sexual dysfunction treatments have been limited to injections, surgery, drugs, and other painful and expensive procedures. But now there's a better, safer, drug-free option! Introducing Maximus, an all-natural blend of vitamins and herbs scientifically-formulated to help promote testosterone and heighten

sexual performance. Maximus is not a drug. It's all-natural and there are no side effects. The results men get are incredible! Maximus will dramatically improve your stamina, urge, and ability, guaranteed!

#### DEFENDANTS' VIOLATIONS OF THE FTC ACT

26. Section 5(a) of the FTC Act, 15 U.S.C. § 45(a), prohibits unfair or deceptive acts or

practices in or affecting commerce. Section 12(a) of the FTC Act, 15 U.S.C. § 52(a),

prohibits the dissemination of any false advertisement in or affecting commerce for the purpose of inducing, or which is likely to induce, the purchase of food, drugs, devices, services, or cosmetics. For the purposes of Section 12 of the FTC Act, Chito-Trim, TurboTone, Impulse Female Herbal Blend, and Maximus Male Herbal Blend are each either a "food" or a "drug" pursuant to Sections 15(b) and (c) of the FTC Act, 15 U.S.C. §§ 55(b) and (c). As set forth below, the VisionTel Defendants have engaged in violations of Sections 5(a) and 12(a) of the FTC Act in connection with the marketing and sale of Chito-Trim, TurboTone, Impulse Female Herbal Blend, and Maximus Male Herbal Blend, and Maximus Male Herbal Blend.

# COUNT I Chito-Trim False Claims

27. Through their advertising and promotional materials, including but not limited to the representations set forth in Paragraph 16 above, the VisionTel Defendants have represented, expressly or by implication, that:

 a. Chito-Trim causes users to lose a substantial amount of weight without reducing their caloric intake and/or increasing their physical activity; and

b. Chito-Trim causes users to lose a substantial amount of weight by blocking the absorption of fat or calories.

28. In truth and in fact:

a.

Chito-Trim does not cause users to lose a substantial amount of weight without reducing their caloric intake and/or increasing their physical activity; and

b. Chito-Trim does not cause users to lose a substantial amount of weight by blocking the absorption of fat or calories.

Therefore, the VisionTel Defendants' representations set forth in Paragraph 27 are false or misleading and constitute a deceptive act or practice, and the making of false advertisements, in or affecting commerce, in violation of Sections 5(a) and 12 of the FTC Act, 15 U.S.C. §§ 45(a) and 52.

## COUNT II Chito-Trim Unsubstantiated Claims

29. The VisionTel Defendants did not possess and rely upon a reasonable basis that substantiated the representations set forth in Paragraph 27 at the time the representations were made. Therefore, the making of the representations set forth in Paragraph 27 constitutes a deceptive act or practice, and the making of false advertisements, in or affecting commerce, in violation of Sections 5(a) and 12 of the FTC Act, 15 U.S.C. §§ 45(a) and 52.

# COUNT III TurboTone False Claims

- 30. Through their advertising and promotional materials, including but not limited to the representations set forth in Paragraph 19 above, the VisionTel Defendants have represented, expressly or by implication, that:
  - a. TurboTone causes users to lose a substantial amount of weight without reducing their caloric intake and/or increasing their physical activity; and
  - TurboTone is clinically proven to cause users to lose a substantial amount of weight without reducing their caloric intake and/or increasing their physical activity.

- a. TurboTone does not cause users to lose a substantial amount of weight without reducing their caloric intake and/or increasing their physical activity; and
- TurboTone is not clinically proven to cause users to lose a substantial amount of weight without reducing their caloric intake and/or increasing their physical activity.

Therefore, the VisionTel Defendants' representations as set forth in Paragraph 30 are false or misleading and constitute a deceptive act or practice, and the making of false advertisements, in or affecting commerce, in violation of Sections 5(a) and 12 of the FTC Act, 15 U.S.C. §§ 45(a) and 52.

# COUNT IV TurboTone Unsubstantiated Efficacy Claim

32. The VisionTel Defendants did not possess and rely upon a reasonable basis that substantiated the representation set forth in Paragraph 30.a at the time the representation was made. Therefore, the making of the representation set forth in Paragraph 30.a constitutes a deceptive act or practice, and the making of false advertisements, in or affecting commerce, in violation of Sections 5(a) and 12 of the FTC Act, 15 U.S.C. §§ 45(a) and 52.

#### COUNT V

## Impulse Female Herbal Blend Unsubstantiated Efficacy Claim

33. Through their advertising and promotional materials, including but not limited to the representations set forth in Paragraph 22 above, the VisionTel Defendants have represented, expressly or by implication, that Impulse Female Herbal Blend is effective in

treating female sexual dysfunction.

34. The VisionTel Defendants did not possess and rely upon a reasonable basis that substantiated the representation set forth in Paragraph 33 at the time the representation was made. Therefore, the making of the representation set forth in Paragraph 33 constitutes a deceptive act or practice, and the making of false advertisements, in or affecting commerce, in violation of Sections 5(a) and 12 of the FTC Act, 15 U.S.C. §§ 45(a) and 52.

#### COUNT VI

# Impulse Female Herbal Blend Unsubstantiated Safety Claim

- 35. Through their advertising and promotional materials, including but not limited to the representations set forth in Paragraph 22 above, the VisionTel Defendants have represented, expressly or by implication, that Impulse Female Herbal Blend is and has been safe.
- 36. The VisionTel Defendants did not possess and rely upon a reasonable basis that substantiated the representation set forth in Paragraph 35 at the time the representation was made. To date, no reliable scientific data or studies have demonstrated that products containing androstenediol are safe for use by women. Further, endocrinologists and other health professionals have raised concerns regarding the lack of safety testing on androgen supplements and the potential health risks and negative side effects of using such products. Therefore, the making of the representation set forth in Paragraph 35 constitutes a deceptive act or practice, and the making of false advertisements, in or affecting commerce, in violation of Sections 5(a) and 12 of the FTC Act, 15 U.S.C. §§ 45(a) and 52.

#### COUNT VII

# Maximus Male Herbal Blend Unsubstantiated Efficacy Claim

- 37. Through their advertising and promotional materials, including but not limited to the representations set forth in Paragraph 25 above, the VisionTel Defendants have represented, expressly or by implication, that Maximus Male Herbal Blend is effective in treating male sexual dysfunction.
- 38. The VisionTel Defendants did not possess and rely upon a reasonable basis that substantiated the representation set forth in Paragraph 37 at the time the representation was made. Studies that have tested the efficacy of yohimbine for sexual dysfunction have had contradictory results; however, to the extent some studies have found yohimbine to be efficacious for this purpose, those studies used daily dosage levels of yohimbine at 15 mg. or higher. Therefore, the making of the representation set forth in Paragraph 37 constitutes a deceptive act or practice, and the making of false advertisements, in or affecting commerce, in violation of Sections 5(a) and 12 of the FTC Act, 15 U.S.C. §§ 45(a) and 52.

#### COUNT VIII

# Maximus Male Herbal Blend Unsubstantiated Safety and No Side Effects Claims

39. Through their advertising and promotional materials, including but not limited to the representations set forth in Paragraph 25 above, the VisionTel Defendants have represented, expressly or by implication, that:

a. Maximus Male Herbal Blend is safe; and

b. Maximus Male Herbal Blend has no harmful side effects.

40. The VisionTel Defendants did not possess and rely upon a reasonable basis that

substantiated the representations set forth in Paragraph 39. Maximus Male Herbal Blend contains yohimbine and one or more other ingredients that may substantially increase blood pressure and interact adversely with other drugs that may be taken by men with conditions that cause erectile dysfunction. Therefore, the making of the representations set forth in Paragraph 39 constitutes a deceptive act or practice, and the making of false advertisements, in or affecting commerce, in violation of Sections 5(a) and 12 of the FTC Act, 15 U.S.C. §§ 45(a) and 52.

#### **CONSUMER INJURY**

41. Consumers throughout the United States have suffered substantial monetary loss as a result of Defendants' unlawful acts or practices. In addition, Defendants have been unjustly enriched as a result of their unlawful practices. Absent injunctive relief by this Court, Defendants are likely to continue to injure consumers, reap unjust enrichment, and harm the public interest.

## THIS COURT'S POWER TO GRANT RELIEF

42. Section 13(b) of the FTC Act, 15 U.S.C. § 53(b), empowers this Court to grant injunctive and such other relief as the Court may deem appropriate to halt and redress violations of the FTC Act. The Court, in the exercise of its equitable jurisdiction, may award other ancillary relief, including rescission of contracts and restitution, and the disgorgement of ill-gotten gains, to prevent and remedy injury caused by Defendants' law violations.

#### PRAYER FOR RELIEF

Wherefore, Plaintiff requests that this Court, as authorized by Section 13(b) of the FTC Act, 15 U.S.C. § 53(b), and pursuant to its own equitable powers:

(1) Enjoin Defendants permanently from violating Sections 5 and 12 of the FTC Act in connection with the advertising or sale of food, drugs, dietary supplements, devices, cosmetics or other products, services or programs;

(2) Award such equitable relief as the Court finds necessary to redress injury to consumers resulting from Defendants' violations of the FTC Act, including but not limited to rescission of contracts and restitution, and the disgorgement of ill-gotten gains by the Defendants; and

(3) Award the Plaintiff the costs of bringing this action and any such other equitable relief as the Court may determine to be just and proper.
