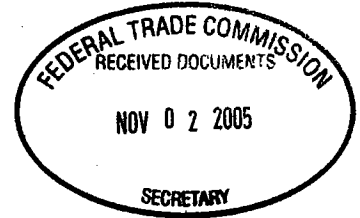



NOTICE OF APPEAL

Pursuant to FTC Rule of Practice § 3.52(a), 16 C.F.R § 3.52(a), Respondent ENH Medical Group, Inc. hereby gives notice that it will appeal, against Complaint Counsel, the entirety of the Initial Decision and Order entered by the Administrative Law Judge, as well as certain procedural and evidentiary rulings, in the above captioned proceeding.

Although ENH Medical Group was served with a copy of the Initial Decision and Order, it was not included in the caption of the Initial Decision and Order pursuant to a discussion among Complaint Counsel, counsel for ENH Medical Group and the office of the Administrative Law Judge. The allegations in Count III of the Complaint against ENH Medical Group were resolved by a consent order that the Commission approved as final on May 17, 2005. This notice of appeal, therefore, is being filed to preserve ENH Medical Group's rights to appeal in the event that it is ultimately determined that ENH Medical Group nevertheless remains a Respondent in this case.


