COMPLAINT FOR PERMANENT INJUNCTION AND OTHER EQUITABLE RELIEF

Plaintiff, the Federal Trade Commission ("FTC" or "Commission"), through its undersigned attorneys, for its Complaint alleges:

1. Plaintiff FTC brings this action under Section 13(b) of the Federal Trade Commission Act ("FTC Act"), 15 U.S.C. § 53(b), to secure a permanent injunction, rescission or reformation of contracts, restitution, the refund of monies paid, the disgorgement of ill-gotten monies, and other equitable relief against the Defendants for engaging in deceptive acts or practices and false advertising in connection with the advertising, marketing, and sale of products purporting to treat and/or cure cancer, in violation of Sections 5(a) and 12 of the FTC Act, 15 U.S.C. §§ 45(a) and 52.

JURISDICTION AND VENUE

- 2. This Court has jurisdiction over this matter pursuant to 15 U.S.C. §§ 45(a), 52, and 53(b) and 28 U.S.C. §§ 1331, 1337(a), and 1345.
- 3. Venue in this District is proper under 15 U.S.C. § 53(b) and 28 U.S.C. §§ 1391(b) and (c).

PLAINTIFF

4. Plaintiff FTC is an independent agency of the United States Government created by statute. 15 U.S.C. §§ 41-58. The Commission enforces Section 5(a) of the FTC Act, 15 U.S.C. § 45(a), which prohibits unfair or deceptive acts or practices in or affecting commerce. The Commission also enforces Section 12 of the FTC Act, 15 U.S.C. § 52, which prohibits false advertisements for food, drugs, devices, services, or cosmetics in or affecting commerce. The Commission, through its own attorneys, may initiate federal district court proceedings to enjoin violations of the FTC Act and to secure such equitable relief, including rescission or reformation of contracts, restitution, the refund of monies paid, and the disgorgement of ill-gotten monies, as may be appropriate in each case. 15 U.S.C. § 53(b).

DEFENDANTS

- 5. Defendant Westberry Enterprises, Inc., (Westberry Enterprises) is a Louisiana Business Corporation with offices at 3121 Highway 107 (Old Marksville Hwy.), Pineville, Louisiana 71360. Westberry Enterprises advertises, markets, offers for sale, and sells a variety of herbal products. Westberry Enterprises is headquartered and has its principal place of business in the Western District of Louisiana and transacts or has transacted business in this District and throughout the United States.
 - 6. Defendant Timothy Stuart Westberry is the sole Director of Westberry

Enterprises. At all times relevant to this Complaint, acting individually or in concert with others, Timothy Westberry formulated, directed, controlled, or participated in the policies, acts, or practices of Westberry Enterprises, including the acts and practices complained of below.

Timothy Westberry resides in the Western District of Louisiana and transacts or has transacted business in this District and throughout the United States.

COMMERCE

7. The acts and practices of Defendants alleged in this Complaint are and have been in or affecting commerce, as "commerce" is defined in Section 4 of the FTC Act, 15 U.S.C. § 44.

DEFENDANTS' COURSE OF CONDUCT

- 8. Since at least July 2004, Defendants Westberry Enterprises and Timothy Westberry, d/b/a Road To Healing, have engaged in the advertising, promotion, offering for sale, sale, and distribution of herbal products that purportedly treat and/or cure cancer.
- 9. Defendants advertise and offer these products to consumers located throughout the United States, Canada, Puerto Rico, and the U.K. through their Internet website, www.roadtohealing.com. Orders are received via email or through Defendants' toll-free telephone number (888-589-HERB).
- 10. Defendants' principal product is Native Herbal Tea Rene Caisse's Original Formula, a/k/a Essiac Tea ("Native Herbal Tea"). This raw tea contains a mix of four herbs Burdock Root (Arctium lappa), Sheep Sorrel (Rumex Acetosella), Slippery Elm Bark (Ulmus Fulva), and Turkish Rhubarb Root (Rheum Palmatum). Native Herbal Tea is promoted as a treatment or cure for many kinds of cancer including bladder, bone, brain, breast, cervical, colon, esophagus, kidney, liver, lung, mouth, ovarian, pancreatic, prostate, rectal, skin, stomach, testicular, throat, thyroid, tongue, and uterine cancers. Defendants' website claims that Native

Herbal Tea "is nothing short of a miracle," and guarantees you will see results "even a complete recovery of the illness that you suffer with." Consumers are instructed to drink Native Herbal Tea on an empty stomach twice daily. The typical cost to consumers for the Native Herbal Tea product is approximately \$25.00 a month, plus shipping and handling fees.

- 11. Defendants advertise and sell a number of additional products that purportedly complement the Native Herbal Tea and assist in fighting cancer. Cats Claw (capsules) (Uncaria tomentosa), also known by its Spanish name Uña de Gato, is sold by Defendants for approximately \$24.00 a month, plus shipping and handling fees. Defendants claim that Cats Claw prevents the development and growth of malignant cells in cancer. Chlora Plasma (tablets), which is composed of saltwater blue-green algae (Spirulina Plaensis) in a base of vegetable oil and silica, is sold for approximately \$34.00 a month, plus shipping and handling fees. Defendants contend Chlora Plasma helps reduce cancerous tumors. Red Clover Plus (capsules), which contains cascara sagrada bark and a "proprietary blend" of 13 other ingredients including red clover, sheep sorrel, barberry, echinacea, licorice, and devil's claw extract, is sold for approximately \$20.00 a month, plus shipping and handling fees. Red Clover Plus purportedly fights against cancerous growths. Melatonin (tablets) (N-acetyl-5methoxytryptamine) is produced in a base of sorbitol, magnesium stearate, and Peppermint flavor, and is sold for approximately \$22.00 a month, plus shipping and handling fees. According to Defendants, their Melatonin product helps and treats many forms of cancer, especially breast cancer, prostate cancer, and melanoma.
- 12. To reach consumers suffering from cancer, Defendants employ numerous references to cancer in their website metatags, including the following: "anti cancer treatment," "cancer treatment," "alternative cancer treatment," and "natural cancer treatment." These

metatags are used by search engines to index websites for the purpose of comparing sites to an Internet user's search request. Thus, a consumer using these or similar search terms would be more likely to locate the Defendants' website.

13. To induce consumers to purchase their herbal products, Defendants disseminated or caused to be disseminated advertisements, including but not limited to their Internet website advertisements. Copies of particular web pages from Defendants' website, as of March 6, 2008, are attached as Exhibit A. The Defendants' website contains numerous express and implied claims that their herbal products can be used to treat and/or cure cancer. The website contains more than 100 references to cancer, including the following claims:

EXCERPTS FROM DEFENDANTS' WEBSITE: EXHIBIT A

a. All Natural Alternative Cancer Treatment ROAD TO HEALING

As long as there is life, there is hope. [Exhibit A, p1]

- b. <u>If you have Cancer, click here to learn about a Natural Treatment that has Great Results.</u> [Exhibit A, p1] (Original contains hyperlink to information on Native Herbal Tea.)
- c. We want to share the knowledge of this Herbal Tea, from the experience of using it personally and knowing of great testimonies that are nothing short of a miracle from the miraculous results received from so many that have used the Native Herbal Tea. [Exhibit A, p2]
- d. [Native Herbal Tea can] [s]hrink the size of Tumors in a short while. It has been proven many times with Cat [sic] Scans and MRI's. [Exhibit A, p2]
- e. The Native Herbal Tea that we offer on our site has been proven, through Testimonials, time and time again to be a great tool in fighting and wining [sic] the battle against Cancer and many other illnesses. . . . Go to the Products page to learn more about the other products that can assist the Native Herbal Tea in your fight against cancer or any other illness that you or your love one [sic] may have. [Exhibit A, pp2-3] (underlined portion hyperlinked in original).

- f. For more than 50 years people from all over the world went to Ontario, Canada for cancer treatment with a simple herbal formula [Native Herbal Tea] that gave miraculous results. [Exhibit A, p4]
- g. From this knowledge many people recovered from cancer by using this wonderful formula [Native Herbal Tea].

Testimony:

Brenda J. from Louisiana was diagnosed with cervical cancer and her blood count was down to 9. The doctor said she needed a blood transfusion, but she started drinking the Native herbal Tea and in a week's time of, 2 ozs, 3 times a day of this wonderful herbal tea, her blood count went up to 27. She overcame cancer and is still cancer free today[.] Brenda J. (LA)

[Exhibit A, p4]

h. Dr. Charles Brusch of the famed Brusch Clinic in Cambridge, Massachusetts (physician to John F. Kennedy) - not only tested ESSIAC on human patients, but proved its value against his own cancer. He cured himself of stomach cancer with the **Native Herbal Tea** (Rene Caisse's Original ESSIAC Formula). He continued proclaiming its great value as long as he lived.

Testimony:

Randy from Texas was diagnosed with Lung cancer Oct. 2004 and the doctor gave him some radiation, but he was still in much pain and sick. He began taking the Native Herbal Tea in Nov. 2004. He drank it 3 or 4 times a day and did not miss a dose, even when he went camping he took his jug of herbal tea with him. He soon began feeling better. His doctor at M.D. Anderson in Houston, Texas said his tumor was shrinking and his blood count was great. He has gone back to work and is in no pain, thanks to the Native Herbal Tea.

i. The Native Herbal Tea is an alternative treatment for all kinds of Cancer.

j. Listed below are other products that compliment [sic] the Native Herbal Tea. Click on them for further information.

<u>Cats Claw</u> - It provides cystic action, thus preventing the development and growth of malignant cells in cancer and other tumorous condition [sic].

<u>Chlora Plasma</u> - This product is a pure, uncontaminated, saltwater blue-green algae (ten times the amount found in alfalfa), and contains high amounts of minerals, vitamins, and beta carotene, amino acids, iron, Vitamin B12, nucleic acids and chlorophyll. This is a wonderful product to treat cancer with, and give strength to the body. It could be considered as a Multipliable Vitamin Supplement.

Red Clover Plus - This proprietary product helps nourish the body's ability to cleanse and enhance the liver and intestinal tract functions, and fights against cancerous growths.

<u>Melatonin</u> - It helps and treats many forms of cancer, especially breast cancer, prostate cancer, and melanoma. It is an antioxidant which destroys substances that cause disease and tumors, and increases the body's antibody response to infections and helps regulate the body's defense systems.

- k. This Proprietary formula [Chlora Plasma] helps enhance the body's immune system, increases energy, helps reduce cancer tumors [Exhibit A, p6]
- 1. A total body's cleanse [sic] and detoxifier, this proprietary product [Native Herbal Tea] is especially effective in building up and strengthening the immune system. Products in the formulation have proven effective in dealing with tumors, tumorous growths and various forms of cancer. [Exhibit A, p7]
- m. Some studies and trials have shown [Melatonin] can improve the survival time and quality of life of patients with untreatable cancer. [Exhibit A, p8]
- n. **Q: "Can the Herbal Tea cure Cancer?"**

- A: The Herbal Tea is a treatment for all kinds of cancer. Many people have been treated with herbs according to their testimony. We do not say it will cure or heal, but we ask you to use it and be your own judge, also read the testimonies. [Exhibit A, p9]
- o. Rene was a Canadian nurse who discovered a native Indian remedy to treat cancer. She modified the formula and successfully helped save many lives. She obtained the Native Herbal tea recipe from a lady who used the Native Herbal tea 30 years before, and as a result was completely healed of breast cancer. The lady had been treated by a native Indian medicine man who taught her how to grow and make the formula. In many cases of painful diseases, like cancer and others, by drinking the tea on a regular basis, took away all the pain and kept the patients more comfortable. Rene Caisse, being a nurse, began using the herbal tea to treat many cases of terminal illnesses. She treated over 40,000 people with remarkable results. [Exhibit A, p10]
- p. D.H. was diagnosed with a brain tumor, and his medical complications had progressed to immune system failure, life threatening high blood pressure, pain and other complications. After chemotherapy treatments, radiation treatments and various other experimental allopathic remedies, the medical doctors gave him three months to live. He began taking the Native Herbal tea formula 3 times a day plus Chloro [sic] Plasma and Red Clover and he recovered from the brain tumor, his blood pressure became normal and his immune system was built up. He felt so much better the doctors were amazed. [Exhibit A, p11]
- q. Bob M. reported-Cancer-Cysts [sic] on the back, neck, and right leg. After taking the Alternative Native Herbal tea he noticed increased energy, cysts on the neck were completely gone in 3 weeks, and cysts on the leg were reduced to half. No side effects reported. [Exhibit A, p11]
- r. After taking the Native Herbal tea for only three days, Van's skin cancer disappeared. He works in the sun and had skin cancers come on his arm. As soon as he began to drink the tea the skin cancers began to fade away. [Exhibit A, p11]
- s. One 90 year old woman found out she had cervical cancer. The doctors wanted to start her on radium to stop the hemorrhaging. They did a CT scan to check out the tumors. She had lymph nodes 12 to 13 centimeters in size. She also had many small ones 5 to 6 centimeters. She did take the radium, but she also drank the Alternative Native Herbal tea 3 times a day. She used 2 ozs of tea with 2 ozs of water. She also took the Red Clover Plus to build her blood and cleanse her liver. The doctor did a CT scan on her every month for 5 months. Each time the lymph nodes were smaller until they were gone. She drank the tea every day, and the doctors were amazed. Effie K. (Texas) [Exhibit A, pp11-12]

- t. My husband became sick with a cancer growing in his small intestine, he had 60% of his intestine removed with surgery. The doctor put him on 5 days of very strong chemotherapy. He became so sick he almost died from the strong treatment. He quit the chemo and refused to use any other allopathic drugs. He began using all natural products and started using the Alternative treatment of the Native Herbal Tea, Red Clover Plus, and also added Chlora Plasma. The Oncologist said that my husband has become a miracle. He had a bone scan and a MRI test with "no cancer" now. We are so excited about the Native Herbal tea that many others are using it because of my husband's results. Thank you for giving us this wonderful information." S.G. [Exhibit A, p12]
- u. A thirteen year old girl was diagnosed with a large tumor the size of a football, located over her left kidney and in her left adrenal gland. After removing the solid tumor, she was put on a regiment of very strong Chemotherapy. Her immune system naturally would plummet after every treatment of the conventional chemo. Even though, she had a very rare cancer of only one per 3 million, she credits her survival today, to the Alternative treatment of drinking the Native Herbal [T]ea! S.V. [Exhibit A, p12]
- v. A person with prostate cancer was given only a short time to live from the allopathic medicine professionals. They had done all they could do. The person was very ill and had lost a great deal of weight. He could not eat. His wife made the Native Herbal tea and began to give it to him 3 times a day, as well as little amounts of food every few hours. They reported a very significant reduction in pain. The man began to gain weight and is still alive and healing. [Exhibit A, p12]
- 14. On August 27, 2007, an FTC Advisory Letter was emailed to the Defendants' website advising them that health-related claims, like those made about cancer on the website, must be supported by competent and reliable scientific evidence and that it is against the law: (1) to make health claims without scientific support; (2) to exaggerate the benefits of products or services; or (3) to misstate the level of scientific support for claims made. The Advisory Letter also informed Defendants that:

If your website makes express claims (literally made in the ad) or claims by implication (made indirectly or by inference) about the benefits of any cancer-related products or services that are not substantiated by competent and reliable scientific evidence, or are otherwise deceptive or fraudulent, you must stop making those claims immediately.

15. On September 27, 2007, in response to a request from Defendant Timothy Westberry for further assistance in understanding his legal requirements, the FTC sent him an additional email. This correspondence listed specific cancer-related claims, made for each of the five products (including many of the specific claims cited above), that are believed to be without the support of competent and reliable scientific evidence. In addition, Mr. Westberry was sent three press releases that described previous FTC lawsuits against companies making false and/or unsubstantiated health-related claims for a variety of products, including similar cancer treatment and/or cure claims for essiac tea and cats claw.

SECTIONS 5 AND 12 OF THE FTC ACT

16. Section 5(a) of the FTC Act, 15 U.S.C. § 45(a), prohibits unfair or deceptive acts or practices in or affecting commerce. Section 12(a) of the FTC Act, 15 U.S.C. § 52(a), prohibits the dissemination of any false advertisement in or affecting commerce for the purpose of inducing, or which is likely to induce, the purchase of food, drugs, devices, services, or cosmetics. For the purposes of Section 12 of the FTC Act, Defendants' herbal products are either "foods" or "drugs" as defined in Section 15(b) and (c) of the FTC Act, 15 U.S.C. § 55(b) and (c). As set forth below, the Defendants have engaged in, and are continuing to engage in, such unlawful practices in connection with the marketing and sale of their herbal products, including: Native Herbal Tea, Cats Claw, Chlora Plasma, Red Clover Plus, and Melatonin.

DECEPTIVE ACTS OR PRACTICES IN VIOLATION OF THE FTC ACT

COUNT I

17. Through the means described in Paragraphs 12 and 13, including but not limited to the statements contained in Defendants' website attached as Exhibit A, Defendants have

represented, expressly or by implication, that Native Herbal Tea:

- is effective in treating and curing many kinds of cancer, including but not limited to breast cancer, cervical cancer, skin cancer, brain cancer, stomach cancer, and prostate cancer;
- b. is effective in reducing the size of, or eliminating, cancerous cysts;
- c. is effective in causing skin cancer to disappear in a short period of time; and
- d. is proven by CT Scans and MRIs to shrink the size of tumors in a short period of time.
- 18. The representations set forth in Paragraph 17 are false or were not substantiated at the time they were made. Therefore, the making of the representations set forth in Paragraph 17 constitutes a deceptive practice, and the making of false advertisements, in or affecting commerce, in violation of Sections 5(a) and 12 of the FTC Act, 15 U.S.C. §§ 45(a) and 52.

COUNT II

- 19. Through the means described in Paragraphs 12 and 13, including but not limited to the statements contained in Defendants' website attached as Exhibit A, Defendants have represented, expressly or by implication, that Cats Claw:
 - a. is effective in treating cancer; and
 - b. is effective in preventing the development and growth of malignant cells in cancer and other tumorous conditions.
- 20. The representations set forth in Paragraph 19 are false or were not substantiated at the time they were made. Therefore, the making of the representations set forth in Paragraph 19 constitutes a deceptive practice, and the making of false advertisements, in or affecting commerce, in violation of Sections 5(a) and 12 of the FTC Act, 15 U.S.C. §§ 45(a) and 52.

COUNT III

- 21. Through the means described in Paragraphs 12 and 13, including but not limited to the statements contained in Defendants' website attached as Exhibit A, Defendants have represented, expressly or by implication, that Chlora Plasma:
 - a. is effective in treating cancer; and
 - b. is effective in reducing cancerous tumors.
- 22. The representations set forth in Paragraph 21 are false or were not substantiated at the time they were made. Therefore, the making of the representations set forth in Paragraph 21 constitutes a deceptive practice, and the making of false advertisements, in or affecting commerce, in violation of Sections 5(a) and 12 of the FTC Act, 15 U.S.C. §§ 45(a) and 52.

COUNT IV

- 23. Through the means described in Paragraphs 12 and 13, including but not limited to the statements contained in Defendants' website attached as Exhibit A, Defendants have represented, expressly or by implication, that Red Clover Plus:
 - a. is effective in treating cancer; and
 - b. is effective in treating cancerous growths.
- 24. The representations set forth in Paragraph 23 are false or were not substantiated at the time they were made. Therefore, the making of the representations set forth in Paragraph 23 constitutes a deceptive practice, and the making of false advertisements, in or affecting commerce, in violation of Sections 5(a) and 12 of the FTC Act, 15 U.S.C. §§ 45(a) and 52.

COUNT V

25. Through the means described in Paragraphs 12 and 13, including but not limited to the statements contained in Defendants' website attached as Exhibit A, Defendants have

represented, expressly or by implication, that Melatonin:

- a. is effective in treating many kinds of cancer, including but not limited to breast cancer, prostate cancer, and melanoma;
- b. is effective in destroying substances that cause disease and tumors; and
- is shown in some studies and trials to improve the survival time and quality of life
 of patients with untreatable cancer.
- 26. The representations set forth in Paragraph 25 are false or were not substantiated at the time they were made. Therefore, the making of the representations set forth in Paragraph 25 constitutes a deceptive practice, and the making of false advertisements, in or affecting commerce, in violation of Sections 5(a) and 12 of the FTC Act, 15 U.S.C. §§ 45(a) and 52.

INJURY

27. Consumers throughout the United States have suffered and continue to suffer substantial monetary loss as a result of Defendants' unlawful acts or practices. In addition, Defendants have been unjustly enriched as a result of their unlawful practices. Absent injunctive relief by this Court, Defendants are likely to continue to injure consumers, reap unjust enrichment, and harm the public interest.

THIS COURT'S POWER TO GRANT RELIEF

28. Section 13(b) of the FTC Act, 15 U.S.C. § 53(b), empowers this Court to grant injunctive and such other relief as the Court may deem appropriate to halt and redress violations of the FTC Act. The Court, in the exercise of its equitable jurisdiction, may award other ancillary relief, including but not limited to, rescission or reformation of contracts, restitution, the refund of monies paid, and the disgorgement of ill-gotten monies, to prevent and remedy injury caused by Defendants' law violations.

PRAYER FOR RELIEF

Wherefore, Plaintiff Federal Trade Commission, pursuant to Section 13(b) of the FTC Act, 15 U.S.C. § 53(b), and the Court's equitable powers, requests that this Court:

- (1) Enter a permanent injunction to prevent future violations of the FTC Act by Defendants;
- (2) Award such equitable relief as the Court finds necessary to redress injury to consumers resulting from Defendants' violations of Sections 5(a) and 12 of the FTC Act, including but not limited to, rescission or reformation of contracts, restitution, the refund of monies paid, and the disgorgement of ill-gotten monies; and
- (3) Award Plaintiff the costs of bringing this action, as well as such other and additional relief as the Court may determine to be just and proper.
