Docket No. 9324 12 a corporation. **PUBLIC** 13 **DECLARATION OF BRIAN ROHTER** 14 15 16 I, Brian Rohter, under penalty of perjury, do hereby declare: 17 I am over the age of 18 years and have personal knowledge of the matters 18 set forth herein. 19 2. I am the Chief Executive Officer of New Seasons Markets. New Seasons 20 Markets has nine stores in the Portland (Oregon) metropolitan area. Our management team 21 includes more than 300 people. Those range from executives such as myself to store managers, 22 department managers, human resources managers, merchandising managers, and so forth. 23 3. Each of those people on the management team has their own New Seasons 24 email account and much of their work is done by email, both within the company and with 25 outside vendors and the like. 26

1	4. The period preceding Thanksgiving is the busiest week to ten days of the			
2	year for our business, and the month of December is the busiest month of the year for New			
3	Seasons. For New Seasons to divert employees to respond to the Whole Foods subpoena during			
4	this period of the year or even to allow outsiders to have access to New Seasons' computer			
5	system in order to conduct the kind of search necessary to comply with the Whole Foods			
6	subpoena would be extremely disruptive to our business and would result in substantial financia			
. 7	losses to the company at a time when economic conditions are already extremely difficult. New			
8	Seasons could not carry on its normal business during the holiday season if it was required to			
9	comply with the document requests set forth in the Whole Foods subpoena.			
10	5. New Seasons is a private company. None of its stock is publicly held and			
11	it is not subject to any of the reporting requirements of public companies.			
12	6. New Seasons diligently guards its confidential information, which would			
13	include sales and cost figures, market surveys, marketing plans, growth and expansion plans, an			
14	assessments of competitors. Our computer system is password protected and we restrict certain			
15	types of information about the company to a small number of management employees. Because			
16	of the highly competitive nature of the grocery business, inside information regarding any market			
17	surveys, marketing plans, growth and expansion plans and assessments of competitors that may			
18	be created by New Seasons Market would be extremely valuable to a competitor, and the			
19	disclosure of this information to anyone in the industry would enable a knowledgeable person or			
20	company to construct a business plan that would be damaging, if not fatal, to New Seasons'			
21	business. New Seasons does not release this highly confidential information to anyone outside			
22	of the company except as contractually required (subject to confidentiality agreements), and			
23	severely restricts access to it even within the company.
