**RESPONDENTS' OPPOSITION TO COMPLAINT COUNSEL'S MOTION AND  
MEMORANDUM TO MODIFY COMPLAINT COUNSEL'S FINAL EXHIBIT  
LIST AND TO INTRODUCE NEW EVIDENCE TO THE COURT ON  
RESPONDENTS' FOR-PROFIT LEGAL STATUS**

Respondents respectfully ask this court to deny Complaint Counsel's Motion and Memorandum to Modify Complaint Counsel's Final Exhibit List and to Introduce New Evidence to the Court on Respondents' For-Profit Legal Status. Complaint Counsel seeks to introduce new evidence from the Corporations Division of the State of Rhode Island Office of the Secretary of State (hereinafter, "Rhode Island Corporations Division") alleged by Complaint Counsel to concern DCO's **prior** for-profit legal status, at the Court's April 21, 2009 hearing on jurisdiction in this matter and at trial. Respondents oppose Complaint Counsel's motion because the material offered is both irrelevant and misleading.

This evidence is not relevant to Respondents' current financial status because as

Complaint Counsel points out the subject information concerns at best a “prior” organizational structure of Daniel Chapter One which Complaint Counsel alleges to relate to DCO’s corporate status. Respondents restate, as said in their Pre-Hearing Memorandum on Jurisdiction, that "Daniel Chapter One is a non profit religious organization" and that it operated as an "unincorporated religious association" beginning in 1983.

The documents sought to be introduced by Complaint Counsel are a partial record of Daniel Chapter One’s status in the state of Rhode Island. The entire records, which are available online, demonstrate that the corporate status applied for in 1991 received revocation notices on 11/14/1994, 6/12/1997, and 5/26/98, a revocation certificate on 11/01/1998 and filed one annual report in 1997. Virtually the same record exists for World Sports Nutrition. See Exhibits 1 and 2.

In fact, DCO operated as an unincorporated religious association which an advisor tried to register —unsuccessfully— as a corporation in Rhode Island, during a period when James Feijo was critically ill with Multiple Sclerosis and trying to manage DCO activities in China. See Exhibit 3, Declaration of James Feijo. DCO had none of the indicia of a corporation, such as a board of directors, and never operated as an officially recognized entity other than, subsequent to October 30, 2002, as a Corporation Sole.


For the above stated reasons Respondents respectfully ask the court to deny Complaint Counsel’s motion.

**DECLARATION OF JAMES FEIJO**


I, James Feijo, make the following declaration:

1. In 1991 I was at the height of my battle with Multiple Sclerosis symptoms and we were involved intensely in our activities in China requiring that Daniel Chapter One facilities in Rhode Island be managed by other volunteers. In addition, for a number of years afterwards, I was periodically incapacitated for periods of time. During this time I had someone helping me with management matters and that individual told me that incorporating the ministry with the State of Rhode Island was the proper thing to do. I believe that papers had already been filed but I do not remember. I was led to believe that to incorporate was the lawful and only way to run the Ministry of Daniel Chapter One. I never knew that there were other options. Still, as I learned what incorporation entailed including that it meant that the work of the Lord was going to funding ungodly support of government programs I determined that it was not appropriate for Daniel Chapter One to be a corporation. In fact, I do not know if it was ever recognized by Rhode Island. To the best of my knowledge we did not have a board of directors or officers – everything belonged to Jesus, we did not keep corporate records. We stopped pursuing this filing and intended to allow it to expire and continue to operate as a Free Church. It appears from the State of Rhode Island records that a report was filed in 1997—the only report filed by Daniel Chapter One. I do not know who filed this report but to the best of my recollection I do not believe I authorized it. At no time did I seek for Daniel Chapter One to operate as a corporation or intend to be incorporated in Rhode Island.

2. We have periodically followed the advice of people who we believe have expertise on worldly matters, and in a number of cases we later learned that their advice was not appropriate for our ministry. Eventually I learned about the Corporate Sole form and recognized that it was the proper form for the Daniel Chapter One ministry because it reflected our mission and method of operations. That we seek to own nothing and that everything belongs to God Almighty.

I declare under penalty of perjury that the foregoing is true and correct.
