ORDER GRANTING UNOPPOSED MOTION OF NON-PARTY ORACLE CORPORATION FOR EXTENSION OF TIME TO FILE MOTION TO QUASH OR TO LIMIT SUBPOENA DUCES TECUM

On March 5, 2010, non-party Oracle Corporation ("Oracle") submitted an Unopposed Motion for an Extension of Time to File a Motion to Quash or Limit ("Motion") a Subpoena *Duces Tecum* served by Complaint Counsel on February 24, 2010 ("Subpoena").¹

Oracle's Motion requests an order allowing until March 24, 2010 to file a motion to quash or limit, and further providing that Oracle's obligation to respond to the Subpoena shall be tolled during that extension period. Oracle states that it is in discussions with Complaint Counsel regarding the scope of the specifications in the Subpoena, Oracle's objections thereto, and the time required for Oracle to respond. Oracle further states that it has requested that Complaint Counsel agree that Oracle shall have an additional twenty (20) days in which to file a motion to quash or limit the Subpoena, should the parties' discussions fail to result in a resolution of all issues.

Oracle also states that the proposed extension has been agreed upon in order to afford Oracle sufficient time to review the Subpoena and discuss with Complaint Counsel opportunities to limit the scope of the Subpoena, with the purpose of avoiding the necessity of filing a motion to quash or limit. Oracle advises that it has conferred with Complaint Counsel and that Complaint Counsel does not object to the proposed extension.

¹ The instant Subpoena is, according to Oracle, "separate from the subpoena" that was the subject of the Oracle's March 2, 2010 Unopposed Motion for Extension of Time to File Motion to Quash or to Limit Subpoena *Duces Tecum*, which Oracle states focused on documents held by Oracle's recently acquired company, Sun Microsystems, Inc. Motion at 1. *See* Order Granting Unopposed Motion of Non-Party Oracle Corporation for Extension of Time to File Motion to Quash or to Limit Subpoena *Duces* Tecum, issued March 4, 2010.

Based on the foregoing, the Motion is GRANTED, and it is hereby ORDERED that Oracle shall have until March 24, 2010 to file a motion to quash or limit the Subpoena served upon it by Complaint Counsel on February 24, 2010, and further, that Oracle's obligation to respond to the Subpoena shall be tolled during this extension period.
