


RESPONDENT'S REVISED NOTICE OF APPEAL

Pursuant to FTC Rule of Practice § 3.52(a), 16 C.F.R. § 3.52(a), Respondent hereby amends its Notice of Appeal and gives notice that it will appeal, against Complaint Counsel, the following portions of the Initial Decision and Order entered by the Administrative Law Judge in the above captioned proceeding, as well as certain procedural and evidentiary rulings, in the above captioned proceeding:

1. All portions relating to Count I of the Complaint in their entirety;
2. The portions relating to Count III of the Complaint discussing whether Respondent had monopoly power or a dangerous probability of achieving or maintaining monopoly power in alleged North American deep-cycle, motive and UPS battery separator markets; and
