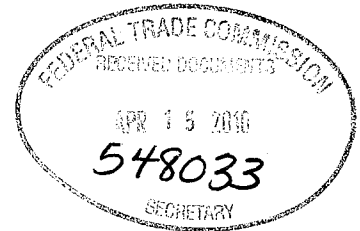

**MICROSOFT CORPORATION'S UNOPPOSED MOTION FOR EXTENSION OF TIME
TO FILE MOTION TO QUASH OR LIMIT COMPLAINT COUNSEL'S
SUBPOENA *DUCES TECUM***

Non-party Microsoft Corporation ("Microsoft") files this unopposed Motion for Extension of Time to File Motion to Quash or Limit Complaint Counsel's Subpoena *Duces Tecum*, received by Microsoft's agent for service of process on April 7, 2010 ("Subpoena"). The Subpoena includes seventeen (17) requests for production of documents.

Pursuant to the FTC's Rules of Practice, 16 C.F.R. § 3.34(c), Microsoft has ten (10) days in which to file a motion to quash or limit the Subpoena, or until April 19, 2010.


Microsoft's Counsel and Complaint Counsel have agreed that Microsoft shall have until May 3, 2010 to file a motion to quash or limit the Subpoena. Microsoft's Counsel and Complaint Counsel are in negotiations regarding the Subpoena and require more time to complete their negotiations effectively. In addition, because Microsoft will respond to both Complaint Counsel's Subpoena as well as Intel Corporation's ("Intel") subpoena and due to the substantial overlap between their specifications, Microsoft's Counsel and Complaint Counsel have agreed it will be most efficient for Microsoft's time to file a motion to quash or limit the

Subpoena to correspond to Microsoft's deadline to file a motion to quash or limit Intel's subpoena, which is currently due May 3, 2010.

Accordingly, Microsoft respectfully requests that this unopposed motion be granted and that Microsoft have until May 3, 2010 to file a motion to quash or limit the Subpoena.¹ Further, during such time, Microsoft's obligations to otherwise respond to the Subpoena shall be tolled.

Undersigned counsel represents that they have conferred with Complaint Counsel and that Complaint Counsel does not object to the proposed extension.

**[PROPOSED] ORDER GRANTING NON-PARTY MICROSOFT CORPORATION'S
UNOPPOSED MOTION FOR EXTENSION OF TIME TO FILE MOTION TO QUASH
OR LIMIT COMPLAINT COUNSEL'S SUBPOENA *DUCES TECUM***

On April 15, 2010, non-party Microsoft Corporation ("Microsoft") submitted an unopposed motion for extension of time to move to quash or limit a Subpoena *Duces Tecum* received from Complaint Counsel on April 7, 2010 ("Subpoena").

Microsoft states that it is negotiating with Complaint Counsel to resolve concerns regarding the scope of the Subpoena and that additional time is need to complete those negotiations. Microsoft further states that Complaint Counsel has agreed that Microsoft may have an extension of time to submit a motion to quash or limit the Subpoena equal in length to Microsoft's obligation to submit a motion in response to Intel's subpoena *duces tecum*. Accordingly, Microsoft seeks an extension of time through May 3, 2010, and further requests that its obligations to otherwise respond to the Subpoena be tolled during the period of the extension.

Based on the foregoing, Microsoft's Unopposed Motion for Extension of Time to File Motion to Quash or Limit Complaint Counsel's Subpoena *Duces Tecum* is GRANTED, and it is hereby ORDERED that Microsoft shall have until May 3, 2010 to file a motion to quash or limit the subpoena received from Complaint Counsel on April 7, 2010, and that Microsoft's obligations to otherwise respond to such subpoena shall be tolled during the period of the extension.


