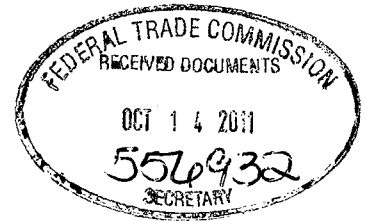

DECLARATION OF NATHAN E. STANDLEY


I, Nathan E. Standley, declare as follows:
