Given the parties' agreement that Defendant Graco Inc. will give Plaintiff two weeks' notice before consummating the transaction which Plaintiff seeks to enjoin in this litigation, Plaintiff's Motion for Temporary Restraining Order is hereby DENIED WITHOUT PREJUDICE; it is

FURTHER ORDERED that Defendants shall give Plaintiff at least two weeks' notice prior to consummating the transaction; Defendants' opposition to Plaintiff's Motion for Preliminary Injunction (Docket No. 9) shall be submitted no later than two (2) days after the giving of such notice; and Plaintiff's reply brief, if any, is due seven (7) days after filing of Defendants' opposition. The Court will schedule a hearing once the motion for preliminary injunction has been fully briefed.
