Thank you for your comments regarding the proposed consent order accepted by the Federal Trade Commission for public comment in the above-captioned matter. Your message describes numerous objections to making the consent order final. The Commission has reviewed your comments in connection with its decision concerning whether to accord final approval to the proposed consent order.

The Commission has placed your comment on the public record pursuant to Rule 4.9(b)(6)(ii) of the Commission's Rules of Practice, 16 C.F.R. § 4.9(b)(6)(ii), and it has been given careful consideration. The investigation examined all of the markets in which the transaction was likely to have a competitive impact, including the forensic testing services market. Because that market is relatively unconcentrated, the parties taken together do not account for a large portion of that market, and there were no other indications of likely anticompetitive effects in that market, no action was taken regarding the forensic testing services component of the acquisition. The Commission has determined that the public interest would best be served by issuing the Decision and Order in final form without modification.
