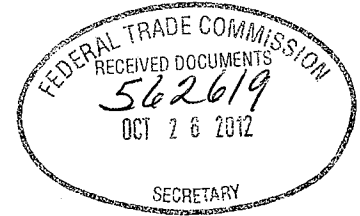

**ORDER ON RESPONDENT'S AND COMPLAINT COUNSEL'S
MOTIONS FOR *IN CAMERA* TREATMENT**

Pursuant to Rule 3.45(b) of the Commission's Rules of Practice, orders granting *in camera* treatment for certain materials meeting the Commission's standards were previously issued on August 17, 2012 (granting *in camera* treatment for certain McWane, Inc. material); August 17, 2012 (granting *in camera* treatment for certain materials submitted by non-parties, including Sigma Corporation); and August 31, 2012 (granting *in camera* treatment for certain Star Pipe Products, Ltd. material). The expert reports submitted on behalf of both Complaint Counsel and Respondent contain information derived in part from materials that have been granted *in camera* treatment pursuant to those orders. At the direction of the Court, Respondent and Complaint Counsel each filed a motion for *in camera* treatment requesting *in camera* treatment for those portions of their expert reports referring to *in camera* material. Complaint Counsel also seeks *in camera* treatment for a demonstrative exhibit to be used with its expert containing such information. Neither side opposes the other's motion.

Respondent's Motion, filed October 22, 2012 is GRANTED. *In camera* treatment, for a period of five years, to expire on September 1, 2017¹ is granted for the Expert Report of Dr. Parker Normann, ("Normann Report") which Respondent attached to its Motion as Exhibit A. The public, redacted version of the Normann Report is designated as RX 712A. Respondent shall withdraw its previous version of RX 712A and submit the version attached to its motion to the court reporter for the official record. Respondent is also directed to provide an *in camera*, non-redacted version with a designation of RX 712B, to the court reporter for the record.

¹ In order to make the expiration date of *in camera* treatment consistent across all exhibits for which *in camera* treatment has been granted, the expiration date shall be September 1, 2017.

Complaint Counsel's Motion, filed October 24, 2012, is GRANTED. *In camera* treatment, for a period of five years, to expire on September 1, 2017 is granted for the Expert Report of Dr. Laurence Schumann, which is designated as CX 2260; the Rebuttal Expert Report of Dr. Schumann, which is designated as CX 2265; and Dr. Schumann's Rebuttal Testimony Demonstrative Exhibit, which is designated as CXD 3085. Complaint Counsel is directed to withdraw its previous version of CX 2260, CX 2265, and CXD 3085 and submit the complete version of these exhibits, which indicates the *in camera* material, to the court reporter for the official record. Complaint Counsel is also directed to provide a public, redacted version, of each of these exhibits, with the designations CX 2260A, CX 2265A, and CXD 3085A, to the court reporter for the official record.
