# CONSENT ORDER, ETC., IN REGARD TO ALLEGED VIOLATION OF SECS. 5 AND 12 OF THE FEDERAL TRADE COMMISSION ACT

## Docket C-3463. Complaint, Oct. 7, 1993--Decision, Oct. 7, 1993

This consent order prohibits, among other things, a California-based corporation, that advertised and promoted "Therapy Plus," from misrepresenting: the efficacy of certain devices; the degree to which scientific proof demonstrates that any such device is effective in reducing, relieving, or eliminating pain; the degree to which such a device is a significant medical breakthrough; or the degree to which the device is used, recommended, or accepted by the relevant medical or scientific community as effective in reducing, relieving or eliminating pain. This consent order also requires the respondent to possess competent and reliable scientific evidence to substantiate future health and pain-relief claims. In addition, the order prohibits the respondent from misrepresenting the endorsement for any product or service or the connection between the endorser and any individual or company marketing the product or service.

## COMPLAINT

The Federal Trade Commission, having reason to believe that Numex Corporation, a corporation, hereinafter sometimes referred to as respondent, has violated the provisions of the Federal Trade Commission Act, and it appearing to the Commission that a proceeding by it in respect thereof would be in the public interest, alleges:

#### Complaint

PARAGRAPH 1. Respondent Numex Corporation is a Delaware corporation, with its offices and principal place of business located at 12604 Hiddencreek Way, Suite C, Cerritos, California.

PAR. 2. Respondent has manufactured, advertised, labeled, offered for sale, sold, and distributed a device, Therapy Plus, to the public. Therapy Plus is a hand-held, mechanical roller purported to be a pain-relieving device. This product is a "device" within the meaning of Sections 12 and 15 of the Federal Trade Commission Act.

PAR. 3. The acts and practices of respondent alleged in this Complaint have been in or affecting commerce, as "commerce" is defined in Section 4 of the Federal Trade Commission Act.

PAR. 4. Respondent has disseminated or has caused to be disseminated advertisements and promotional materials for Therapy Plus, including but not necessarily limited to the attached Exhibit A a transcription of the program-length television commercial or "infomercial" entitled "Freedom From Pain." The aforesaid advertisement contains the following statements and depictions:

A. THELMA NORA (Consumer Endorser): "My headaches are gone, my neck, the stiffness of my neck; I can move my neck and shoulders and everything. I feel great." (Exhibit A, p. 1)

B. ROGER BARKLEY (Announcer): "It's called Therapy Plus, the pain reliever and its effectiveness is backed by scientific proof and documented clinical use. You'll meet some of the people who have used it: the professional sports star, the weekend warrior, and the incredible testimony of pain sufferers; how it relieves acute pains, chronic pains, the pain of arthritis, bursitis, tendinitis, and many other muscle-related pains. You'll hear from doctors who have treated hundreds of patients with positive results, and you'll see the scientific proof that Therapy Plus really works." [Depiction: Therapy Plus being rolled on man in glass enclosure in laboratory] (Exhibit A, p.3)

C. BARKLEY: "I know it's hard to believe, but this little device can literally roll away pain. Stephanie Osnower knows. In addition to arthritic hands, she had terrible pain in her leg from standing too much."

STEPHANIE OSNOWER (Consumer Endorser): "And I suddenly had a swelling in this area behind my knee and it got larger and larger and larger."

BARKLEY: "Stephanie visited her doctor who rolled her leg with this therapeutic device back and forth for several minutes. She said that the pain went away."

OSNOWER: "And he said, 'Tell me when you feel better,' and it was almost immediate, almost immediate that I began to feel better and had some relief." (Exhibit A, p. 4)

D. MARGARET TANNEHILL (Consumer Endorser): "I've had rheumatoid arthritis for five years. And the past year it had gotten worse, to the point where I thought of giving up golf and also knitting, and those are my two favorites. So I thought, well, I'll borrow a roller from a friend for one week and see if it would work because I've heard so much about it. So I borrowed the roller, and the first night I thought, my God, it worked, because I slept all night. . . . So I used it for one week and went and purchased one. And since then, I hadn't worn my rings for one year, and I do wear them. And my knuckles were gnarled; you can still see probably a little, but you have no idea how pretty these hands look to me. And I do this watching television. Sometimes it runs seven minutes but five minutes is what I give myself on each hand. That's all I do, and I do it religiously every night and I love it." (Exhibit A, pp. 6-7)

E. BARKLEY: "Maurice Lindsay, a physicist and engineer, was told by bone surgeons that he would have to have operations on both knees in order to relieve his pain."

MAURICE LINDSAY (Consumer Endorser): "Well, I came in and said, 'Jim, I can't take it anymore. My knees are so bad that they hurt constantly, and I'd like to have you make arrangements to have them operated on -- they're just too painful.' So, he kind of chuckled and got the roller out and -- I'd never seen one, of course, before -- and he had me sit there while he rolled the knee. And it was hurting; it was hurting, that's why I came in. And I was hurting whether I was sitting, standing, walking, or whatever, and running was out of the question. And so he rolled it rather vigorously, oh, maybe three or four minutes, and said, 'Now get up and walk towards the door,' which I did, and he said, 'Do you feel any-thing?,' and I said, 'No, my knee does not hurt.' So, it was an immediate sale, no questions asked! I had to have one." [Superimposed Text: "Arthritic Knee Pain Relieved with Therapy Plus"] (Exhibit A, pp. 7-8)

F. GEORGE STEVENS (Consumer Endorser): "I rolled my elbow, and I was going to get a shot that day -- cortisone shot -- and I rolled it, about five minutes, and it worked. It was great. All the tendinitis and stuff -- it was excellent." (Exhibit A, p. 8)

G. VOICE-OVER: "Imagine what it would feel like to have your pain disappear. Therapy Plus is the breakthrough pain-relieving device that is completely safe and easy to use. It is recommended by medical doctors, chiropractors, and other health experts." [Depiction: Dr. Randolph Stern using Therapy Plus to point to anatomical charts of human body] (Exhibit A, pp. 10 and 18)

H. VOICE-OVER: "Its design is unique, and reports from scientists at a major university and research hospital have proven that is does work. (Depiction: Therapy Plus being rolled on man in glass enclosure in laboratory.) Its effectiveness has even been presented at the American Pain Society. Patients who have

been suffering with chronic pain for years, now relieve pain in minutes, with no effort, no exercise, and no drugs." (Exhibit A, pp. 10-11 and 18-19)

I. VOICE-OVER: "Just roll it gently but rapidly over the area where pain exists, such as arthritic hands, tight shoulder, sore knees, elbows, or the lower back, even muscles stressed during recreation. It works almost anywhere. Most people report their pain disappearing in just minutes." (Exhibit A, pp. 11 and 19-20)

J. BARKLEY: "Can there be anybody else who knows as much about pain as an NFL football player? Nolan Cromwell spent eleven years with the Los Angeles Rams, and is a four-time all-pro safety."

NOLAN CROMWELL: "The first time I saw the roller, I thought it was a joke. You know, here they're going to take something that you just roll lightly on the skin, and reduce the pain anywhere on your body. But after using it for the first time and finding out that it does work and the simplicity that is there -- it goes in your pocket; you carry it wherever you want to go -- and it works. I was totally surprised that it did relieve the pains actually in all parts of my body." [Superimposed Text: "Therapy Plus replaced expensive physiotherapy treatments"] (Exhibit A, pp. 15-16)

K TANNEHILL: "For every one of you that has arthritis: believe me, purchase this. It costs pennies compared to what your prescription costs. Two prescriptions and this is paid for. And I'll guarantee it will work. It worked on me." (Exhibit A, p. 17)

L. VOICE-OVER: "If there really is a way you can safely relieve your pain without drugs, without oils and balms, without frequent and costly doctor visits, and without effort or exercise, any time, any place in just minutes, shouldn't you try it yourself?" (Exhibit A, pp. 12 and 20)

M. DR. RANDOLPH STERN, CHIROPRACTOR: "The most remarkable thing is that everyone that I have recommended using Therapy Plus has benefited from it, across the board, so I feel very confident in recommending it to my patients." [Depiction: Dr. Randolph Stern using Therapy Plus to point to anatomical charts of human body] (Exhibit A, p. 5)

N. R. STERN: "When Therapy Plus was first presented to me, I reviewed the research, which made sense. It made sense on a scientific and practical level. And so it was very easy for me to utilize it in my practice and recommend it to my patients, and they've had great results with it as well." [Depiction: Dr. Randolph Stern in front of anatomical charts of human body] [Superimposed text: "Scientific evidence convinced him to use Therapy Plus"] (Exhibit A, p. 9)

O. VOICE-OVER: "There is a new breakthrough in pain relief, and it works without drugs, in minutes. It's recommended by doctors, and proven to work in scientific tests. [Depiction: Dr. Randolph Stern using Therapy Plus to point to anatomical charts of human body] It is Therapy Plus." (Exhibit A, p. 23)

P. OSNOWER: "This is like a magic wand. That I can go like this when my thumb gets real bad and if you've had experience with arthritis it doesn't let you

know when it's going to decide to flare up it just flares up. But to be able to pick up the roller and go like this a couple times a day and then suddenly the swelling goes down and the thumb moves -- it's like a magic wand, it really is." (Exhibit A, p. 25)

Q. JAMES L. MCELHANEY, M.D.: "Since being introduced to Therapy Plus we've used this almost exclusively for the treatment of pain with very great success. It s been an absolute godsend to my patients in pain." (Exhibit A, p. 1)

R. DR. MCELHANEY: "I've treated more than 250 patients with Therapy Plus. We've had a 95% success rate in relieving their pain, and this has occurred in minutes. I find Therapy Plus very successful in the treatment of all types of musculo-skeletal pain, including tendinitis, bursitis, sprains, strains, tight spastic muscles, and even arthritis." (Exhibit A, pp. 4-5)

S. BARKLEY: "Doctor, you've treated a lot of pain sufferers with Therapy Plus. Can you tell us what kind of results you've seen?"

DR. MCELHANEY: "I've treated over 250 patients. 95% have experienced relief within minutes. It's the greatest advance in the treatment of pain that I've seen in all of my medical years, and for my patients, it's a godsend."

BARKLEY: "How does this device work?"

DR. MCELHANEY: "At first we didn't know. But research was then done at a leading southern California university and a leading hospital research center. [Depiction: Woman under metal cap with electrodes inside apparatus in laboratory] The first study showed by objective criteria that the roller relaxes tense muscles and muscles in spasm. [Depiction: Medical monitoring device in process of collecting and recording data) It also improves circulation in the area where it is rolled. And it brings the sympathetic nerves to a high state of arousal. These effects are definitely physiology and not psychology. [Depiction: Woman under metal cap with electrodes inside apparatus in laboratory] The results of this study were presented at the Eighth Annual Scientific Meeting of the American Pain Society. The second study is now being reviewed and accepted for publication in a scientific journal." (Exhibit A, pp. 13-14)

T. BARKLEY: "So the medical community must be very excited about this." DR. MCELHANEY: "Oh yes. Researchers, too - pain researchers. We think

that this is a major breakthrough in the treatment in pain." (Exhibit A, p. 14)

U. BARKLEY: "How does this compare with other muscular pain relievers?"

DR. MCELHANEY: "Compared to analgesics, liniments, physical therapy, or oral medications there's just no comparison. This works as effective or more effectively than any of those products." (Exhibit A, p. 14)

PAR. 5. Through the use of the statements and depictions contained in the advertisements and promotional materials referred to in paragraph four, including but not necessarily limited to the advertisement attached as Exhibit A, respondent has represented, directly or by implication, that:

#### Complaint

A. Scientific proof, including research at a major university and a leading research hospital, demonstrates that Therapy Plus is effective in significantly reducing, relieving, or eliminating pain.

B. Therapy Plus is a major breakthrough in the treatment of pain.

C. A substantial number of medical doctors use Therapy Plus and recommend it as an effective way to significantly reduce, relieve, or eliminate pain.

D. The statements of James McElhaney, M.D., appearing in the infomercial "Freedom From Pain" were the endorsements of an individual who, at the time of providing his endorsements, was independent from the individuals and entities marketing the product.

E. The statements of Nolan Cromwell appearing in the infomercial "Freedom From Pain" were the endorsements of an individual who, at the time of providing his endorsements, was independent from the individuals and entities marketing the product.

PAR. 6. In truth and in fact:

A. Scientific proof does not demonstrate that Therapy Plus is effective in significantly reducing, relieving, or eliminating pain.

B. Therapy Plus is not a major breakthrough in the treatment of pain.

C. A substantial number of medical doctors neither use Therapy Plus nor recommend it as an effective way to significantly reduce, relieve, or eliminate pain.

D. The statements of James McElhaney, M.D., appearing in the advertisements were not the endorsements of an individual who, at the time of providing his endorsements, was independent from the individuals and entities marketing the product. At the time of providing his endorsements, James McElhaney, M.D., was an officer and director of Numex Corporation, was to receive payments from Numex Corporation for each unit of Therapy Plus sold, and owned stock in Delux Distributions International, Inc., a corporate shareholder of Numex Corporation.

## FEDERAL TRADE COMMISSION DECISIONS

## Complaint

E. The statements of Nolan Cromwell appearing in the advertisements were not the endorsements of an individual who, at the time of providing his endorsements, was independent from the individuals and entities marketing the product. At the time of providing his endorsements, Nolan Cromwell was Athletic Director of Numex Corporation, was to receive payments from Numex Corporation for each unit of Therapy Plus sold, and owned stock in Delux Distributions International, Inc., a corporate shareholder of Numex Corporation.

Therefore, the representations set forth in paragraph five were, and are, false and misleading.

PAR. 7. Through the use of the statements and depictions contained in the advertisements and promotional materials referred to in paragraph four, including but not necessarily limited to the advertisement attached as Exhibit A, respondent has represented, directly or by implication, that:

A. Use of Therapy Plus will significantly reduce, relieve, or eliminate virtually all types of musculoskeletal pain, including acute pain, chronic pain, sprains, strains, tight spastic muscles, and the pain of arthritis, bursitis, and tendinitis.

B. Use of Therapy Plus will relieve headaches.

C. Therapy Plus can be safely used to relieve painful swelling in the legs.

D. Use of Therapy Plus will reduce, relieve, or eliminate swelling, gnarling, or deformities of the joints caused by rheumatoid arthritis.

E. Use of Therapy Plus will significantly reduce, relieve, or eliminate pain in minutes, even in individuals who have suffered from chronic pain for years.

F. For a substantial majority of people, Therapy Plus is effective in significantly reducing, relieving, or eliminating pain.

G. For the treatment of pain, Therapy Plus is as effective as, or more effective than, analgesics, liniments, physical therapy, or oral medications.

#### Complaint

H. Therapy Plus is an effective substitute for surgery in relieving the pain of arthritic knees.

I. Therapy Plus will significantly reduce, relieve, or eliminate arthritis and other pain without the need for medication, including prescription medication.

J. For the treatment of pain, use of Therapy Plus will eliminate the need for treatment by a doctor.

PAR. 8. Through the use of the statements and depictions contained in the advertisements and promotional materials referred to in paragraph four, including but not necessarily limited to the advertisement attached as Exhibit A, respondent has represented, directly or by implication, that at the time it made the representations set forth in paragraphs five and seven, respondent possessed and relied upon a reasonable basis that substantiated such representations.

PAR. 9. In truth and in fact, at the time it made the representations set forth in paragraphs five and seven, respondent did not possess and rely upon a reasonable basis that substantiated such representations. Therefore, the representation set forth in paragraph eight was, and is, false and misleading.

PAR. 10. Through the advertising and dissemination of the infomercial "Freedom From Pain," a transcription of which is attached hereto as Exhibit A, respondent has represented, directly or by implication, that the testimonials or endorsements from consumers appearing in advertisements for Therapy Plus reflect the typical or ordinary experience of members of the public who use Therapy Plus.

PAR. 11. Through the advertising and dissemination of the infomercial "Freedom From Pain," a transcription of which is attached hereto as Exhibit A, respondent has represented, directly or by implication, that, at the time it made the representation set forth in paragraph ten, it possessed and relied upon a reasonable basis that substantiated such representation.

PAR. 12. In truth and in fact, at the time it made the representation set forth in paragraph ten, respondent did not possess and rely upon a reasonable basis that substantiated such representation.

Therefore, the representation set forth in paragraph eleven, was, and is, false and misleading.

PAR. 13. In its advertising and sale of Therapy Plus, respondent has represented that James McElhaney, M.D., and Nolan Cromwell are endorsers of Therapy Plus. Respondent has failed to disclose adequately that McElhaney and Cromwell each has a material connection with Therapy Plus in that, at the time of providing their endorsements, McElhaney and Cromwell owned stock in Delux Distributions International, Inc., a corporate shareholder of Numex Corporation; McElhaney and Cromwell were to receive payments for each unit of Therapy Plus sold; McElhaney was an officer and director of Numex Corporation; and Cromwell was Athletic Director of Numex Corporation. These facts would materially affect the weight and credibility given by consumers to the endorsements and would be material to consumers in their decisions to purchase the product. Therefore, the failure to disclose adequately these facts, in light of the representations made, was, and is, a deceptive practice.

PAR. 14. The acts and practices of respondent as alleged in this complaint constitute unfair or deceptive acts or practices and the making of false advertisements in or affecting commerce in violation of Sections 5(a) and 12 of the Federal Trade Commission Act.

#### Decision an d Order

## DECISION AND ORDER

The Federal Trade Commission having initiated an investigation of certain acts and practices of the respondent named in the caption hereof, and the respondent having been furnished thereafter with a copy of a draft complaint which the Bureau of Consumer Protection proposed to present to the Commission for its consideration and which, if issued by the Commission, would charge respondent with violations of the Federal Trade Commission Act; and

The respondent and counsel for the Commission having thereafter executed an agreement containing a consent order, an admission by respondent of all the jurisdictional facts set forth in the aforesaid draft of complaint, a statement that the signing of said agreement is for settlement purposes only and does not constitute an admission by respondent that the law has been violated as alleged in such complaint, and waivers and other provisions as required by the Commission's rules; and

The Commission having thereafter considered the matter and having determined that it had reason to believe that the respondent has violated the said Act, and that complaint should issue stating its charges in that respect, and having thereupon accepted the executed consent agreement and placed such agreement on the public record for a period of sixty (60) days, and having duly considered the comment filed thereafter by an interested party pursuant to Section 2.34 of its Rules, now in further conformity with the procedure prescribed in Section 2.34 of its Rules, the Commission hereby issues its complaint, makes the following jurisdictional findings and enters the following order:

It is ordered, That, respondent Numex Corporation, a corporation, its successors and assigns, and its officers, agents, representatives and employees, directly or through any corporation, subsidiary, division or other device, in connection with the manufacturing, labeling, advertising, promotion, offering for sale, sale, or distribution of Therapy Plus or any other device, as "device" is defined in Section 15 of the Federal Trade Commission Act, in or affecting commerce, as "commerce" is defined in the Federal Trade Commission Act, do forthwith cease and desist from:

A. Misrepresenting, in any manner, directly or by implication, the degree to which scientific proof demonstrates that any such device is effective in reducing, relieving, or eliminating pain; or

B. Misrepresenting, in any manner, directly or by implication, the degree to which any such device is a significant medical breakthrough or a significant scientific advance; or

C. Misrepresenting, in any manner, directly or by implication, the degree to which any such device is used, recommended, or accepted by the relevant medical or scientific community as effective in reducing, relieving, or eliminating pain.

II.

It is further ordered, That, respondent Numex Corporation, a corporation, its successors and assigns, and its officers, agents, representatives and employees, directly or through any corporation, subsidiary, division or other device in connection with the manufacturing, labeling, advertising, promotion, offering for sale, sale, or distribution of any device, as "device" is defined in Section 15 of the Federal Trade Commission Act, in or affecting commerce, as "commerce" is defined in the Federal Trade Commission Act, do forthwith cease and desist from representing, in any manner, directly or by implication:

"competent and reliable scientific evidence" shall mean tests, analyses, research, studies, or other evidence based on the expertise of professionals in the relevant area, that has been conducted and evaluated in an objective manner by persons qualified to do so, using procedures generally accepted in the profession to yield accurate and reliable results.

senting, in any manner, directly or by implication, that any endorsement (as "endorsement" is defined in 16 CFR 255.0(b)) of such product or service represents the typical or ordinary experience of members of the public who use such product or service, unless respondent, at the time of making such representation, possesses and relies upon competent and reliable evidence that substantiates the representation. For purposes of this provision, if such evidence consists of any test, analysis, research, study, survey or other evidence based on the expertise of professionals in the relevant area, such evidence shall be "competent and reliable" only if it has been conducted and evaluated in an objective manner by persons qualified to do so, using procedures generally accepted in the profession to yield accurate and reliable results.

## VI.

It is further ordered, That, respondent Numex Corporation, a corporation, its successors and assigns, and its officers, agents, representatives and employees, directly or through any corporation, subsidiary, division or other device, in connection with the manufacturing, labeling, advertising, promotion, offering for sale, sale, or distribution of any product or service for personal or household use, in or affecting commerce, as "commerce" is defined in the Federal Trade Commission Act, do forthwith cease and desist from failing to disclose, clearly and prominently, a material connection, where one exists, between an endorser of any such product or service and respondent or any other individual or entity manufacturing, advertising, promoting, offering for sale, selling, or distributing such product or services. For purposes of this order, a "material connection" shall mean any relationship that might materially affect the weight or credibility of the endorsement and would not reasonably be expected by consumers.

# CONSENT ORDER, ETC., IN REGARD TO ALLEGED VIOLATION OF SECS. 5 AND 12 OF THE FEDERAL TRADE COMMISSION ACT

#### Docket C-3464. Complaint, Oct. 7, 1993--Decision, Oct. 7, 1993

This consent order prohibits, among other things, the former Executive Vice President of Numex, a California-based corporation that advertised and promoted "Therapy Plus," from misrepresenting: the efficacy of certain devices; the degree to which scientific proof demonstrates that any such device is effective in reducing, relieving, or eliminating pain; the degree to which such a device is a significant medical breakthrough; or the degree to which the device is used, recommended, or accepted by the relevant medical or scientific community as effective in reducing, relieving or eliminating pain. This consent order also requires the respondent to possess competent and reliable scientific evidence to substantiate future health and pain-relief claims. In addition, the order prohibits the respondent from misrepresenting the endorsement for any product or service or the connection between the endorser and any individual or company marketing the product or service.

## COMPLAINT

The Federal Trade Commission, having reason to believe that Gisela E. Flick, individually and as a former director and officer of Numex Corporation, hereinafter sometimes referred to as respondent, has violated the provisions of the Federal Trade Commission Act, and it appearing to the Commission that a proceeding by it in respect thereof would be in the public interest, alleges:

PARAGRAPH 1. Respondent Gisela E. Flick is or was at relevant times an officer and director of Numex Corporation, and a

shareholder in Delux Distributions International, Inc., a corporate shareholder of Numex Corporation. At all times relevant hereto, respondent, individually or in concert with others, participated in the formulation, direction and control of the acts and practices of Numex Corporation, including the acts and practices alleged in this complaint. Respondent resides at 19203 Moorshire Place, Cerritos, California.

PAR. 2. Numex Corporation, under the direction and control of respondent and others, has manufactured, advertised, labeled, offered for sale, sold, and distributed a device, Therapy Plus, to the public. Therapy Plus is a hand-held, mechanical roller purported to be a pain-relieving device. This product is a "device" within the meaning of Sections 12 and 15 of the Federal Trade Commission Act.

PAR. 3. The acts and practices of respondent alleged in this complaint have been in or affecting commerce, as "commerce" is defined in Section 4 of the Federal Trade Commission Act

PAR. 4. Numex Corporation, under the direction and control of respondent and others, has disseminated or has caused to be disseminated advertisements and promotional materials for Therapy Plus, including but not necessarily limited to the attached Exhibit A, a transcription of the program-length television commercial or "infomercial" entitled "Freedom From Pain." The aforesaid advertisement contains the following statements and depictions:

A. THELMA NORA (Consumer Endorser): "My headaches are gone, my neck, the stiffness of my neck; I can move my neck and shoulders and everything. I feel great." (Exhibit A, p. 1)

B. ROGER BARKLEY (Announcer): "It's called Therapy Plus, the pain reliever, and its effectiveness is backed by scientific proof and documented clinical use. You'll meet some of the people who have used it: the professional sports star, the weekend warrior, and the incredible testimony of pain sufferers; how it relieves acute pains, chronic pains, the pain of arthritis, bursitis, tendinitis, and many other muscle-related pains. You'll hear from doctors who have treated hundreds of patients with positive results, and you'll see the scientific proof that Therapy Plus really works." (Depiction: Therapy Plus being rolled on man in glass enclosure in laboratory] (Exhibit A, p. 3)

C. BARKLEY: "I know it's hard to believe, but this little device can literally roll away pain. Stephanie Osnower knows. In addition to arthritic hands, she had terrible pain in her leg from standing too much."

STEPHANIE OSNOWER (Consumer Endorser): "And I suddenly had a swelling in this area behind my knee and it got larger and larger and larger."

BARKLEY: "Stephanie visited her doctor who rolled her leg with this therapeutic device back and forth for several minutes. She said that the pain went away."

OSNOWER: "And he said, 'Tell me when you feel better,' and it was almost immediate, almost immediate that I began to feel better and had some relief." (Exhibit A, p. 4)

D. MARGARET TANNEHILL (Consumer Endorser): "I've had rheumatoid arthritis for five years. And the past year it had gotten worse, to the point where I thought of giving up golf and also knitting, and those are my two favorites. So I thought, well, I'll borrow a roller from a friend for one week and see if it would work, because I've heard so much about it. So I borrowed the roller, and the first night I thought, my God, it worked, because I slept all night . . . . So I used it for one week and went and purchased one. And since then, I hadn't worn my rings for one year, and I do wear them. And my knuckles were gnarled; you can still see probably a little, but you have no idea how pretty these hands look to me. And I do this watching television. Sometimes it runs seven minutes but five minutes is what I give myself on each hand. That's all I do, and I do it religiously every night and I love it." (Exhibit A, pp. 6-7)

E. BARKLEY: "Maurice Lindsay, a physicist and engineer, was told by bone surgeons that he would have to have operations on both knees in order to relieve his pain."

MAURICE LINDSAY (Consumer Endorser): "Well, I came in and said, 'Jim, I can't take it anymore. My knees are so bad that they hurt constantly, and I'd like to have you make arrangements to have them operated on -- they're just too painful.' So, he kind of chuckled and got the roller out and -- I'd never seen one, of course, before -- and he had me sit there while he rolled the knee. And it was hurting; it was hurting, that's why I came in. And I was hurting whether I was sitting, standing, walking, or whatever, and running was out of the question. And so he rolled it rather vigorously, oh, maybe three or four minutes, and said, 'Now get up and walk towards the door,' which I did, and he said, 'Do you feel anything?, ' and I said, 'No, my knee does not hurt.' So, it was an immediate sale, no questions asked! I had to have one." [Superimposed Text: "Arthritic Knee Pain Relieved with Therapy Plus"] (Exhibit A, pp. 7-8)

F. GEORGE STEVENS (Consumer Endorser): "I rolled my elbow, and I was going to get a shot that day -- cortisone shot -- and I rolled it, about five minutes, and it worked. It was great. All the tendinitis and stuff -- it was excellent." (Exhibit A, p. 8)

G. VOICE-OVER: "Imagine what it would feel like to have your pain disappear. Therapy Plus is the breakthrough pain-relieving device that is completely safe and easy to use. It is recommended by medical doctors, chiropractors, and other health experts." [Depiction: Dr. Randolph Stern using Therapy Plus to point to anatomical charts of human body] (Exhibit A, pp. 10 and 18)

H. VOICE-OVER: "Its design is unique, and reports from scientists at a major university and research hospital have proven that is does work. [Depiction Therapy Plus being rolled on man in glass enclosure in laboratory.] Its effectiveness has been presented at the American Pain Society. Patients have been suffering with chronic pain for years, now relieve pain in minutes, with no effort, no exercise, and no drugs." (Exhibit A, pp. 10-11 and 18-19)

I. VOICE-OVER: "Just roll it gently but rapidly over the area where pain exists, such a arthritic hands, tight shoulder, sore knees, elbows, or the lower back, even muscles stressed during recreation. It works almost anywhere. Most people report their pain disappearing in just minutes." (Exhibit A, pp. 11 and 19-20).

J. BARKLEY: "Can there be anybody else who knows as much about pain as an NFL football player? Nolan Cromwell spent eleven years with the Los Angeles Rams, and is a four-time all-pro safety."

NOLAN CROMWELL: "The first time I saw the roller, I thought it was a joke. You know, here they're going to take something that you just roll lightly on the skin, and reduce the pain anywhere on your body. But after using it for the first time and finding out that it does work and the simplicity that is there -- it goes in your pocket; you carry it wherever you want to go -- and it works. I was totally surprised that it did relieve the pains actually in all parts of my body." [Super-imposed Text: "Therapy Plus replaced expensive physiotherapy treatments"] (Exhibit A, pp. 15-16)

K. TANNEHILL: "For every one of you that has arthritis: believe me, purchase this. It costs pennies compared to what your prescription costs. Two prescriptions, and this is paid for. And I'll guarantee it will work. It worked on me." (Exhibit A, p. 17).

L. VOICE-OVER: "If there really is a way you can safely relieve your pain without drugs, without oils and balms, without frequent and costly doctor visits, and without effort or exercise, any time, any place in just minutes, shouldn't you try it yourself?" (Exhibit A, pp. 12 and 20).

M. DR. RANDOLPH STERN, CHIROPRACTOR: "The most remarkable thing is that everyone that I have recommended using Therapy Plus has benefited from it, across the board, so I feel very confident in recommending it to my patients." [Depiction: Dr. Randolph Stern using Therapy Plus to point to anatomical charts of human body] (Exhibit A, p. 5).

N. DR. STERN: "When Therapy Plus was first presented to me, I reviewed the research, which made sense. It made sense on a scientific and practical level. And so it was very easy for me to utilize it in my practice and recommend it to my patients, and they've had great results with it as well." [Depiction: Dr. Randolph

Stern in front of anatomical charts of human body] [Superimposed text: "Scientific evidence convinced him to use Therapy Plus"] (Exhibit A, p. 9)

O. VOICE-OVER: "There is a new breakthrough in pain relief, and it works without drugs, in minutes. It is recommended by doctors, and proven to work in scientific tests. [Depiction: Dr. Randolph Stern using Therapy Plus to point to anatomical charts of human body] It is Therapy Plus." (Exhibit A, p. 23)

P. OSNOWER: "This is like a magic wand. That I can go like this when my thumb gets real bad and if you've had experience with arthritis it doesn't let you know when it's going to decide to flare up it just flares up. But to be able to pick up the roller and go like this a couple times a day and then suddenly the swelling goes down and the thumb moves -- it's like a magic wand, it really is." (Exhibit A, p. 25)

Q. JAMES L. MCELHANEY, M.D.: "Since being introduced to Therapy Plus, we've used this almost exclusively for the treatment of pain with very great success. It s been an absolute godsend to my patients in pain." (Exhibit A, p. 1)

R. DR. MCELHANEY: "I've treated more than 250 patients with Therapy Plus. We've had a 95% success rate in relieving their pain, and this has occurred in minutes. I find Therapy Plus very successful in the treatment of all types of muscular-skeletal pain, including tendinitis, bursitis, sprains, strains, tight spastic muscles, and even arthritis." (Exhibit A, pp. 4-5)

S. BARKLEY: "Doctor, you've treated a lot of pain sufferers with Therapy Plus. Can you tell us what kind of results you've seen?"

DR. MCELHANEY: "I've treated over 250 patients. 95% have experienced relief within minutes. It's the greatest advance in the treatment of pain that I've seen in all of my medical years, and for my patients, it's a godsend."

BARKLEY: "How does this device work?"

DR. MCELHANEY: "At first we didn't know. But research was then done at a leading southern California University and a leading hospital research center. [Depiction: Woman under metal cap with electrodes inside apparatus in laboratory] The first study showed by objective criteria that the roller relaxes tense muscles and muscles in spasm. [Depiction: Medical monitoring device in process of collecting and recording data] It also improves circulation in the area where it is rolled. And it brings the sympathetic nerves to a high state of arousal. These effects are definitely physiology and not psychology. [Depiction: Woman under metal cap with electrodes inside apparatus in laboratory] The results of this study were presented at the Eighth Annual Scientific Meeting of the American Pain Society. The second study is now being reviewed and accepted for publication in a scientific journal." (Exhibit A, pp. 13-14)

T. BARKLEY: "So the medical community must be very excited about this."

DR. MCELHANEY: "Oh yes. Researchers, too -- pain researchers. We think that this is a major breakthrough in the treatment in pain." (Exhibit A, p. 14)

U. BARKLEY: "How does this compare with other muscular pain relievers?"

DR. MCELHANEY: "Compared to analgesics, liniments, physical therapy, or oral medications there's just no comparison. This works as effective or more effectively than any of those products." (Exhibit A, p. 14)

PAR. 5. Through the use of the statements and depictions contained in the advertisements and promotional materials referred to in paragraph four, including but not necessarily limited to the advertisement attached as Exhibit A, Numex Corporation, under the direction and control of respondent and others, has represented, directly or by implication, that:

A. Scientific proof, including research at a major university and a leading research hospital, demonstrates that Therapy Plus is effective in significantly reducing, relieving, or eliminating pain.

B. Therapy Plus is a major breakthrough in the treatment of pain.

C. A substantial number of medical doctors use Therapy Plus and recommend it as an effective way to significantly reduce, relieve, or eliminate pain.

D. The statements of James McElhaney, M.D., appearing in the infomercial "Freedom From Pain" were the endorsements of an individual who, at the time of providing his endorsements, was independent from the individuals and entities marketing the product.

E. The statements of Nolan Cromwell appearing in the infomercial "Freedom From Pain" were the endorsements of an individual who, at the time of providing his endorsements, was independent from the individuals and entities marketing the product.

PAR. 6. In truth and in fact:

A. Scientific proof does not demonstrate that Therapy Plus is effective in significantly reducing, relieving, or eliminating pain.

B. Therapy Plus is not a major breakthrough in the treatment of pain.

C. A substantial number of medical doctors neither use Therapy Plus nor recommend it as an effective way to significantly reduce, relieve, or eliminate pain.

D. The statements of James McElhaney, M.D., appearing in the advertisements were not the endorsements of an individual who, at the time of providing his endorsements, was independent from the individuals and entities marketing the product. At the time of providing his endorsements, James McElhaney, M.D., was an officer and director of Numex Corporation, was to receive payments from Numex Corporation for each unit of Therapy Plus sold, and owned stock in Delux Distributions International, Inc., a corporate share-holder of Numex Corporation.

E. The statements of Nolan Cromwell appearing in the advertisements were not the endorsements of an individual who, at the time of providing his endorsements, was independent from the individuals and entities marketing the product. At the time of providing his endorsements, Nolan Cromwell was Athletic Director of Numex Corporation, was to receive payments from Numex Corporation for each unit of Therapy Plus sold, and owned stock in Delux Distributions International, Inc., a corporate shareholder of Numex Corporation.

Therefore, the representations set forth in paragraph five were, and are, false and misleading.

PAR. 7. Through the use of the statements and depictions contained in the advertisements and promotional materials referred to in paragraph four, including but not necessarily limited to the advertisement attached as Exhibit A, Numex Corporation, under the direction and control of respondent and others, has represented, directly or by implication, that:

A. Use of Therapy Plus will significantly reduce, relieve, or eliminate virtually all types of musculoskeletal pain, including acute pain, chronic pain, sprains, strains, tight spastic muscles, and the pain of arthritis, bursitis, and tendinitis.

B. Use of Therapy Plus will relieve headaches.

C. Therapy Plus can be safely used to relieve painful swelling in the legs.

#### Complaint

D. Use of Therapy Plus will reduce, relieve, or eliminate swelling, gnarling, or deformities of the joints caused by rheumatoid arthritis.

E. Use of Therapy Plus will significantly reduce, relieve, or eliminate pain in minutes, even in individuals who have suffered from chronic pain for years.

F. For a substantial majority of people, Therapy Plus is effective in significantly reducing, relieving, or eliminating pain.

G. For the treatment of pain, Therapy Plus is as effective as, or more effective than, analgesics, liniments, physical therapy, or oral medications.

H. Therapy Plus is an effective substitute for surgery in relieving the pain of arthritic knees.

I. Therapy Plus will significantly reduce, relieve, or eliminate arthritis and other pain without the need for medication, including prescription medication.

J. For the treatment of pain, use of Therapy Plus will eliminate the need for treatment by a doctor.

PAR. 8. Through the use of the statements and depictions contained in the advertisements and promotional materials referred to in paragraph four, including but not necessarily limited to the advertisement attached as Exhibit A, Numex Corporation, under the direction and control of respondent and others, has represented, directly or by implication, that at the time it made the representations set forth in paragraphs five and seven, it possessed and relied upon a reasonable basis that substantiated such representations.

PAR. 9. In truth and in fact, at the time Numex Corporation made the representations set forth in paragraphs five and seven, it did not possess and rely upon a reasonable basis that substantiated such representations. Therefore, the representation set forth in paragraph eight was, and is, false and misleading.

PAR. 10. Through the advertising and dissemination of the infomercial "Freedom From Pain," a transcription of which is attached hereto as Exhibit A, Numex Corporation, under the direction and control of respondent and others, has represented, directly

or by implication, that the testimonials or endorsements from consumers appearing in advertisements for Therapy Plus reflect the typical or ordinary experience of members of the public who use Therapy Plus.

PAR. 11. Through the advertising and dissemination of the infomercial "Freedom From Pain," a transcription of which is attached hereto as Exhibit A, Numex Corporation, under the direction and control of respondent and others, has represented, directly or by implication, that, at the time it made the representation set forth in paragraph ten, it possessed and relied upon a reasonable basis that substantiated such representation.

PAR. 12. In truth and in fact, at the time Numex Corporation made the representation set forth in paragraph ten, it did not possess and rely upon a reasonable basis that substantiated such representation. Therefore, the representation set forth in paragraph eleven, was, and is, false and misleading.

PAR. 13. In the advertising and sale of Therapy Plus, Numex Corporation, under the direction and control of respondent and others, has represented that James McElhaney, M.D., and Nolan Cromwell are endorsers of Therapy Plus. Numex Corporation has failed to disclose adequately that McElhaney and Cromwell each has a material connection with Therapy Plus in that, at the time of providing their endorsements, Mc Elhaney and Cromwell owned stock in Delux Distributions International, Inc., a corporate shareholder of Numex Corporation; Mc Elhaney and Cromwell were to receive payments for each unit of Therapy Plus sold; McElhaney was an officer and director of Numex Corporation; and Cromwell was Athletic Director of Numex Corporation. These facts would materially affect the weight and credibility given by consumers to the endorsements and would be material to consumers in their decisions to purchase the product. Therefore, the failure to disclose adequately these facts, in light of the representations made, was, and is, a deceptive practice.

The Federal Trade Commission having initiated an investigation of certain acts and practices of the respondent named in the caption hereof, and the respondent having been furnished thereafter with a copy of a draft complaint which the Bureau of Consumer Protection proposed to present to the Commission for its consideration and which, if issued by the Commission, would charge respondent with violations of the Federal Trade Commission Act; and

The respondent and counsel for the Commission having thereafter executed an agreement containing a consent order, an admission by respondent of all the jurisdictional facts set forth in the aforesaid draft of complaint, a statement that the signing of said agreement is for settlement purposes only and does not constitute an admission by respondent that the law has been violated as alleged in such complaint, and waivers and other provisions as required by the Commission's rules; and

It is further ordered, That respondent Gisela E. Flick, individually and as a former director and officer of Numex Corporation, and respondent's agents, representatives and employees, directly or through any corporation, subsidiary, division or other device, in connection with the manufacturing, labeling, advertising, promotion, offering for sale, sale, or distribution of any device, as "device" is defined in Section 15 of the Federal Trade Commission Act, in or affecting commerce, as "commerce" is defined in the Federal Trade Commission Act, do forthwith cease and desist from representing, in any manner, directly or by implication:

This consent order prohibits, among other things, the former Vice President and Medical Director of Numex, a California-based corporation that advertised and promoted "Therapy Plus," from misrepresenting: the efficacy of certain devices; the degree to which scientific proof demonstrates that any such device is effective in reducing, relieving, or eliminating pain; the degree to which such a device is a significant medical breakthrough; or the degree to which the device is used, recommended, or accepted by the relevant medical or scientific community as effective in reducing, relieving or eliminating pain. This consent order also requires the respondent, when making certain claims as an expert endorser, to possess competent and reliable scientific evidence to substantiate those claims.

## COMPLAINT

The Federal Trade Commission, having reason to believe that James L. McElhaney, M.D., individually and as a former director and officer of Numex Corporation, hereinafter sometimes referred to as respondent, has violated the provisions of the Federal Trade Commission Act, and it appearing to the Commission that a proceeding by it in respect thereof would be in the public interest, alleges:

PARAGRAPH 1. Respondent James L. McElhaney, M.D., is or was at relevant times an officer and director of Numex Corporation, and a shareholder in Delux Distributions International, Inc., a corporate shareholder of Numex Corporation. At all times relevant hereto, respondent, individually or in concert with others, participated in the formulation, direction and control of the acts and practices of Numex Corporation, including the acts and practices alleged in this complaint. Respondent resides at 6701 Lawn Haven Drive, Huntington Beach, California.

PAR. 2. Numex Corporation, under the direction and control of respondent and others, has manufactured, advertised, labeled, offered for sale, sold, and distributed a device, Therapy Plus, to the public. Therapy Plus is a hand-held, mechanical roller purported to be a pain-relieving device. This product is a "device" within the meaning of Sections 12 and 15 of the Federal Trade Commission Act.

PAR. 3. The acts and practices of respondent alleged in this complaint have been in or affecting commerce, as "commerce" is defined in Section 4 of the Federal Trade Commission Act.

PAR. 4. Numex Corporation, under the direction and control of respondent and others, has disseminated or has caused to be disseminated advertisements and promotional materials for Therapy Plus, including but not necessarily limited to the attached Exhibit A, a transcription of the program-length television commercial or "infomercial" entitled "Freedom From Pain." The aforesaid advertisement contains the following statements and depictions:

A. THELMA NORA (Consumer Endorser): "My headaches are gone, my neck, the stiffness of my neck; I can move my neck and shoulders and everything. I feel great." (Exhibit A, p. 1)

B. ROGER BARKLEY (Announcer): "It's called Therapy Plus, the pain reliever, and its effectiveness is backed by scientific proof and documented clinical use. You'll meet some of the people who have used it: the professional sports star, the weekend warrior, and the incredible testimony of pain sufferers; how it relieves acute pains, chronic pains, the pain of arthritis, bursitis, tendinitis, and many other muscle-related pains. You will hear from doctors who have treated hundreds of patients with positive results, and you'll see the scientific proof that

Therapy Plus really works." [Depiction: Therapy Plus being rolled on man in glass enclosure in laboratory] (Exhibit A, p. 3)

C. BARKLEY: "I know it's hard to believe, but this little device that can literally roll away pain. Stephanie Osnower knows. In addition to arthritic hands, she had terrible pain in her leg from standing too much."

STEPHANIE OSNOWER (Consumer Endorser): "And I suddenly had a swelling in this area behind my knee and it got larger and larger and larger."

BARKLEY: "Stephanie visited her doctor who rolled her leg with this therapeutic device back and forth for several minutes. She said that the pain went away."

OSNOWER: "And he said, 'Tell me when you feel better,' and it was almost immediate, almost immediate that I began to feel better and had some relief." (Exhibit A, p. 4)

D. MARGARET TANNEHILL (Consumer Endorser): "I've had rheumatoid arthritis for five years. And the past year it had gotten worse, to the point where I thought of giving up golf and also knitting, and those are my two favorites. So I thought, well, I'll borrow a roller from a friend for one week and see if it would work, because I've heard so much about it. So I borrowed the roller, and the first night I thought, my God, it worked, because I slept all night. . . . So I used it for one week and went and purchased one. And since then, I hadn't worn my rings for one year, and I do wear them. And my knuckles were gnarled; you can still see probably a little, but you have no idea how pretty these hands look to me. And I do this watching television. Sometimes it runs seven minutes but five minutes is what I give myself on each hand. That's all I do, and I do it religiously every night and I love it." (Exhibit A, pp. 6-7)

E. BARKLEY: "Maurice Lindsay, a physicist and engineer, was told by bone surgeons that he would have to have operations on both knees in order to relieve his pain."

MAURICE LINDSAY (Consumer Endorser): "Well, I came in and said, 'Jim, I can't take it anymore. My knees are so bad that they hurt constantly, and I'd like to have you make arrangements to have them operated on -- they're just too painful.' So, he kind of chuckled and got the roller out and -- I'd never seen one, of course, before -- and he had me sit there while he rolled the knee. And it was hurting; it was hurting, that's why I came in. And I was hurting whether I was sitting, standing, walking, or whatever, and running was out of the question. And so he rolled it rather vigorously, oh, maybe three or four minutes, and said, 'Now get up and walk towards the door,' which I did, and he said, 'Do you feel anything?,' and I said, 'No, my knee does not hurt.' So, it was an immediate sale, no questions asked! I had to have one." [Superimposed Text: "Arthritic Knee Pain Relieved with Therapy Plus"] (Exhibit A, pp. 7-8)

F. GEORGE STEVENS (Consumer Endorser): "I rolled my elbow, and I was going to get a shot that day -- cortisone shot -- and I rolled it, about five

G. VOICE-OVER: "Imagine what it would feel like to have your pain disappear. Therapy Plus is the breakthrough pain-relieving device that is completely safe and easy to use. It is recommended by medical doctors, chiropractors, and other health experts." [Depiction: Dr. Randolph Stern using Therapy Plus to point to anatomical charts of human body] (Exhibit A, pp. 10 and 18)

H. VOICE-OVER: "Its design is unique, and reports from scientists at a major university and research hospital have proven that is does work. [Depiction: Therapy Plus being rolled on man in glass enclosure in laboratory.] Its effectiveness has even been presented at the American Pain Society. Patients who have been suffering with chronic pain for years, now relieve pain in minutes, with no effort, no exercise, and no drugs." (Exhibit A, pp. 10-11 and 18-19)

I. VOICE-OVER: "Just roll it gently but rapidly over the area where pain exists, such as arthritic hands, tight shoulder, sore knees, elbows, or the lower back, even muscles stressed during recreation. It works almost anywhere. Most people report their pain disappearing in just minutes." (Exhibit A, pp. 11 and 19-20)

J. BARKLEY: "Can there be anybody else who knows as much about pain as an NFL football player? Nolan Cromwell spent eleven years with the Los Angeles Rams, and is a four-time all-pro safety."

NOLAN CROMWELL: "The first time I saw the roller, I thought it was a joke. You know, here they're going to take something that you just roll lightly on the skin, and reduce the pain anywhere on your body. But after using it for the first time and finding out that it does work and the simplicity that is there -- it goes in your pocket; you carry it wherever you want to go -- and it works. I was totally surprised that it did relieve the pains actually in all parts of my body." [Superimposed Text: "Therapy Plus replaced expensive physiotherapy treatments"] (Exhibit A, pp. 15-16)

such representations. Therefore, the representation set forth in paragraph eight was, and is, false and misleading.

PAR. 10. Through the advertising and dissemination of the infomercial "Freedom From Pain," a transcription of which is attached hereto as Exhibit A, Numex Corporation, under the direction and control of respondent and others, has represented, directly or by implication, that the testimonials or endorsements from consumers appearing in advertisements for Therapy Plus reflect the typical or ordinary experience of members of the public who use Therapy Plus.

PAR. 11. Through the advertising and dissemination of the infomercial "Freedom From Pain," a transcription of which is attached hereto as Exhibit A, Numex Corporation, under the direction and control of respondent and others, has represented, directly or by implication, that, at the time it made the representation set forth in paragraph ten, it possessed and relied upon a reasonable basis that substantiated such representation.

PAR. 12. In truth and in fact, at the time Numex Corporation made the representation set forth in paragraph ten, it did not possess and rely upon a reasonable basis that substantiated such representation. Therefore, the representation set forth in paragraph eleven, was, and is, false and misleading.

PAR. 13. In its advertising and sale of Therapy Plus, Numex Corporation, under the direction and control of respondent and others, has represented that James McElhaney, M.D., and Nolan Cromwell are endorsers of Therapy Plus. ## DECISION AND ORDER

The Federal Trade Commission having initiated an investigation of certain acts and practices of the respondent named in the caption hereof, and the respondent having been furnished thereafter with a copy of a draft complaint which the Bureau of Consumer Protection proposed to present to the Commission for its consideration and which, if issued by the Commission, would charge respondent with violations of the Federal Trade Commission Act; and

The respondent and counsel for the Commission having thereafter executed an agreement containing a consent order, an admission by respondent of all the jurisdictional facts set forth in the aforesaid draft of complaint, a statement that the signing of said agreement is for settlement purposes only and does not constitute an admission by respondent that the law has been violated as alleged in such complaint, and waivers and other provisions as required by the Commission's rules; and

The Commission having thereafter considered the matter and having determined that it had reason to believe that the respondent has violated the said Act, and that complaint should issue stating its charges in that respect, and having thereupon accepted the executed consent agreement and placed such agreement on the public record for a period of sixty (60) days, and having duly considered the comment filed thereafter by an interested party pursuant to Section 2.34 of its Rules, now in further conformity with the procedure prescribed in Section 2.34 of its Rules, the Commission hereby issues its complaint, makes the following jurisdictional findings and enters the following order:

1. Respondent James L. McElhaney, M.D., is a former officer and director of Numex Corporation. Individually or in concert with others, respondent participated in the formulation, direction and control of the policies, acts and practices of said corporation, and he resides at 6701 Lawn Haven Drive, Huntington Beach, California.

2. The Federal Trade Commission has jurisdiction of the subject matter of this proceeding and of the respondent, and the proceeding is in the public interest.

McElhaney, M.D., individually and as a former director and officer of Numex Corporation, and respondent's agents, representatives and employees, directly or through any corporation, subsidiary, division or other device, in connection with the manufacturing, labeling, advertising, promotion, offering for sale, sale, or distribution of any product or service for personal or household use, in or affecting commerce, as "commerce" is defined in the Federal Trade Commission Act, do forthwith cease and desist from failing to disclose, clearly and prominently, a material connection, where one exists, between an endorser of any such product or service and the respondent or any other individual or entity manufacturing, advertising, promoting, offering for sale, selling, or distributing such product or service. For purposes of this order, a "material connection" shall mean any relationship that might materially affect the weight or credibility of the endorsement and would not reasonably be expected by consumers.

## VII.

It is further ordered, That, for five (5) years after the last date of dissemination of any representation covered by this order, respondent James L. McElhaney, M.D., or his successors and assigns, shall maintain and upon request make available to the Federal Trade Commission for inspection and copying:

A. All materials that were relied upon in disseminating such representation; and

B. All tests, reports, studies, surveys, demonstrations or other evidence in his possession or control that contradict, qualify, or call into question such representation, or the basis relied upon for such representation, including complaints from consumers.

## VIII.

It is further ordered, That respondent James L. McElhaney, M.D., shall, for a period of five (5) years from the date of entry of

## COMPLAINT

The Federal Trade Commission, having reason to believe that The Texwipe Company, a corporation, hereinafter sometimes referred to as respondent, has violated the provisions of the Federal Trade Commission Act, and it appearing to the Commission that a proceeding by it in respect thereof would be in the public interest, alleges:

PARAGRAPH 1. The Texwipe Company is a New Jersey corporation, with its principal office or place of business at 650 East Crescent Avenue, Upper Saddle River, New Jersey.

PAR. 2. Respondent has advertised, labeled, offered for sale, sold, and distributed computer and office equipment care and maintenance products containing the hydrochlorofluorocarbon ("HCFC") known as chlorodifluoromethane ("HCFC-22") to the public, includ-

ing aerosol cleaning products known as "Micro-Duster," "PC Duster," and "OfficeDuster II" ("respondent's products").

PAR. 3. The acts and practices of respondent alleged in this complaint have been in or affecting commerce, as "commerce" is defined in Section 4 of the Federal Trade Commission Act, 15 U.S.C. 44.

PAR. 4. Respondent has disseminated or has caused to be disseminated advertisements, including product labeling for respondent's products, including but not necessarily limited to, the attached Exhibit A.

The product labeling on the can of Micro Duster (Exhibit A) includes the following statement:

### "Ozone safe."

PAR. 5. Through the statement referred to in paragraph four in product labeling (Exhibit A), respondent has represented, directly or by implication, that there are no ingredients in respondent's products that deplete the earth's ozone layer.

PAR 6. Respondent has disseminated or has caused to be disseminated advertisements, including product labeling, for respondent's products, including but not necessarily limited to, the attached Exhibits A, B, and C.

The product labeling on the cans of Micro Duster (Exhibit A), PC Duster (Exhibit B), and Office Duster II (Exhibit C) include the following statement:

### "Environmentally safe."

PAR. 7. Through the use of the statement referred to in paragraph six in product labeling (Exhibits A, B, and C), respondent has represented, directly or by implication, that there are no ingredients in respondent's products that harm or damage the environment.

PAR. 8. In truth and in fact, respondent's products contain the ozone-depleting chemical HCFC-22, which harms or damages the environment by contributing to the depletion of the earth's ozone

layer. Therefore, the representations set forth in paragraphs five and seven were, and are, false and misleading.

PAR. 9. Through the statements contained in paragraphs four and six, including but not limited to product labeling attached as Exhibits A, B, and C, respondent has represented, directly or by implication, that at the time it made the representations set forth in paragraphs five and seven, respondent possessed and relied upon a reasonable basis that substantiated such representations.

PAR. 10. In truth and in fact, at the time it made the representations set forth in paragraphs five and seven, the respondent did not possess and rely upon a reasonable basis that substantiated such representations. Therefore, the representation set forth in paragraph nine was, and is, false and misleading.

PAR. 11. The acts and practices of respondent as alleged in this complaint constitute unfair or deceptive acts or practices in or affecting commerce in violation of Section 5(a) of the Federal Trade Commission Act, 15 U.S.C. 45(a).

It is ordered, That respondent, The Texwipe Company, a corporation, its successors and assigns, and its officers, agents, representatives and employees, directly or through any corporation, subsidiary, division, or other device, in connection with the advertising, labeling, offering for sale, sale, or distribution of any product, in or affecting commerce, as "commerce" is defined in the Federal Trade Commission Act, do forthwith cease and desist from representing that any such product containing any Class I or Class II ozonedepleting substance is "ozone safe," "environmentally safe," or, by words, depictions, or symbols representing directly or by implication, that any such product will not deplete, destroy, or otherwise adversely affect ozone in the upper atmosphere.

## II.

A. All materials that the respondent relied upon in disseminating any representation covered by this order.

B. All tests, reports, studies or surveys, analyses, or other materials in the possession or control of the respondent that contradict, qualify, or call into question any representation covered by this order or the basis on which the respondent relied for such representation.
