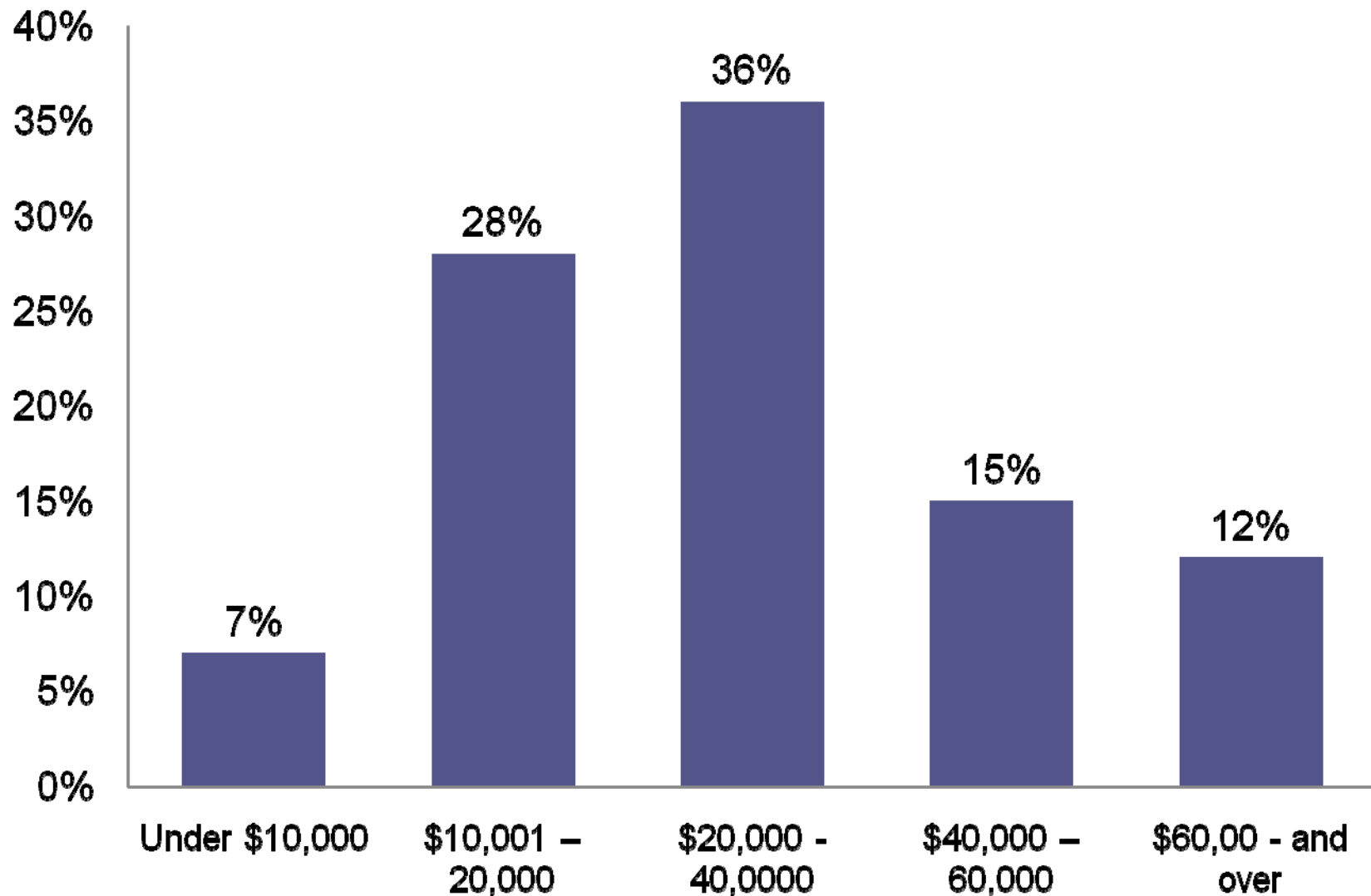

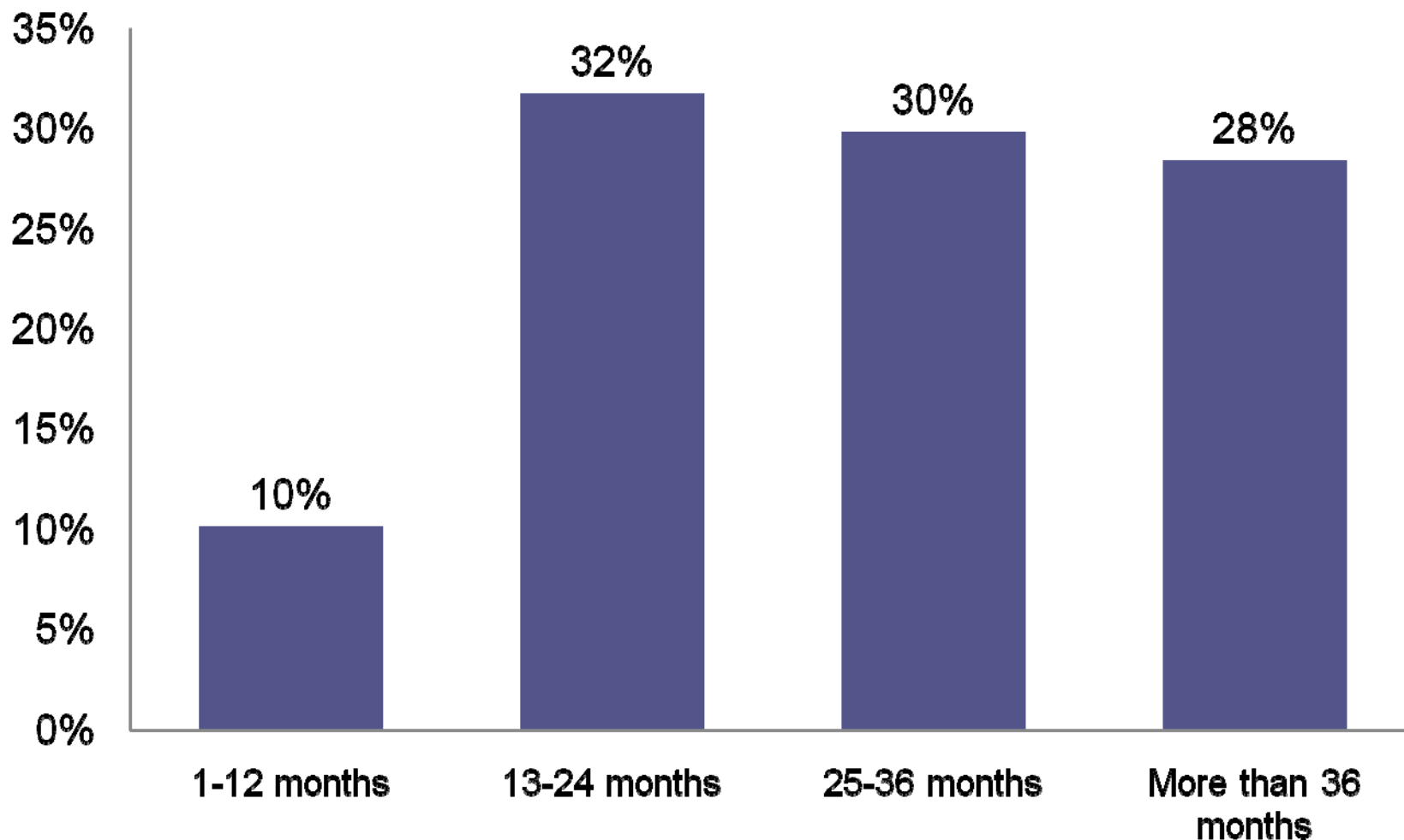

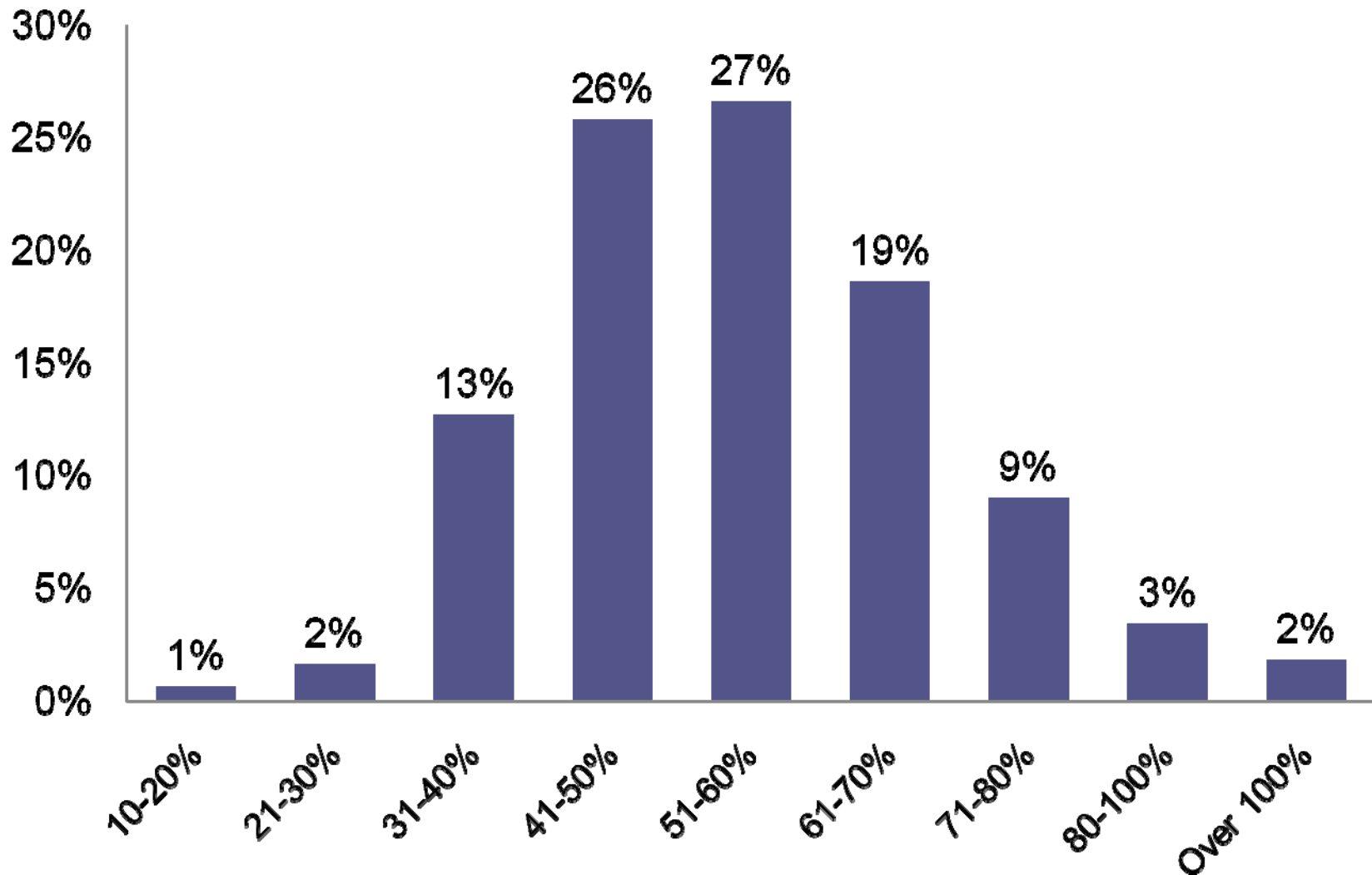

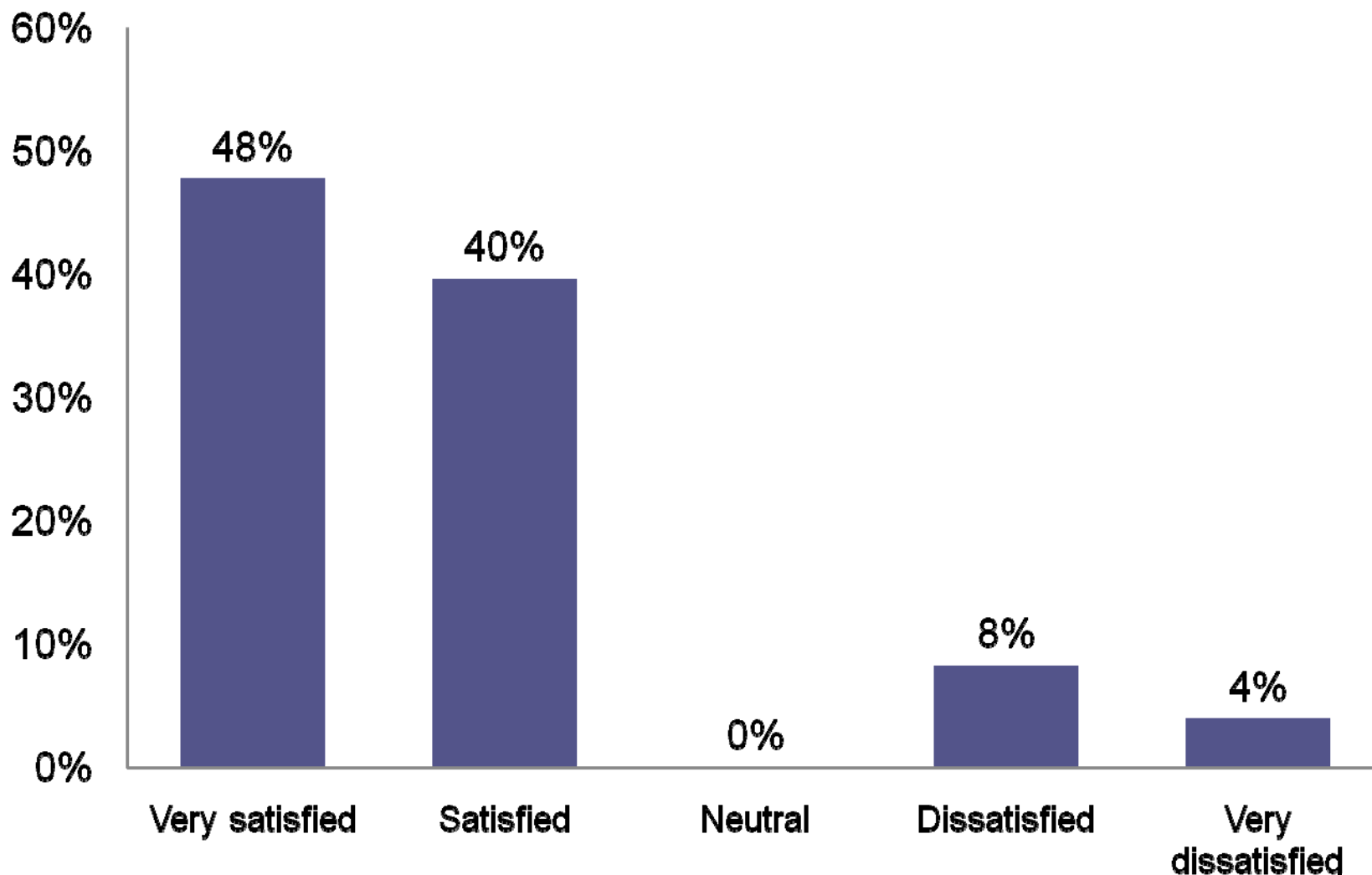

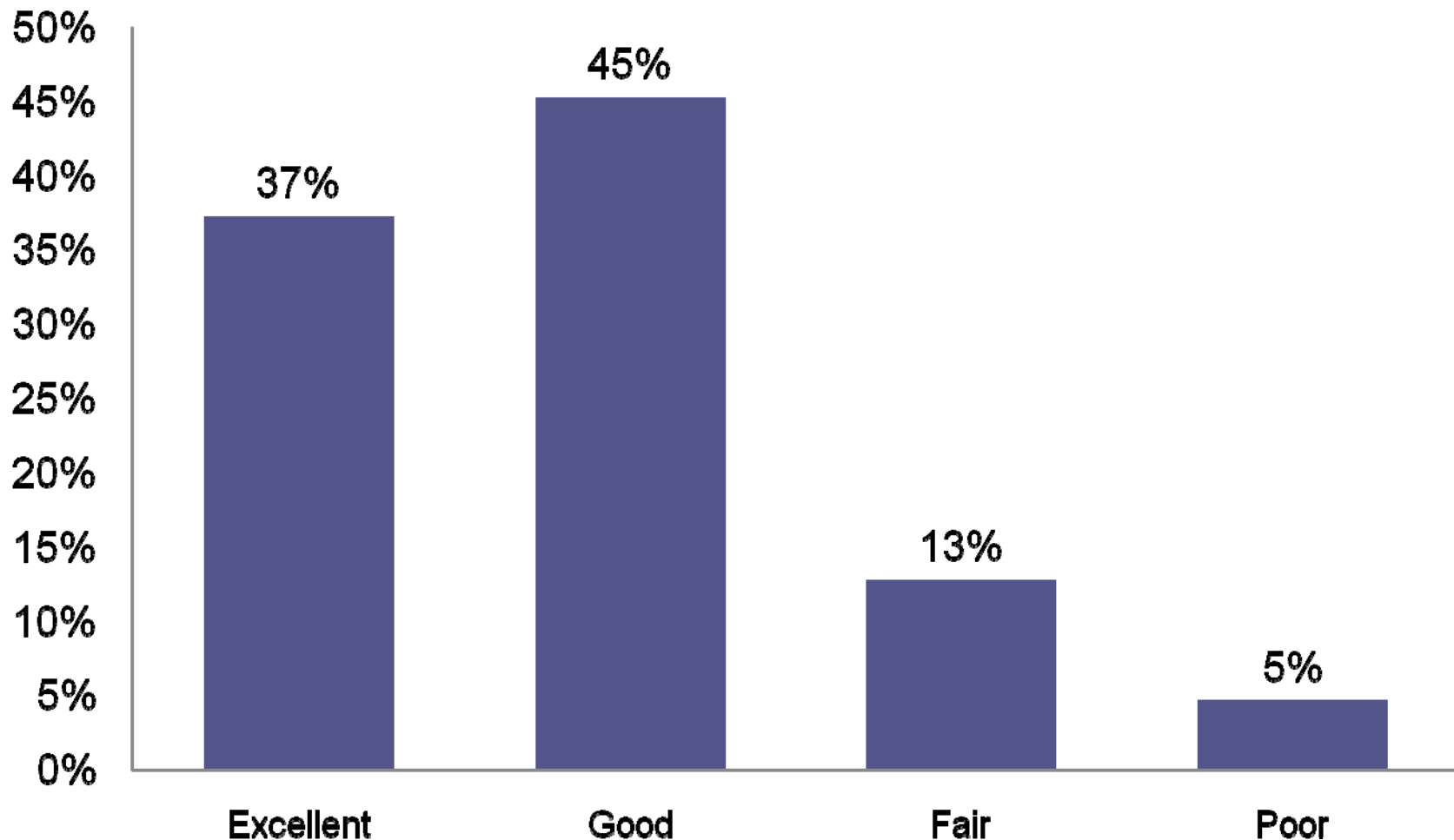

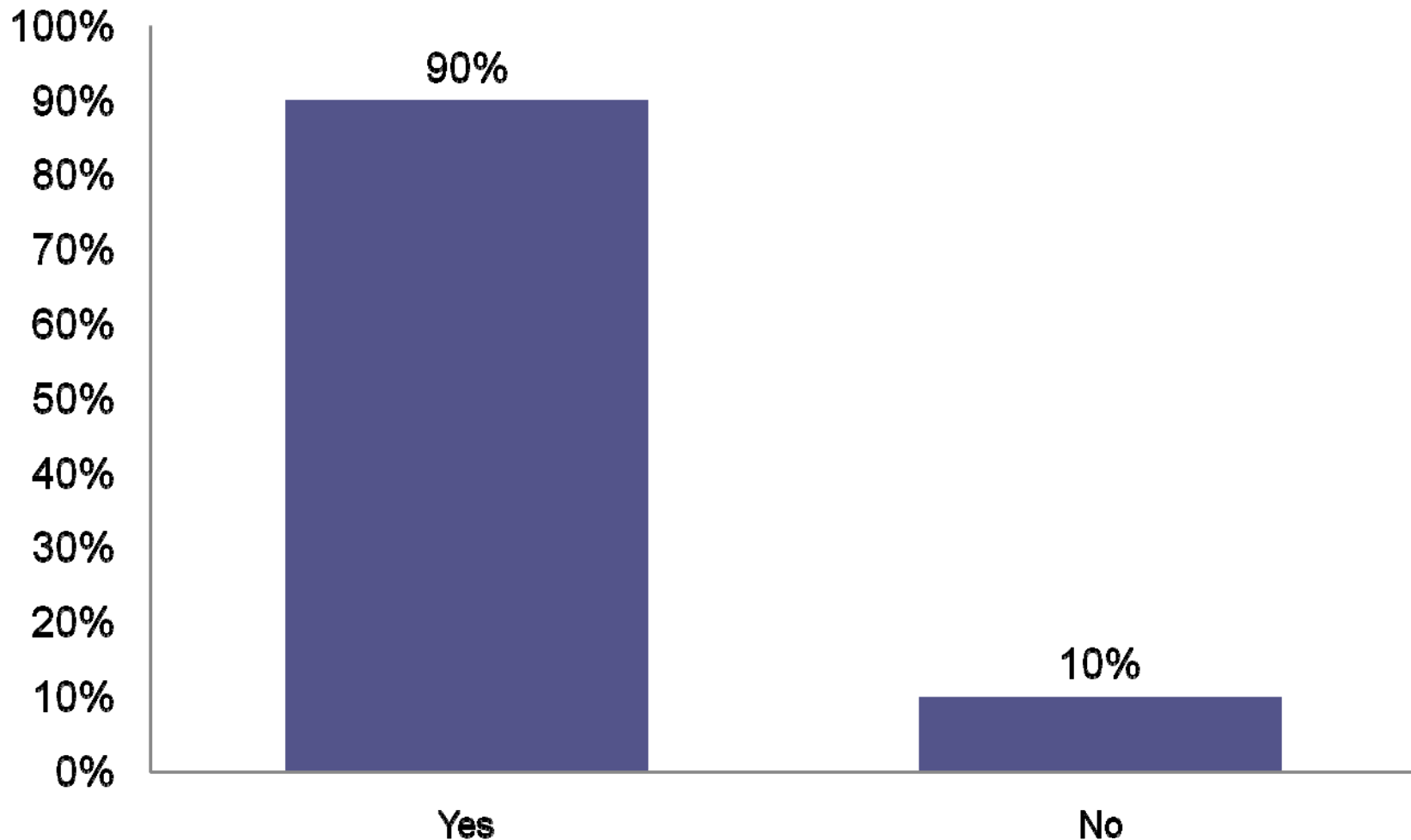

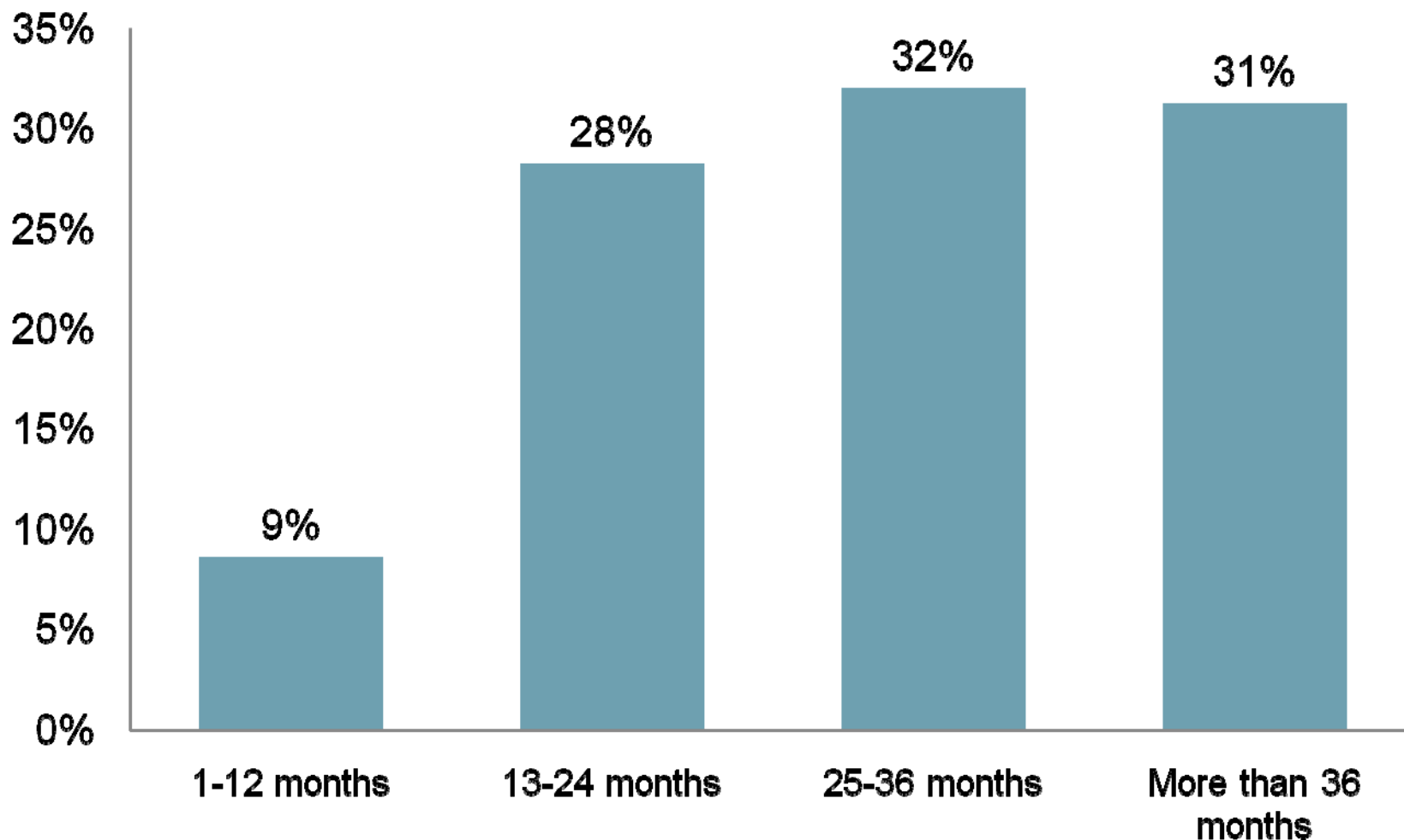

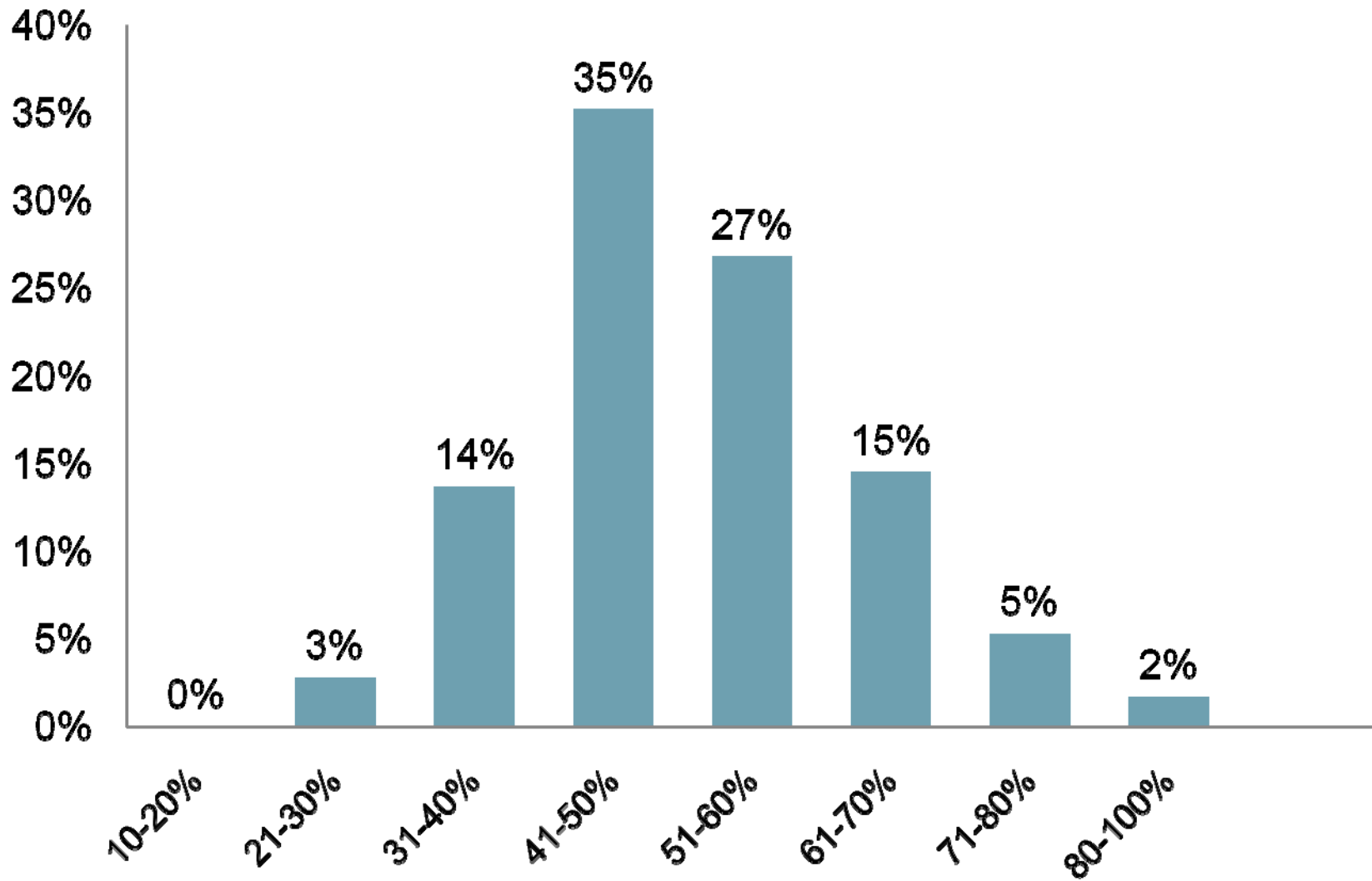

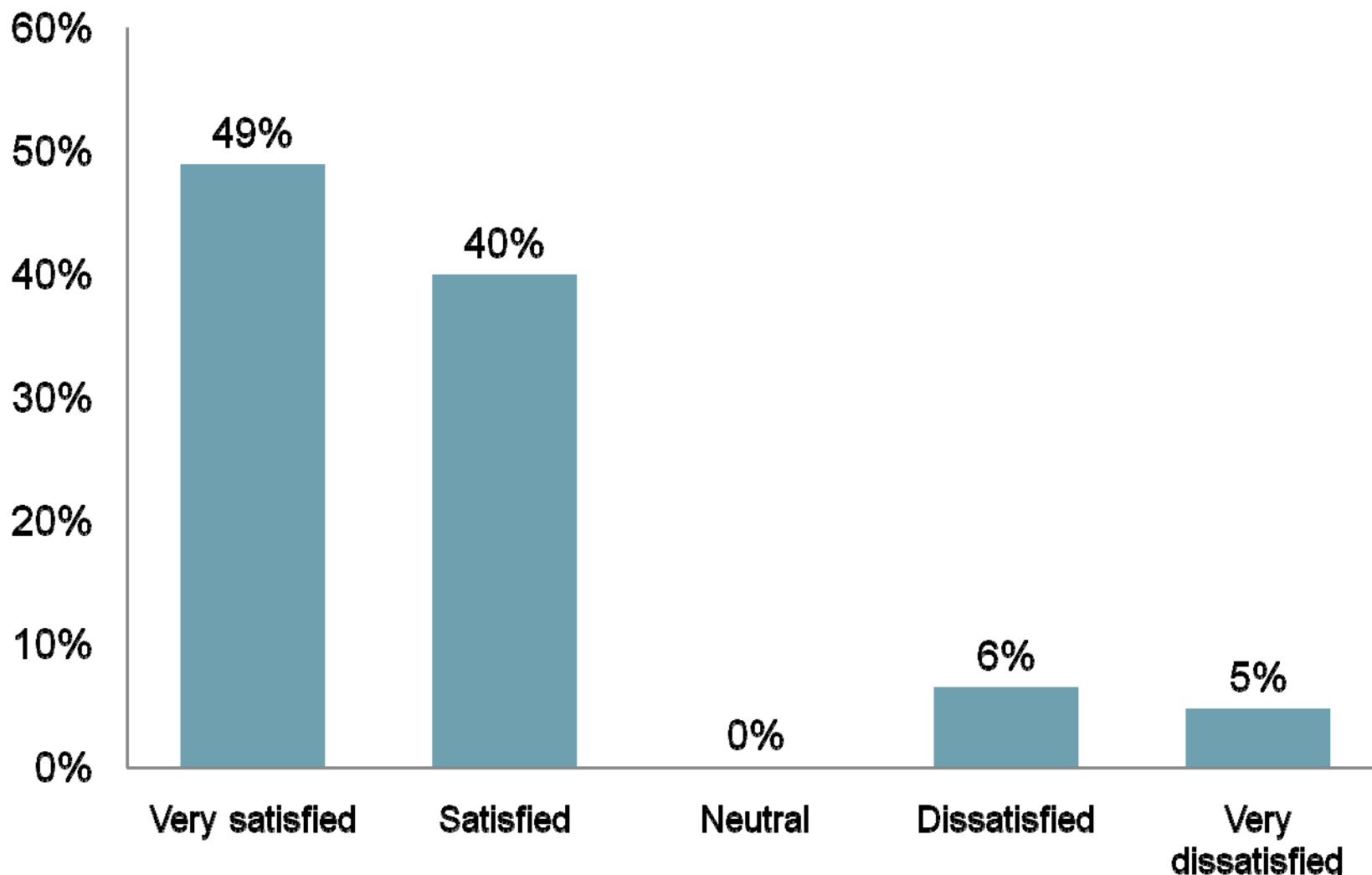

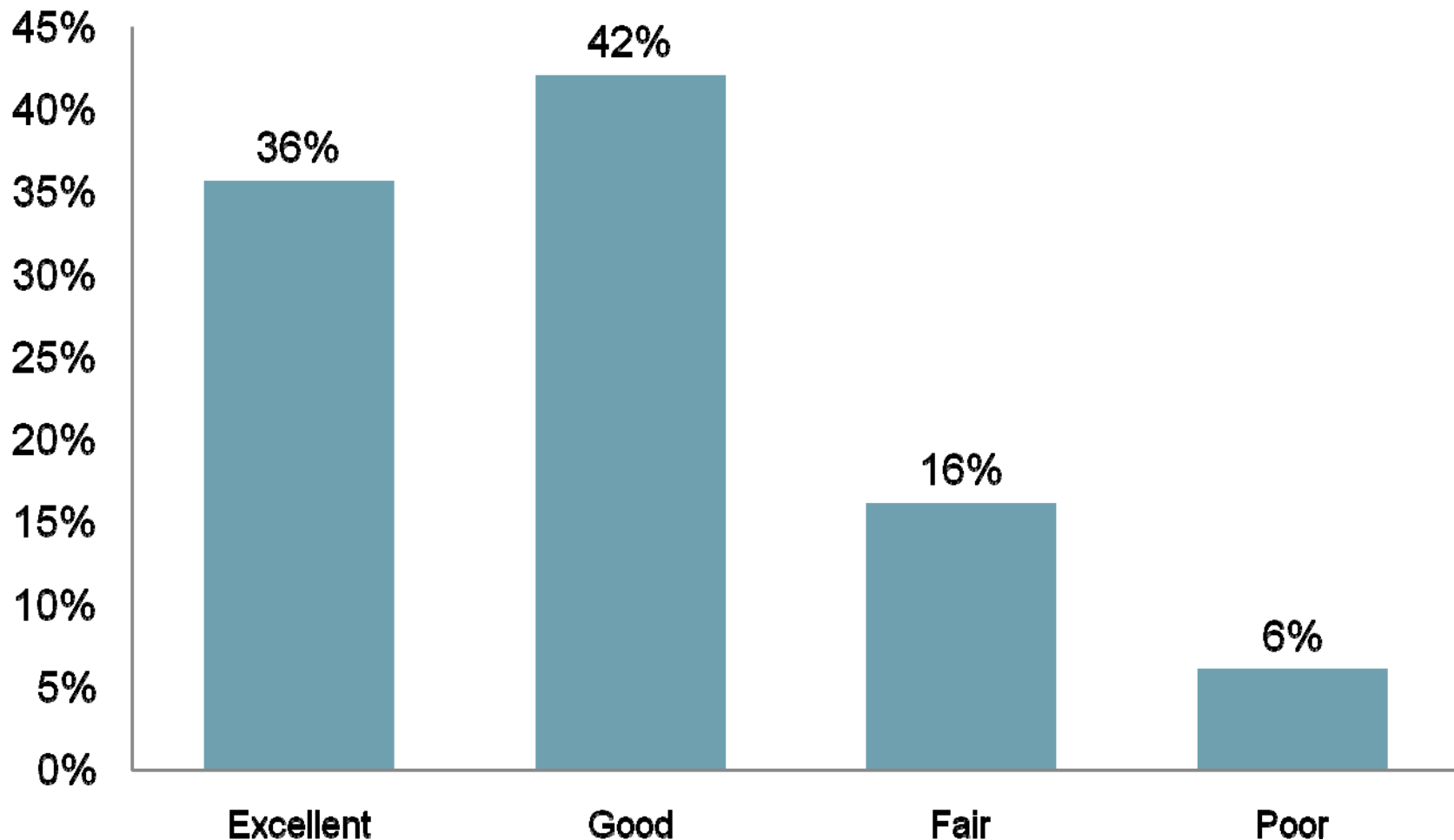

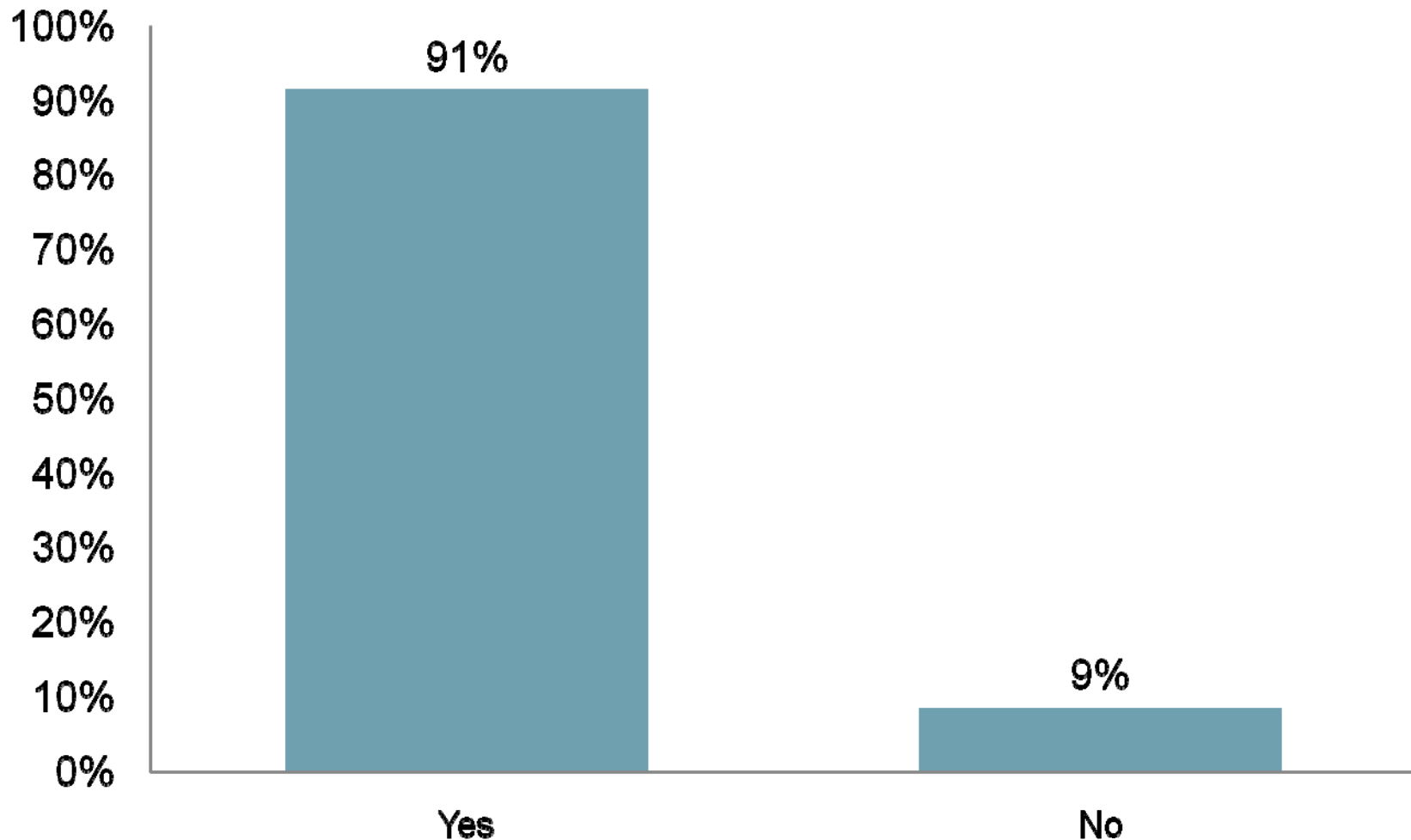

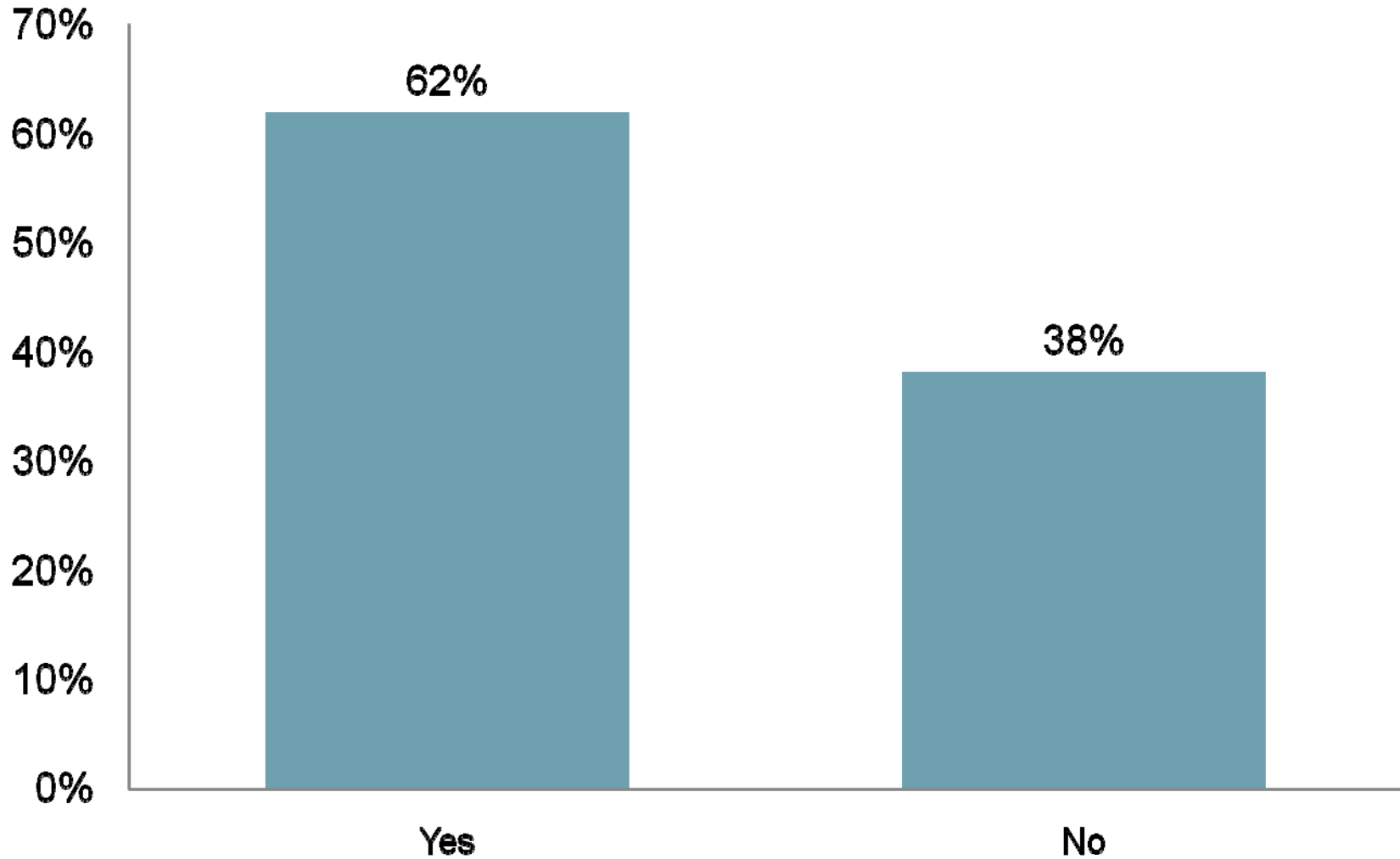

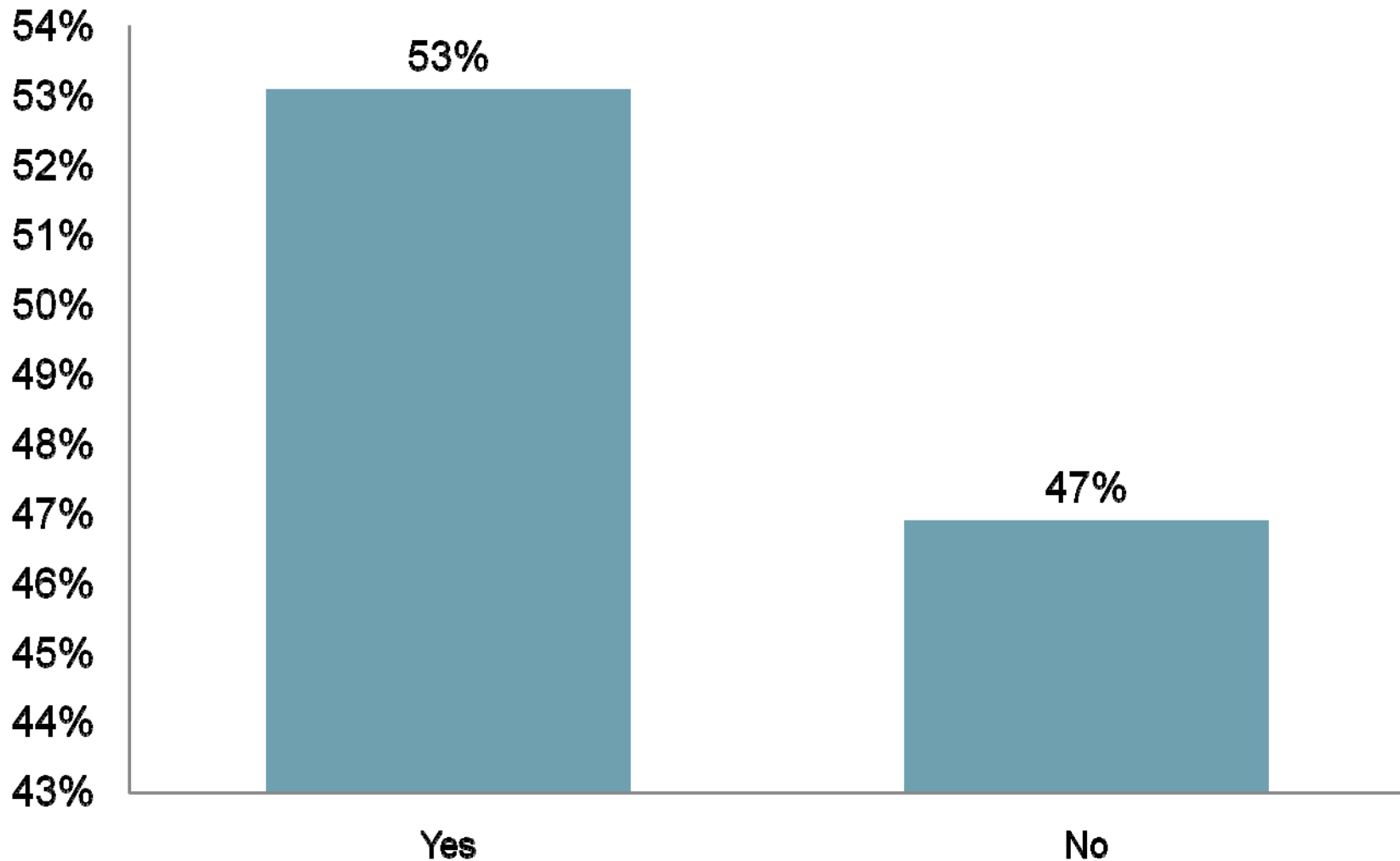
2. If you have run your credit report, what was your FICO score?



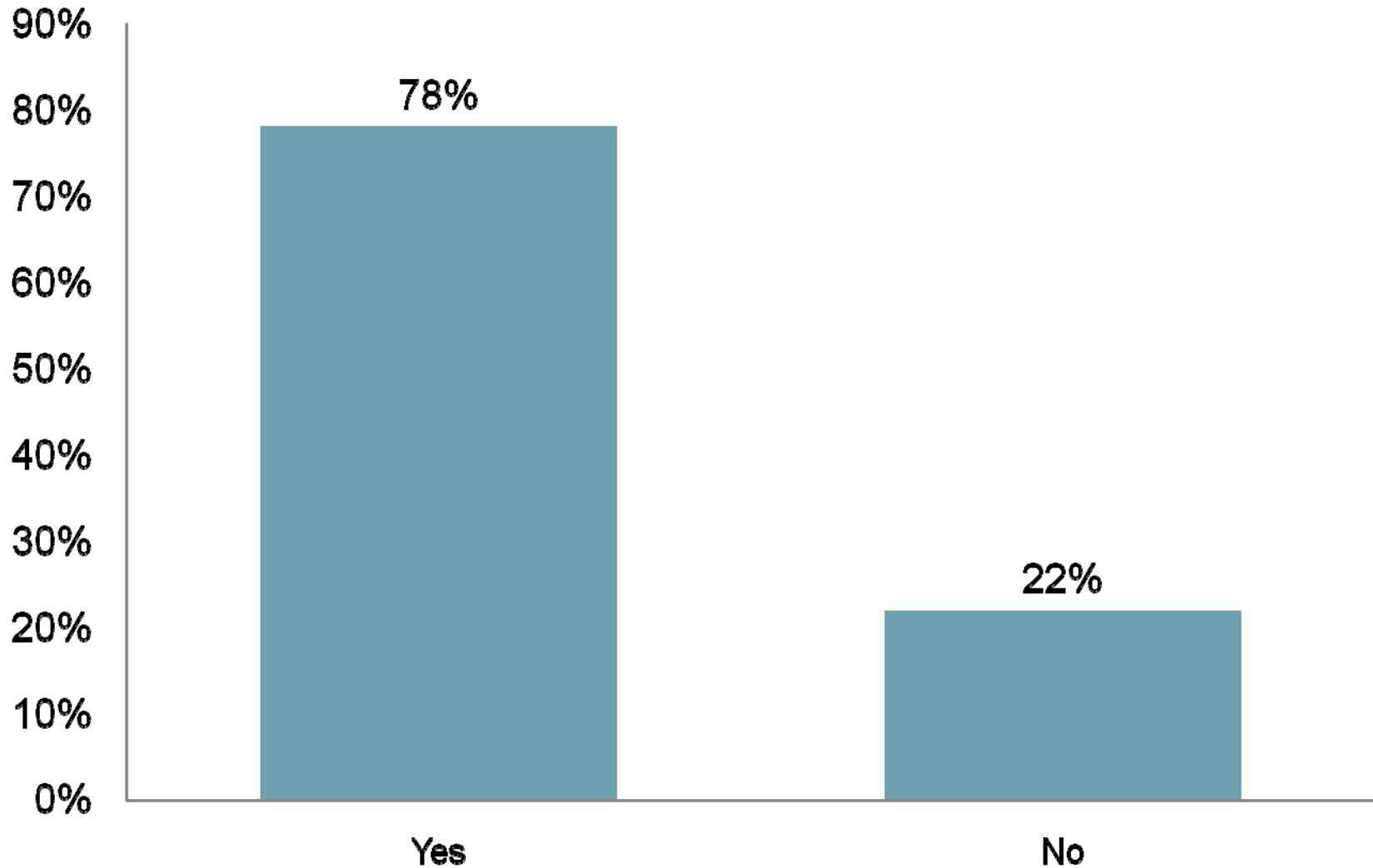

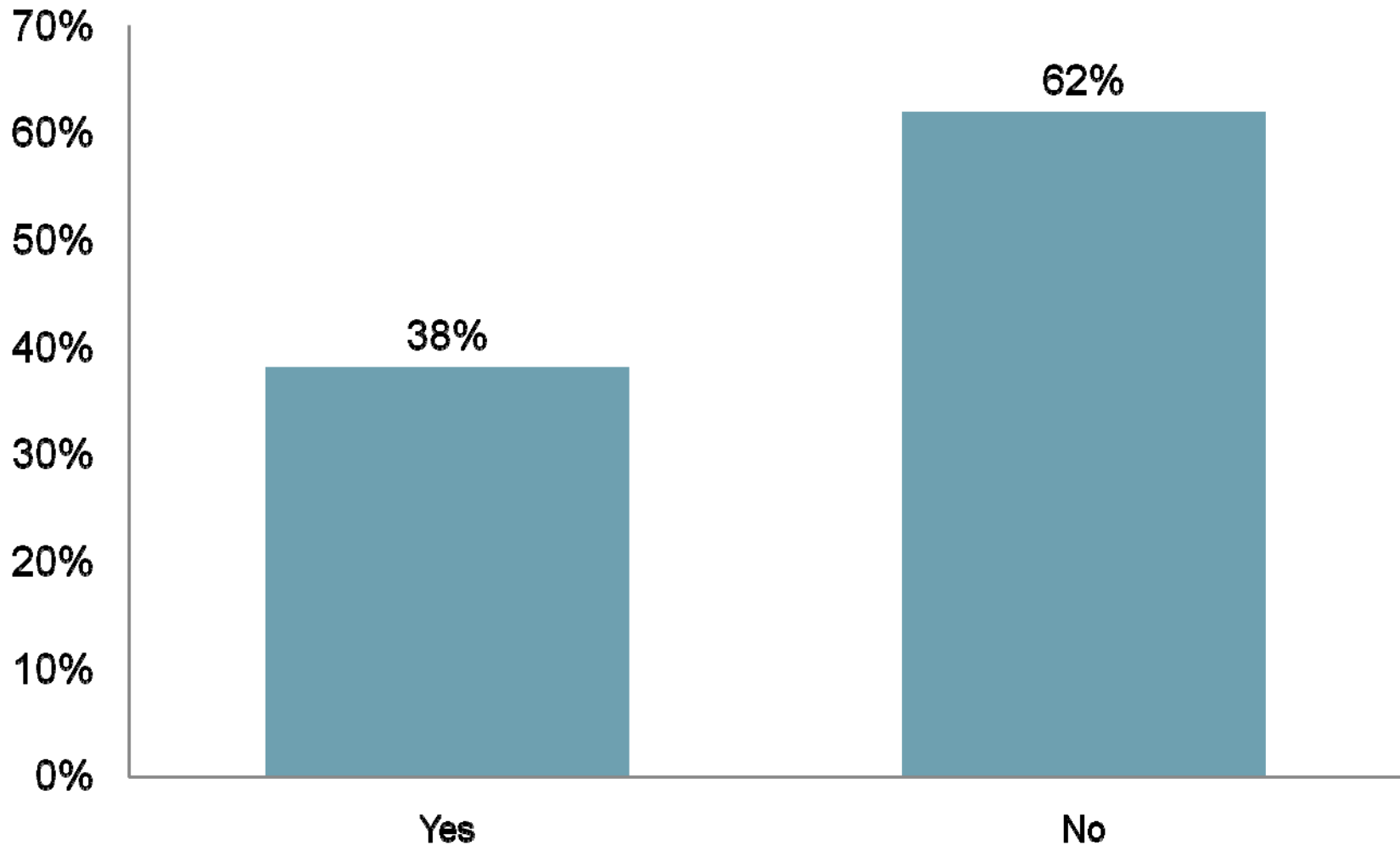

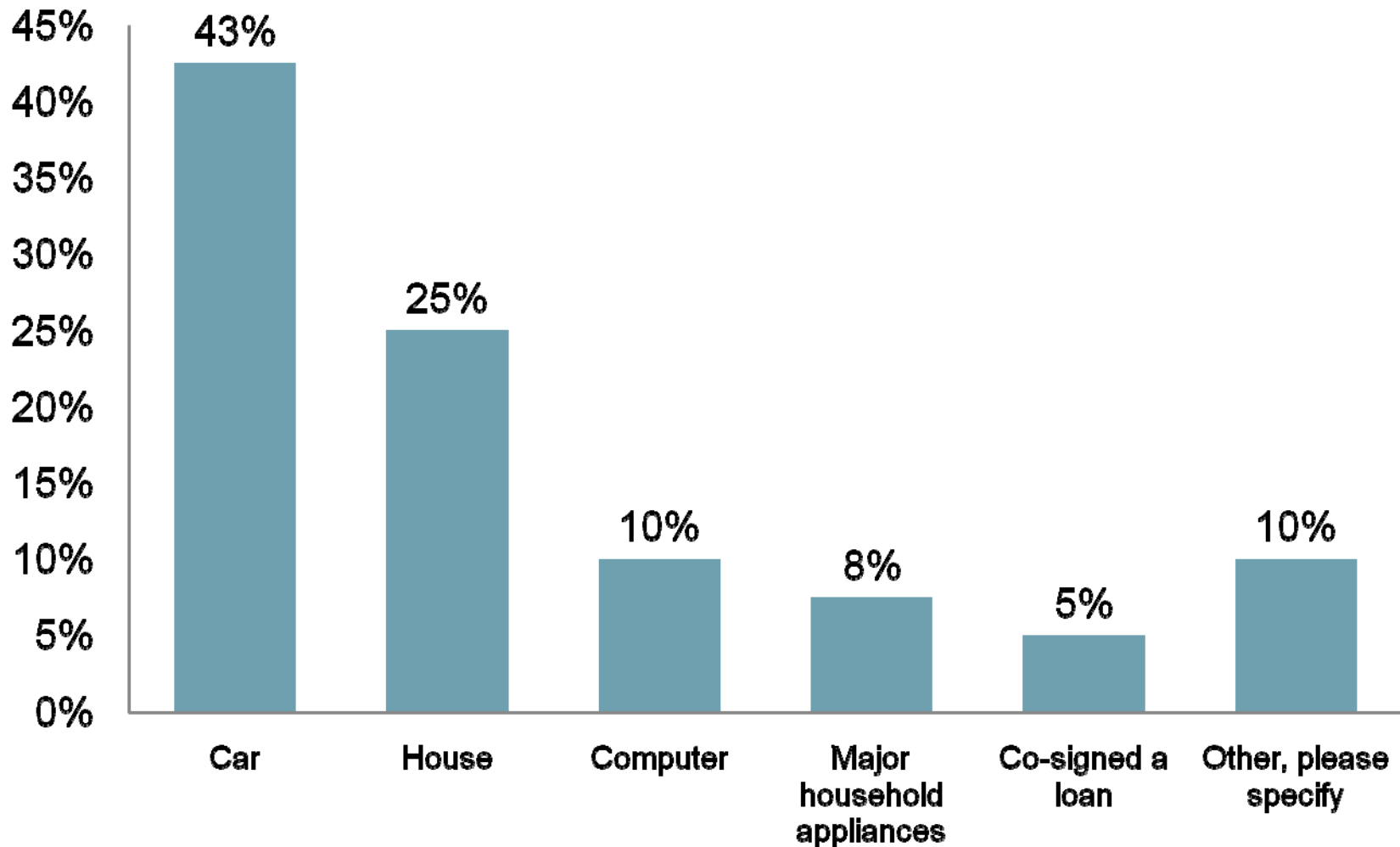
