## **Dr. John A. Anderson** **ELCON**

Dr. Anderson is the President and CEO of the Electricity Consumer Resource Council (ELCON). He joined ELCON in 1980 and was named Executive Director in 1984. He has presented papers and spoken extensively on a wide range of electricity issues of importance to large industrial firms. Dr. Anderson holds both M.S. and Ph.D. Degrees from the University of Florida with concentration in public utility and industrial organization.

## **Thomas C. Anderson** **Baker & O'Brien, Inc.**

Mr. Anderson is a Vice President of Baker & O'Brien, an independent consulting firm specializing in technology, economics, and management practices for the international oil, gas, chemical, and related industries with offices in Dallas and Houston. Mr. Anderson's focus at Baker & O'Brien includes mergers and acquisitions, plant performance evaluations and initiatives, crude and products distribution and trading, and strategic security studies. He is also on the Advisory Board of the Energy and Environmental Security Institute at the University of Colorado and is the chair of the Quantitative Work Group in support of the Clean and Diversified Energy Advisory Council of the Western Governors' Association. He is a Senior Visiting Fellow at the Center for Strategic and International Studies. Dr. Arent has a Ph.D. from Princeton University, an M.B.A. from Regis University, and a B.S. from Harvey Mudd College.

## **David Austin** **Congressional Budget Office (CBO)**

Dr. Austin conducts research in the areas of environmental and technology policy in the Microeconomic Studies Division of CBO. He has been at CBO for almost 6 years, and was at Resources for the Future for 8 years. His current work is on the effects of gasoline prices on driver behavior and on prices and shares in the passenger-vehicle market. He has done extensive work on the costs of fuel-economy standards and of the gasoline tax. In the past, Dr. Austin has also done research on liability policy and toxic emissions; Clean Air Act regulations; consumer benefits of new technologies; and spatial allocation of emissions controls. Dr. Austin is a past Secretary of the Association of Environmental and Resource Economists and has been on Georgetown's adjunct faculty. He received his B.S. in Mathematics from Stanford University, an M.A. in Statistics from Yale University, and a Ph.D. in Economics from the University of California, Berkeley.

### **Admiral Dennis Blair, USN (Ret.) Energy Security Leadership Council**

Prior to retiring in 2002, Admiral Dennis Blair served as Commander in Chief, U.S. Pacific Command, the largest of the combatant commands. During his 34-year Navy career, Admiral Blair served on guided missile destroyers in both the Atlantic and Pacific fleets and commanded the Kitty Hawk Battle Group. Ashore, he served as Director of the Joint Staff and as the first Associate Director of Central Intelligence for Military Support at the CIA. He has also served in budget and policy positions on the National Security Council and several major Navy staffs. A 1968 graduate of the U.S. Naval Academy, Admiral Blair earned a master's degree in History and Languages from Oxford University as a Rhodes Scholar, and served as a White House Fellow at the Department of Housing and Urban Development. He has been awarded four Defense Distinguished Service Medals and has received decorations from the governments of Japan, Thailand, Korea, and Australia.

### **Secretary Samuel Bodman Department of Energy (DOE)**

Secretary Bodman leads DOE as the Secretary of Energy. He was sworn in on February 1, 2005 after unanimous confirmation by the Senate. Previously, Secretary Bodman served as Deputy Secretary of the Treasury since February 2004. He also served as Deputy Secretary of the Department of Commerce beginning in 2001. Secretary Bodman is a financier and executive by trade, with three decades of experience in the private sector. He began his career as an Associate Professor of Chemical Engineering at MIT for 6 years and commenced his work in the financial sector as Technical Director of the American Research and Development Corporation. In 1983 he was named President and COO of Fidelity Investments and a Director of the Fidelity Group of Mutual Funds. In 1987, he joined Cabot Corporation, a Boston-based Fortune 300 company with global business activities in specialty chemicals and materials, where he served as Chairman, CEO, and a Director. He is a former Director of MIT's School of Engineering Practice. Secretary Bodman graduated from Cornell University in 1961 with

a B.S. in Chemical Engineering and completed his Sc.D. at MIT in 1965.

### **Theodore Bolema Central Michigan University**

Theodore Bolema is a Professor in the College of Business Administration at Central Michigan University. He is also a member of the Board of Scholars of the Mackinac Center for Public Policy in Midland, MI, where he has frequently written and spoken on electricity restructuring in Michigan. He previously was an attorney with the Antitrust Division of the United States Department of Justice and with Weil, Gotshal and Manges, LLP. He also served as a Special Assistant United States Attorney for the Eastern District of Virginia and as an Adjunct Professor at the George Mason University School of Law. He holds a Ph.D. in Economics from Michigan State University and a J.D. from the University of Michigan Law School.

He has written extensively on the regulation, organization, and competitiveness of energy markets. Dr. Bushnell has served as a member of the Market Monitoring Committee of the California Power Exchange and is currently a member of the Market Surveillance Committee of the California Independent System Operator (CAISO). He has also testified on regulatory and competition policy issues before numerous state and Federal regulatory and legislative institutions and consulted on energy issues throughout the U.S. and internationally. He received a Ph.D. in Operations Research from Berkeley in 1993.

Dr. Currie is the Global Head of Commodities Research in the Global Investment Research division of Goldman Sachs, where he conducts research on

commodity market dynamics in the context of corporate risk management programs, short- and long-term commodity investment strategies, and asset allocation. Prior to joining the firm, Dr. Currie taught undergraduate and graduate-level courses in Microeconomics and Econometrics at the University of Chicago and served as the associate editor of *Resource and Energy Economics*. He also worked as consulting economist, specializing in energy and other microeconomic issues, at Ernst and Young, LLP and Economic Insight, Inc. He has advised numerous government agencies in the United States, the EU and Russia. Dr. Currie earned a Ph.D. in Economics from the University of Chicago in 1996.

He was also formerly a tenured faculty member of the Department of Economics at the University of Western Ontario.

#### **Energy Policy Research Foundation, Inc.**

Dr. Gaskins is a partner in Norbridge, Inc., a consulting firm. He previously was a partner in High Street Associates, Inc., an investment group, from 1991-2002, and was President and CEO of Burlington Northern Railroad from 1985-89. A climate scientist, engineer and energy policy expert, Dr. Hannegan holds a Ph.D. in Earth System Science, a M.S. in Engineering, both from the University of California, Irvine, and a B.S. in Meteorology from the University of Oklahoma.

### **Jeff Hazle** **National Petrochemical & Refiners Association (NPRA)**

Mr. Hazle is the NPRA Technical Director and committee secretary for the Manufacturing and the Maintenance Committees. He is responsible for planning the technical sessions at the NPRA Annual Meeting, the Q&A and Technology Forum, and the Reliability &

She is past President of the American Association for the Advancement of Science (AAAS) (2004) and former Chairman of the AAAS Board of Directors (2005), a member of the National Academy of Engineering, a Fellow of the American Academy of Arts and Sciences, the American Physical Society, and AAAS. She serves as a Trustee of the Brookings Institution, a Life Member of the M.I.T. Corporation, and a member of the Council on Foreign Relations. She is a member of the Executive Committee of the Council on Competitiveness and serves on the board of Georgetown University. She also serves on the Board of Directors of the New York Stock Exchange (and is Chairman of the New York Stock Exchange Regulation Board), the Board of Regents of the Smithsonian Institution, and is a director of several major corporations. She was appointed Chairman of the Nuclear Regulatory Commission (NRC), 1995-1999, by President William J. Clinton. Prior to that, she was a theoretical physicist at the former AT&T Bell Laboratories and a professor of theoretical physics at Rutgers University. Dr. Jackson holds an S.B. in physics and a Ph.D. in theoretical elementary particle physics from M.I.T., and 40 honorary doctoral degrees.

### **John M. Kelly American Public Power Association**

John M. Kelly has served as director of economics and research for the American Public Power Association in Washington since 1982. Previously, he served in economics posts at the U.S. Bureau of Labor Statistics, the Library of Congress' Congressional Research Service, and the President's Council on Wage and Price Stability. Mr. Kelly has specialized in such areas as electric utility performance measurement, public and private utility efficiency comparisons, utility taxes, costing and pricing of utility services, subsidies, transmission access and deregulation issues, and utility rates of return.
