To Whom It May Concern:

This is a request under the Freedom of Information Act. I hereby request the following records:

A spreadsheet selection that shows complaints to the Consumer Sentinel Network about Fleetcor. This request is similar to a request we made a while back, but the date range of this request is September 20, 2016 to February 22, 2017. Such a selection of a spreadsheet or database will necessarily include dates the complaints were filed; name and location of the requester; full text of the request; and any other information CSN maintains on the complaints.

We also request a similar database sufficient to show complaints (and supplemental information as described above) for any of the products or companies listed below, made during the date range January 1, 2014 to February 22, 2017. If this means the entire database for that date range, that is fine; we have the capability to search for these companies and eliminate all others ourselves. But if you would like to do that for us, that's fine, too.
