- All records relating to current investigations/inquiries of FleetCor and its subsidiaries as listed above with regard to billing and/or bill collections practices.

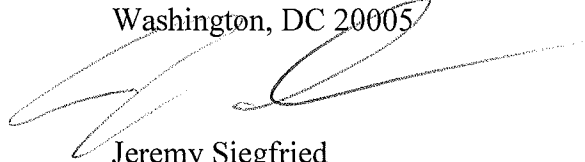
