FTC Rule 4.3(b)(2) provides that, except in situations not here applicable, the Administrative Law Judge may, for good cause shown, extend any time limit prescribed by the Rules. 16 C.F.R. § 4.3(b)(2).

Based on the foregoing, the Motion is GRANTED, and it is hereby ORDERED that the initial scheduling conference in this matter will be held on April 6, 2018, at 2:00 p.m. in Room 532, Federal Trade Commission Building, 600 Pennsylvania Avenue NW, Washington, DC.

The parties are expected to comply with the initial deadlines in the proposed scheduling order provided to the parties on March 20, 2018.
