RESPONDENT TRONOX LIMITED'S
MOTION FOR *IN CAMERA* TREATMENT OF TRIAL EXHIBITS

Tronox Limited (“Tronox”), by and through its undersigned counsel, respectfully moves pursuant to 16 C.F.R. § 3.45(b) and the scheduling order in this matter (as revised February 23, 2018) for *in camera* treatment of certain documents designated as trial exhibits by the parties to this case.

Complaint Counsel and Tronox (in conjunction with its co-respondents) have submitted their final proposed exhibit lists. Many of the documents produced by Tronox that appear on Respondents’ exhibit list or Complaint Counsel’s exhibit list contain confidential, competitively sensitive information. Rule 3.45(b) provides that a party may obtain *in camera* treatment for materials offered into evidence if “public disclosure will likely result in a clearly defined, serious injury.” Tronox, together with its counsel, has carefully reviewed all of the Tronox-produced documents that appear on the parties’ final exhibit lists. Tronox and its counsel have determined

that the public disclosure of documents listed in Exhibit B will cause a clearly defined, serious injury to Tronox. For the reasons set forth below and in the Declaration of John Romano (Exhibit A), Tronox seeks *in camera* treatment for these confidential materials.

I. Legal Standard

An applicant seeking *in camera* treatment for material offered into evidence must demonstrate that “its public disclosure will likely result in a clearly defined, serious injury.” 16 C.F.R. 3.45(b). The applicant must “make a clear showing that the information concerned is sufficiently secret and sufficiently material to their business that disclosure would result in serious competitive injury.” *In re 1-800 Contacts, Inc.*, 2017 FTC LEXIS 55 (April 4, 2017) (citation omitted). This tribunal weighs six factors to determine whether the information is sufficiently secret and material to warrant *in camera* treatment:

- (1) the extent to which the information is known outside of [the] business;
- (2) the extent to which it is known by employees and others involved in [the] business;
- (3) the extent of measures taken by [it] to guard the secrecy of the information;
- (4) the value of the information to [it] and to [its] competitors;
- (5) the amount of effort or money expended by [it] in developing the information;
- (6) the ease or difficulty with which the information could be properly acquired or duplicated by others.

In re Bristol-Myers Co., 90 FTC LEXIS 455, at *5-6 (Nov. 11, 1977).

II. Tronox’s Materials Meet the “Clearly Defined, Serious Injury Standard”

All six *Bristol-Myers* factors support Tronox’s motion for *in camera* treatment.

First, the information at issue is particular to Tronox’s business and is not known outside

Tronox, with the exception of prices, which are known to customers and other parties involved in the sale process, like distributors. *See* Romano Decl. at ¶ 4.

Second, the information at issue is known only to a small group within Tronox. All of the information is generally shared only with those employees who must or should be aware of it in connection with their job duties, and never with more than a small fraction of Tronox's 3,500 employees. *See id.*

Third, the documents that are identified in this motion were produced confidentially under the protections of the HSR Act or the protective order in this matter. Tronox has taken due care to protect the confidentiality of the information at issue, including by establishing and adhering to policies and practices prohibiting its disclosure, and producing it only pursuant to legal assurances that it would remain confidential. *See id.*

Fourth and most significantly, Tronox's competitors and customers would benefit at Tronox's expense from gaining access to these materials. *See id.* ¶¶ 6-13. For instance, Tronox's competitors would be able to use this information to unfairly compete with Tronox and to counteract Tronox's competitive strategies. Tronox's customers would be able to use this information to gain unfair bargaining leverage against Tronox. Tronox's relationships with certain customers would also suffer if the customers perceived themselves to be receiving less favorable terms than other customers. The gains accruing to Tronox's competitors and customers would come at Tronox's loss, working a clearly defined and serious injury to Tronox. *See id.*

Fifth, while most of the materials were created organically through Tronox's ordinary business activities, Tronox expended significant amounts of money on developing some of the materials, such as consultant reports. *See id.* at ¶ 4.

Sixth, it would generally be impossible for another party to properly acquire or develop the

information at issue because it is drawn from Tronox's confidential files and cannot be replicated by any third party. *See id.* ¶¶ 6-13.

The Commission has recognized that competitively sensitive information related to titanium dioxide producers are subject to extraordinary levels of protection. For example, in 1979, Administrative Law Judge Miles J. Brown ordered *in camera* treatment for certain exhibits produced by E.I. Dupont De Nemours & Co. ("DuPont") that contained detailed cost and operations data. *In re E.I. Dupont De Nemours & Co.*, 151 F.T.C. 679 (2011). Since then, Dupont has requested on numerous occasions that those documents remain *in camera*, and the Commission has consistently granted those requests. Most recently in 2011, the Commission has extended *in camera* treatment again until 2021. *Id.* Even 30 years after the documents were produced, the Commission agreed that if titanium dioxide competitors had "access to such detailed cost and operations information, [they] could ascertain DuPont's current costs through the use of readily available extrapolation techniques . . . [and] gain valuable insight about DuPont's closely held and proprietary production process." *Id.* The Commission explained that the documents should remain sealed given "the unusual level of detailed cost and operations data contained in the identified trial exhibits, the existence of precise extrapolation techniques, and the limited amount of technological innovation that has occurred in the titanium dioxide industry." *Id.* Those same competitive concerns exist in this case and the Commission's reasons for granting significant protections to Dupont's sensitive information should also apply here.

III. Each Type Of Confidential Information Should Remain *In Camera*

As described in the Romano Declaration, the materials at issue fall into at least one of eight categories. The following summary chart lists each category of materials, the applicable paragraph

discussing the category in the Romano Declaration, and the time period for which Tronox requests *in camera* treatment:

Exhibit B lists each document in question, the applicable bases for *in camera* treatment, and the time period for which *in camera* treatment is sought. For documents that fall into more than one confidentiality category, Tronox seeks *in camera* treatment for the longer applicable period.

A. Customer-Specific Price and Volume Information

The first category of documents that should be granted *in camera* treatment is the category of documents that contain individual customer price and volume information, or other sensitive customer-specific bidding and negotiations information. Tronox does not publish prices and does not publicly reveal any customer-specific information related to prices, discounts, margins, or sales volumes. Romano Decl. ¶ 6. Since Tronox negotiates individual prices with each of its customers, individualized pricing data is among the most highly sensitive information that Tronox has produced. *Id.* If this confidential pricing and volume information is disclosed, Tronox's customers

could gain an unfair advantage during negotiations with Tronox, and Tronox's competitors could use it to unfairly take business from Tronox. *Id.*

Tronox strives to develop stable, long-term relationships with its customers, so prices paid by those customers relative to other customers tend to change only very gradually over time. Specific price and volume information can be used to infer relevant information about Tronox's current (and future) prices and commercial relationships. *Id.* Tronox requests that this highly sensitive information remain *in camera* for ten years. *See In the Matter of Impax Labs., Inc., A Corp., Respondent.*, 9373, 2017 WL 6033193, at *2 (MSNET Nov. 28, 2017) (granting *in camera* treatment for ten years over documents containing "data, methods and models from the National Prescription Audit database and/or the National Sales Perspectives database").

B. Aggregated Price and Volume Information

Tronox also has produced documents that aggregate information about price and volume which do not include customer-specific information. Romano Decl. ¶ 7. The release of information about Tronox's prices and volumes for a particular customer, industry, product, or geography will harm Tronox's competitive posture, negotiating position, and customer relationships. *Id.* Tronox requests this information remain *in camera* for five years. *See In the Matter of 1-800 Contacts, Inc., A Corp., Respondent.*, 9372, 2017 WL 1345290, at *6 (MSNET Apr. 4, 2017) (granting *in camera* treatment for five years over documents containing aggregate data like "statistics of the pricing impact on brand discounts, brand clicks and investment rates.").

C. Information Regarding Price-Setting Processes

Tronox has produced documents that contain strategically sensitive information about how Tronox sets and negotiates prices. Romano Decl. ¶ 8. These documents include information about how Tronox decides whether to implement a price increase and how Tronox responds to various

types of competitive offers. *Id.* Since Tronox’s negotiation strategies have not changed significantly, even information that is years old is sensitive because it would tend to reveal Tronox’s current (and future) approach to price negotiations. *Id.* Given the highly sensitive nature of these documents, Tronox requests this information remain *in camera* for ten years. *See In the Matter of Impax Labs., Inc., A Corp., Respondent.*, 9373, 2017 WL 6033193, at *2 (MSNET Nov. 28, 2017) (granting *in camera* treatment for ten years over documents containing “data, methods and models from the National Prescription Audit database and/or the National Sales Perspectives database”).

D. Trade Secrets

Tronox has produced documents that include trade secrets, including information regarding its production processes and technical specifications for its products. Romano Decl. ¶ 9. Tronox requests that these documents remain *in camera* indefinitely. *In the Matter of Impax Labs., Inc., A Corp., Respondent.*, 9373, 2017 WL 4948986, at *1 (MSNET Oct. 20, 2017) (“trade secrets meriting indefinite in camera treatment include secret formulas, processes, other secret technical information, or information that is privileged”).

E. Capacity, Production, and Inventory Information

Tronox also has produced documents about Tronox’s production of titanium dioxide, including documents that contain detailed information about input volume and costs, plant capacity, utilization, output, and inventory at its TiO₂ feedstock and pigment facilities. Romano Decl. ¶ 10. Documents that contain detailed costs data present a significant risk to Tronox because competitors could use well-known extrapolation techniques to extrapolate historic cost data to determine Tronox’s current costs. *Id.* The public release of information about these topics will also harm Tronox by allowing Tronox’s competitors and customers to infer whether Tronox is

likely to increase or decrease prices, whether Tronox has the capacity to supply more TiO₂ to specific customers, or whether Tronox is likely to increase capacity or production in the future. *Id.* Tronox requests that this information remain *in camera* for ten years. *See In re E.I. Dupont De Nemours & Co.*, 151 F.T.C. 679 (2011) (granting another ten years of *in camera* treatment to detailed cost data related to titanium dioxide production).

F. Business Plans

Tronox produced business planning documents, including strategic plans, budgets, and other forward-looking business plans, as well as certain non-public documents related to the synergies expected from the proposed combination with Cristal. Romano Decl. ¶ 11. The public release of these materials would harm Tronox because they reveal Tronox's current and future plans to improve its business and compete in the market, and Tronox's competitors could use them to plan their own competitive activities or unfairly undermine Tronox's plans for growth. *Id.* Tronox requests that these documents remain *in camera* for a period of ten years. *See In the Matter of Impax Labs., Inc., A Corp., Respondent.*, 9373, 2017 WL 4948988, at *1 (MSNET Oct. 23, 2017) (ordering *in camera* treatment for ten years over "documents that include financial and sales projections for future years and pipeline products").

G. Sensitive Personal Information

Tronox produced documents that contain sensitive personal information such as social security numbers, personal addresses, and telephone numbers. Romano Decl. ¶ 12. Tronox also produced employee reviews that contain sensitive and personal information about individual employee work performance. *Id.* Tronox requests that sensitive personal information be kept *in camera* indefinitely because "sensitive personal information ... shall be accorded permanent *in camera* treatment unless disclosure or an expiration date is required or provided by law." 16 C.F.R.

§ 3.45(b)(3).

IV. Conclusion

For the reasons set forth herein, Tronox respectfully moves that its motion for *in camera* treatment be granted.

Declaration of John Romano

1. My name is John D. Romano. I am the Senior Vice President and Chief Commercial Officer of Tronox Limited (“Tronox”).
2. I am responsible for supervising all of Tronox’s customer-facing activities, including sales, marketing, logistics, product development, and technical service. I also have knowledge of Tronox’s TiO₂ feedstock and pigment production activities. I have been employed by Tronox or its predecessors since 1987.
3. I am familiar with Tronox’s policies and procedures regarding the protection of confidential information, and I have personal knowledge of how the disclosure of various types of confidential information would harm Tronox.
4. In the ordinary course of business, Tronox keeps certain information strictly confidential and limits its distribution within the company to employees who must or should know it in connection with their job duties. For instance, customer-specific price information is generally known only to a handful of sales, customer service, and accounting personnel. Generally speaking, the only people outside Tronox would who be aware of this information are the customers themselves or other parties who are involved in the sales process, like distributors. When Tronox produced confidential material to the FTC, it relied on the confidentiality rules and protective order which shielded confidential information from public disclosure.
5. I understand that the parties to this litigation have included on their trial exhibit lists thousands of documents that Tronox identified as confidential. Due to the volume, no one person could reasonably review and categorize each document. Tronox’s outside counsel has described to me the categories of confidential information contained in these documents. For each category, I explain why Tronox will be harmed if the confidential information is made public.
6. Customer-Specific Price and Volume Information. Tronox individually negotiates prices with each of its customers. Tronox does not publish list prices and does not publicly reveal any customer-specific information related to prices, discounts, margins, or sales volumes. This information is highly sensitive. If confidential pricing and volume information is disclosed, Tronox’s competitors could use it to unfairly take business from Tronox. If this confidential pricing and volume information is disclosed, Tronox’s customers could gain an unfair advantage during negotiations with Tronox. Further, Tronox’s relationships with certain customers could suffer if they learned that other customers were paying different prices. I believe this information should remain confidential because it can be used to infer relevant information about Tronox’s current (and future) prices and commercial relationships. For instance, Tronox strives to develop stable, long-term relationships with its customers so prices paid by those customers relative to other customers tend to change only very gradually over time.
7. Aggregated Price and Volume Information. Tronox also has produced documents that aggregate information about price and volume which do not include customer-specific

information. This information is also sensitive and would seriously harm Tronox if publicly disclosed. For instance, the release of information about Tronox's prices and volumes for a particular customer industry, products, or geography will harm Tronox's competitive posture, negotiating position, and customer relationships in the manner described in the previous paragraph. I believe this information should remain confidential.

8. Information Regarding Price-Setting Processes. Tronox has produced documents that contain information about how Tronox sets and negotiates prices. These documents include information about how Tronox decides whether to implement a price increase and how it determines how to respond to various types of competitive offers. I believe this information should remain confidential. Even information that is years old is sensitive because it would tend to reveal Tronox's current (and future) approach to price negotiations.
9. Trade Secrets. Tronox has produced documents that include trade secrets, including information regarding its production processes and technical specifications for its products.
10. Capacity, Production, and Inventory Information. Tronox also has produced documents about Tronox's production of TiO₂. These types of documents include information about input volume and costs, plant capacity, utilization, output, and inventory at its TiO₂ feedstock and pigment facilities. Certain documents with detailed costs data present a significant risk to Tronox. Given the existence of extrapolation techniques, competitors could extrapolate historic cost data to ascertain Tronox's current costs. The public release of information about these topics will also harm Tronox by allowing Tronox's competitors and customers to infer whether Tronox is likely to increase or decrease prices, whether Tronox has the capacity to supply more TiO₂ to specific customers, or whether Tronox is likely to increase capacity or production in the future. I believe this information should remain confidential.
11. Business Plans. Tronox produced documents categorized as "Business Plans" which includes strategic plans, budgets, and other forward-looking business plans, as well as certain non-public documents related to the synergies expected from the proposed combination with Cristal. The public release of these materials would harm Tronox because they reveal Tronox's current and future plans to improve its business and compete in the market; Tronox's competitors could use them to plan their own competitive activities or unfairly undermine Tronox's plans for growth. I believe this information should remain confidential.
12. Sensitive Personal Information. Tronox also produced documents that contained sensitive personal information such as social security numbers, personal addresses, and telephone numbers. Tronox also produced employee reviews that contain sensitive and personal information about individual employee work performance. I believe this information should remain confidential.
13. Other Confidential Information. For each category, the examples provided are merely representative—they are not meant to be an exhaustive list of the types of documents in that category that appear on the parties' exhibit lists and that should be afforded in

camera treatment because releasing them to the public would harm Tronox. Similarly, these categories cannot capture every possible type of sensitive information that should not be released to the public. I understand that Tronox's outside counsel may identify such documents and, with my guidance, identify in applicable court filings why in camera treatment is warranted for those documents.

14. This declaration draws upon the collective efforts of multiple people other than myself, and is based on my understanding of the facts at this time. I reserve the right to modify or supplement this affidavit if I discover new facts that render it inaccurate or incomplete.

Pursuant to 28 U.S.C. § 1746, I declare under penalty of perjury that the foregoing is true and correct.
