HENRY SCHEIN, INC'S MOTION FOR *IN CAMERA*
TREATMENT OF TRIAL EXHIBITS

Pursuant to Rule 3.45 of the Federal Trade Commission's Rules of Practice, 16 C.F.R. § 3.45(b), Henry Schein, Inc. ("Schein") respectfully moves this Court for *in camera* treatment of certain documents designated as trial exhibits by the parties to this case.

Complaint Counsel and Respondents have submitted their final proposed exhibit lists. Many of the documents produced by Schein that appear on Respondents' or Complaint Counsel's exhibit lists contain confidential, competitively sensitive information, disclosure of which would harm Schein's business operations. Under Rule 3.45(b), a party may obtain *in camera* treatment for materials offered into evidence if "public disclosure will likely result in a clearly defined, serious injury." After conducting a careful review of all of the documents produced by Schein that appear on the parties' exhibit lists, Schein and its counsel have determined that public disclosure of the documents listed in Exhibit B will cause a clearly defined, serious injury to Schein. As such, and for the reasons set forth below and in the Declaration of Marjorie Han (Exhibit A), Schein seeks *in camera* treatment for these confidential and proprietary materials.

I. Legal Standard

In camera treatment is appropriate for materials (1) that constitute sensitive personal information, such as social security or other ID numbers, tax info, bank account info, and sensitive health info, or (2) public disclosure of which will result in serious injury to the party requesting *in camera* treatment. See 16 C.F.R. 3.45; see also *In re 1-800-Contacts, Inc.*, 2017 FTC LEXIS 55 (April 4, 2017) (*in camera* treatment appropriate for information that “is sufficiently secret and sufficiently material to their business that disclosure would result in serious competitive injury.”). A proponent of *in camera* treatment may demonstrate the requisite competitive injury by showing that the information is secret and that it is material to the business. *In re General Foods Corp.*, 95 F.T.C. 352, 355 (1980).

In making *in camera* determinations, factors that the Court may consider include: (1) the extent to which the information is known outside the business; (2) the extent to which it is known by employees and others involved in the business; (3) the extent of measures taken to guard the secrecy of the information; (4) the value of the information to the business and its competitors; (5) the amount of effort or money expended in developing the information; and (6) the ease or difficulty with which the information could be acquired or duplicated. *In re Bristol-Myers Co.*, 90 FTC LEXIS 455, at *5-6 (Nov. 11, 1977). In general, courts endeavor to “protect confidential business information from unnecessary airing.” *H.P. Hood & Sons, Inc.*, 58 F.T.C. 1184, 1188 (1961).

II. Schein’s Materials Meet the Standard for *In Camera* Treatment

Schein seeks *in camera* treatment of documents listed in Exhibit B to this motion, all of which contain information that is both secret and material to Schein’s business. This information includes customer contracts; customer-specific pricing, purchasing plans, discounts, rebates and service arrangements; performance information such as sales, costs, profits, margins and market

share; and business plans, strategic initiatives and forward-looking metrics (“Confidential Information”).

The Confidential Information is confidential and proprietary, and is known only to individuals in Schein’s employ or outside consultants engaged by Schein, such as attorneys and accountants. The lone exception is for prices, which are customer-specific and frequently subject to contractual confidentiality clauses. For this reason, Schein noted the confidential nature of its documents when they were produced. It has also established internal policies and practices to prohibit disclosure of this information. Han Decl. ¶ 3. In many cases, Schein is contractually bound to maintain the confidentiality of such information. *See, e.g.*, CX0294 at 4-5; CX2224 at 7-8; CX2878 at 130-131; RX2079 at 5; RX2348 at 3-4; RX2656 at 6-7.

As described in more detail below, disclosure of the Confidential Information would result in loss of business advantage to Schein. *See In re Dura Lube Corp.*, 1999 FTC LEXIS 255 at *7 (1999) (“The likely loss of business advantages is a good example of a ‘clearly defined, serious injury.’”). If disclosed, both competitors and customers would be able to take advantage of this information. It would give insight into Schein’s competitive strategies, negotiation positions, and pricing. Such asymmetrical information vis-à-vis competitors and customers would disadvantage Schein and cause substantial injury in the marketplace.

Competitors cannot obtain this Confidential Information absent disclosure in this matter, because the materials come from Schein’s confidential business practices. Without insight into Schein’s confidential practices and operations, this information could not be replicated by an outside party.

Schein has separated the Confidential Information for which it seeks *in camera* treatment into five categories, listed in the chart below. The chart also indicates the relevant paragraphs of

the Han Declaration and the requested duration of *in camera* treatment for each category. Exhibit B lists each document at issue, the applicable basis for *in camera* treatment, the portion of the document on which confidential material can be found, and the duration for which *in camera* treatment is sought.

A. Customer Contracts

Schein's Confidential Information includes numerous contracts produced in this matter, including numerous primary vendor agreements between Schein and various customers. *See, e.g.*, CX0294; CX2224; CX2878; RX2079; RX2348; RX2656. These contracts are confidential agreements between private parties, and most contain confidentiality clauses. *See, e.g.*, CX0294 at 4-5; CX2224 at 7-8; CX2878 at 130-131; RX2079 at 5; RX2348 at 3-4; RX2656 at 6-7. Schein negotiates these contracts individually with each of its customers, including individualizing pricing, discounts, and other terms. If this confidential information were disclosed, then competitors could attempt to undercut the terms of such agreements to take away Schein customers, while new customers would have an unfair advantage in negotiations with Schein. Because Schein's pricing structures, service offerings and negotiation strategies develop gradually over time, even disclosure of contracts that are several years old would be harmful to Schein. Such disclosure would allow competitors or customers to infer valuable information about Schein's

current and future contracts and customer relationships. Schein requests that this information remain *in camera* for at least 10 years. See *In re Otto Bock Healthcare N. Am., Inc.*, 2018 FTC LEXIS 111, *11 (F.T.C. July 6, 2018) (granting five years of *in camera* treatment for distribution agreements); *In re Tronox Ltd.*, 2018 FTC LEXIS 77, *2 (F.T.C. May 15, 2018) (granting 10 years of *in camera* treatment for customer-specific information).

B. Non-Public Pricing and Service Information

The Confidential Information also includes materials such as price lists, discount schedules, rebate figures and volume purchasing information offered to specific customers on a confidential basis. See, e.g., CX2371 at 3-5 (pricing and discount information); CX2385 (price, discount and volume purchasing information); CX2389 at 001 (discount and rebate information); CX2508 at 4-11 (price and service proposal); CX2614 (sponsorship outlays for customer events); CX2934 (pricing, warranty and fee figures); RX2511 (purchase level and rebate information); RX2613 (purchase and rebate figures). As noted above, release of information about prices, discounts, or contractual terms—even if several years old—would materially harm Schein’s ability to compete in the marketplace and fairly negotiate. Schein’s price information is customer-specific and non-public, meaning disclosure would provide competitors and customers with the advantage of asymmetrical information. Schein requests that this information remain *in camera* for at least 10 years. See *Tronox*, 2018 FTC LEXIS 77, *2 (granting 10 years of *in camera* treatment for customer-specific prices).

C. Confidential Performance Metrics

The Confidential Information also includes information about Schein’s sales, costs, margins, financials, and market share. See, e.g., CX2226 (sales and profit figures); CX2345 (sales and market share information); CX2936 (annualized revenues); CX2956 (regional sales figures and

growth percentages); RX2324 (equipment and merchandise purchase figures); RX2622 (net sales figures). These documents describe Schein’s business operations, and Schein’s analysis of them. If disclosed, they could be used by competitors to gain an unfair advantage with information about whether and when Schein decides to implement business changes, or how Schein is impacted by different competitive forces. Details about costs—and in particular, commission rates paid to employees—present an increased risk. Such information would enable competitors to unfairly compete against Schein. As such, Schein requests that these documents remain protected for at least five years. *See Otto Bock*, 2018 FTC LEXIS 111, *11 (F.T.C. July 6, 2018) (providing five years of *in camera* treatment for sales and financial data).

D. Confidential Strategic and Business Plans

The parties’ exhibits lists include strategic plans, budgets, projections, private information related to proposed mergers and acquisition activity, and other forward-looking strategic documents produced by Schein. *See, e.g.*, CX2596 (Board of Directors presentation that details, among other things, strategic priorities, growth plans, and budgets); CX2632 (detailing strategic plans and projects); CX2944 (sales structure and commission information); RX2249 (changes to customer engagement and onboarding protocols); RX2627 (detailing pricing and commission rate changes). These documents implicate Schein’s near-term and long-term plans to compete in the marketplace, and could be used by competitors to unfairly undermine Schein in certain competitive areas. As such, these documents should be granted *in camera* treatment for at least 10 years. *See Tronox*, 2018 FTC LEXIS 77, at *2 (granting 10 years of *in camera* treatment for confidential business plans); *In the Matter of Impax Labs., Inc., A Corp.*, 9373, 2017 WL 4948988, at *1 (MSNET Oct. 23, 2017) (granting ten years of *in camera* treatment for “financial and sales projections for future years and pipeline products”).

E. Sensitive Personal Information

The documents in this category are more numerous than any other. Schein produced many documents that contain sensitive personal information such as personal addresses and telephone numbers. Schein requests that sensitive personal information be kept *in camera* indefinitely because such information “shall be accorded permanent in camera treatment unless disclosure or an expiration date is required or provided by the law.” 16 C.F.R. § 3.45(b)(3).

III. Conclusion

For the foregoing reasons, Schein respectfully move that its motion for *in camera* treatment be granted.

Exhibit A

Declaration of Marjorie Han

1. I am Marjorie Han of Henry Schein, Inc. (“Schein”). I make this declaration in support of Schein’s Motion for *In Camera* Treatment of certain confidential documents and information (the “Confidential Information”).

2. I am Vice President and Senior Counsel for Litigation. I am responsible for overseeing Schein’s antitrust and other litigation matters, including the protection of Schein’s confidential and proprietary information used in litigation. I have been employed by Schein since 2003.

3. I and outside counsel have reviewed the Confidential Information, and I am familiar with these materials. I am familiar with the confidential and proprietary nature of this information from my work in connection with related litigation where such information has remained under seal. Given my position at Schein, I am familiar with Schein’s policies and procedures regarding the protection of such confidential and proprietary information. Based on my review of the documents and my knowledge of Schein’s business, I believe disclosure of the Confidential Information would cause serious competitive injury to Schein.

4. I understand that parties to this litigation have included on their final proposed exhibit lists hundreds of documents produced by Schein, many of which include confidential and propriety information. In the ordinary course of business, Schein generates and maintains highly confidential information. Below, I explain why and how Schein would be harmed if any such category of Confidential Information is publicly disclosed. Documents containing the below categories of Confidential Information are listed in Exhibit B.

5. Customer Contracts: Schein negotiates contracts with many of its customers, which include pricing and other competitively sensitive terms that are specific to individual agreements.

As such, these contracts are generally subject to confidentiality provisions. *E.g.*, CX0294 at 4-5; CX2224 at 7-8; CX2878 at 130-131; CX4091 at 5; CX6602 at 5. If the terms of these current contracts were disclosed, Schein's business operations would be harmed on multiple fronts. First, competitors would gain insight into Schein's offerings and could attempt to unfairly compete for Schein's current and prospective customers, thus harming its current and future business. Furthermore, prospective customers would obtain an upper hand in negotiations, while current customer relations could be imperiled if certain customers discovered contract terms that they interpret, without context, to be more favorable to other parties. To the extent this category includes contracts that are several years old and/or no longer operative, disclosure would nonetheless be harmful to Schein. Schein's pricing structures, service offerings and negotiation tactics develop gradually over time. As such, competitors or customers could use past contracts to infer information about Schein's current or future contracts or customer relationships.

6. Non-Public Pricing and Service Information: Schein individually negotiates prices with many of its customers. Schein does not publicly disclose information related to specific prices, discounts, rebates, and volume purchasing information related to individual customers. To the extent Schein's documents include such information on a customer-specific basis, Schein would be harmed by public disclosure for the same reasons given in the previous paragraph. Furthermore, as noted above, Schein's pricing and service offerings develop very slowly over time, meaning that competitors and customers could infer valuable information from materials that are several years old. Accordingly, this information should remain confidential.

7. Confidential Performance Metrics: Some documents on the parties' exhibit lists contain confidential information about Schein's sales, costs, margins, financial performance, and market share. If produced publicly, this information could give competitors extensive and

unwarranted insight into Schein's business operations, and allow them to deduce how Schein plans strategically and responds to changes in the marketplace, such as new competitive forces or the development of different customer attributes and demands. This information would also allow competitors and customers to infer Schein's forward-looking pricing strategies which would be damaging for reasons given in the paragraphs above. Details about costs are particularly sensitive in this regard because of their relation to potential prices. Included in costs are employee commission rates, which are also highly confidential; disclosure of that information would enable competitors to unfairly compete for talented and valuable employees. Accordingly, this information should be afforded a high degree of protection.

8. Confidential Strategic and Business Plans: In the course of its business, Schein creates various strategic plans, budgets, projections, and other forward-looking documents, as well as private information related to proposed merger and acquisition activity. These documents directly relate to Schein's plans in the near term and long term to improve its business operations, grow sales and compete in the marketplace. If disclosed, Schein's competitors could use this information to make their own business plans or to undermine Schein's plans. These materials should therefore remain confidential.


9. Sensitive Personal Information: Schein produced documents that contain sensitive personal information such as personal addresses and telephone numbers. I believe the documents in this category, which are more numerous than any other, should remain confidential indefinitely.

10. Though many documents could plausibly be grouped into multiple categories, each document has been designated with the category that is most appropriate. The only exceptions are documents that contain confidential business information and sensitive personal information, which are noted as separate entries on Exhibit B.

11. I reserve the right to modify or supplement this affidavit if I discover new facts that render it inaccurate or incomplete.

Pursuant to 28 U.S.C. § 1746, I declare under penalty of perjury that the foregoing is true and correct.
