23 On February 7, 2011, this Court issued an Order Granting Leave to File
24 Amended Complaint Under Temporary Seal (“Temporary Seal Order”) permitting
25 plaintiff Federal Trade Commission (“FTC”) to file an unredacted Amended
26 Complaint Under Temporary Seal. Docket No. 48. The Temporary Seal Order
27 provided that, pending a protective order request from Lights of America, Inc.
28 (“LOA”) and the Court’s ruling on any such request, a temporary seal would

1 remain in place. The FTC filed an unredacted Amended Complaint under
2 Temporary Seal as well as a publicly filed Redacted Amended Complaint. Docket
3 Nos. 42 and 49.

4 Subsequent to the Temporary Seal Order, LOA filed an Application to
5 Retain Redacted Amended Complaint (“Application”) asking the Court to retain,
6 as the operative public document in this matter, the FTC’s Redacted Amended
7 Complaint with redaction of references to internal LOA emails and LOA sales
8 figures. The FTC opposed that Application.¹ On March 31, 2011, the Court
9 entered an order denying LOA’s Application. Docket No. 87.

10 Therefore, consistent with the Temporary Seal Order, the FTC submits for
11 filing and entry on the public docket the FTC’s Amended Complaint (attached
12 hereto as Exhibit A) with all redactions removed, except for the sales figures
13 referenced in the Temporary Seal Order. The unredacted Amended Complaint
14 shall remain under seal.
