**STIPLUATED TEMPORARY
RESTRAINING ORDER**

Plaintiff, Federal Trade Commission (“FTC”), has filed a complaint seeking a permanent injunction and other equitable relief, pursuant to Section 13(b) of the Federal Trade Commission Act (“FTC Act”), 15 U.S.C. § 53(b), and a motion for a temporary restraining order (Doc. 3) pursuant to Rule 65(b) of the Federal Rules of Civil Procedure. The parties have stipulated (Doc. 17) to the entry of a temporary restraining order (“Order”).

Based upon the parties' Stipulation (Doc. 17), and as fully set forth herein, **IT IS HEREBY ORDERED GRANTING** the Federal Trade Commission's Motion for a Temporary Restraining Order (Doc. 3).

FINDINGS

By stipulation of the parties, the Court finds as follows:

1. The FTC and Defendants have stipulated and agreed to entry of this temporary restraining order without any admission of wrongdoing or violation of law, and without a finding by the Court of law or fact other than stated below.

- 1 2. The Court has jurisdiction over the subject matter of this case, and there is good
2 cause to believe it will have jurisdiction over Defendants.
- 3 3. Venue in the District of Arizona is proper under 28 U.S.C. § 1391(b) and (c) and
4 15 U.S.C. § 53(b).
- 5 4. The FTC asserts that there is good cause to believe that Defendants Stepping
6 Stonez Development, LLC, Intentional Growth, LLC, and Stephen J. Remley have
7 engaged, and are likely to continue to engage, in acts or practices that violate
8 Section 5 of the FTC Act, 15 U.S.C. § 45, and that the FTC is, therefore, likely to
9 prevail on the merits of this action.
- 10 5. The FTC asserts that there is good cause to believe that immediate and irreparable
11 harm will result from Defendants' ongoing violations of the FTC Act unless
12 Defendants are immediately restrained by an order of this Court.
- 13 6. The FTC asserts that there is good cause to believe that immediate and irreparable
14 damage to the Court's ability to grant effective final relief for consumers in the
15 form of monetary restitution and disgorgement of ill-gotten gains will occur from
16 the transfer, dissipation or concealment by Defendants of their assets or business
17 records unless Defendants are immediately restrained and enjoined by Order of
18 this Court.
- 19 7. The FTC asserts that good cause exists for permitting the FTC immediate access
20 to Defendants' business premises, and permitting the FTC to take expedited
21 discovery to locate and preserve assets and documents and ensure compliance with
22 this Order.
- 23 8. No security is required of any agency of the United States for issuance of a
24 temporary restraining order. Fed. R. Civ. P. 65(c).
- 25 9. The entry of this Order is in the public interest.

DEFINITIONS

- 26 1. "Academic Degree or Certification Program" means any product, service, plan, or
27 program that provides or purports to provide doctoral degrees, master's degrees,
28 bachelor's degrees, associate's degrees, high school diplomas or high school

- 1 equivalency diplomas or certificates, certifications, certificates, or any other
2 document that confers or purports to confer a qualification, records or purports to
3 record success in examinations or successful completion of a course of study, or
4 evidences or purports to evidence that a consumer has completed and shown
5 proficiency in a curriculum recognized as necessary to earn the indicated degree,
6 diploma, certification, certificate, or other document, whether denominated as a
7 degree, diploma, certification, certificate, or other name, whether denoted as a real
8 or novelty item.
- 9 2. “Assets” means any legal or equitable interest in, right to, or claim to, any real or
10 personal property, including, without limitation, chattels, goods, instruments,
11 equipment, fixtures, general intangibles, leaseholds, mail or other deliveries,
12 inventory, checks, notes, accounts, credits, contracts, receivables, shares of stock,
13 and all cash, wherever located.
- 14 3. “Customer” means any person who has paid, or may be required to pay, for
15 products, services, plans, or programs offered for sale or sold by any other person.
- 16 4. “Defendants” means the Individual Defendant and the Corporate Defendants,
17 individually, collectively, or in any combination. “Corporate Defendants” means
18 Stepping Stonez Development, LLC, Intentional Growth, LLC, and their
19 successors and assigns. “Individual Defendant” means Stephen J. Remley, and
20 any other name by which he may be known.
- 21 5. “Document” is equal in scope and synonymous in meaning to the usage of the
22 term in Federal Rule of Civil Procedure 34(a), and includes writings, drawings,
23 graphs, charts, photographs, audio and video recordings, computer records, and
24 any other data compilations from which information can be obtained. A draft or
25 non-identical copy is a separate document within the meaning of the term.
- 26 6. “Person” means a natural person, organization, or other legal entity, including a
27 corporation, partnership, proprietorship, association, cooperative, or any other
28 group or combination acting as an entity.

ORDER

PROHIBITED REPRESENTATIONS

- 1
2
3 **I. IT IS THEREFORE ORDERED** that Defendants, their officers, agents,
4 employees, and attorneys, and all other persons in active concert or participation
5 with any of them who receive actual notice of this Order by personal service or
6 otherwise, whether acting directly or indirectly, in connection with the advertising,
7 marketing, promotion, offering for sale, or sale of any academic degree or
8 certification program are temporarily restrained and enjoined from
9 misrepresenting, or assisting others in misrepresenting, expressly or by
10 implication:
- 11 A. That consumers can successfully use any academic degree or certification
12 program as a valid high school equivalency credential when applying for jobs,
13 seeking enrollment in higher education institutions, or for other purposes;
 - 14 B. That any high school, college, university, or other educational institution
15 issuing any academic degree or certification program has been accredited by an
16 independent, third-party accrediting body; or
 - 17 C. Any other fact material to a consumer’s decision whether to purchase any
18 academic degree or certification program.

DISABLEMENT OF WEB SITES

- 19
20 **II. IT IS FURTHER ORDERED** that, immediately upon service of the Order upon
21 them and pending determination of the FTC’s request for a preliminary injunction,
22 (1) any person hosting any Internet website for, or on behalf of, any Defendant,
23 and (2) Defendants, their officers, agents, employees, and attorneys, and all other
24 persons in active concert or participation with any of them who receive actual
25 notice of this Order by personal service or otherwise, whether acting directly or
26 indirectly, shall:
- 27 A. Immediately do whatever is necessary to ensure that the Internet websites
28 listed on **Schedule A** of this Order cannot be accessed by the public;

1 B. Prevent the destruction or erasure of any Internet website used by Defendants
2 for the advertising, marketing, promotion, offering for sale, sale, or provision
3 of any academic degree or certification program, including, but not limited to
4 the Internet websites listed on **Schedule A** of this Order, by preserving such
5 website in the format in which they are maintained currently; and

6 C. Immediately notify in writing counsel for the FTC of any other Internet
7 website operated or controlled by any Defendant and used by Defendants for
8 the advertising, marketing, promotion, offering for sale, sale, or provision of
9 any academic degree or certification program that is not listed in Section II.A
10 or B above.

11 **SUSPENSION OF INTERNET DOMAIN NAME REGISTRATIONS**

12 **III. IT IS FURTHER ORDERED** that, pending determination of the FTC's request
13 for a preliminary injunction, any domain name registrar shall suspend the
14 registration of the Internet websites listed on **Schedule A** of this Order , and
15 provide immediate notice to counsel for the FTC of any other Internet domain
16 names registered by Defendants, their officers, agents, employees, and attorneys,
17 and all other persons in active concert or participation with any of them who
18 receive actual notice of this Order by personal service or otherwise, whether acting
19 directly or indirectly.

20 **PROHIBITION ON RELEASE OF CONSUMER INFORMATION**

21 **IV. IT IS FURTHER ORDERED** that Defendants, their officers, agents, employees,
22 and attorneys, and all other persons in active concert or participation with any of
23 them who receive actual notice of this Order by personal service or otherwise,
24 whether acting directly or indirectly, are temporarily restrained and enjoined from
25 disclosing, using, or benefitting from consumer information, including the name,
26 address, telephone number, email address, social security number, other
27 identifying information, or any data that enables access to a consumer's account
28 (including a credit card, bank account, or other financial account), of any person
which any Defendant obtained prior to entry of this Order in connection with any

1 academic degree or certification program; *provided, however*, that Defendants
2 may disclose such information to a law enforcement agency or as required by law,
3 regulation, or court order.

4 **ASSET FREEZE**

5 **V. IT IS FURTHER ORDERED** that:

6 A. Except as set forth in Sections V. B, V.C, and V.D of this Order, Defendants are
7 hereby temporarily restrained and enjoined from directly or indirectly:

- 8 1. Transferring, liquidating, converting, encumbering, pledging, loaning, selling,
9 concealing, dissipating, disbursing, assigning, spending, withdrawing, granting
10 a lien or security interest or other interest in, or otherwise disposing of any
11 funds, real or personal property, accounts, contracts, consumer lists, or any
12 other assets, or any interest therein, wherever located, including outside the
13 United States, that are: (1) owned or controlled, directly or indirectly, by any
14 Defendant(s), in whole or in part, or held, in whole or in part for the benefit of
15 any Defendant(s); (2) in the actual or constructive possession of any
16 Defendant(s); or (3) owned, controlled by, or in the actual or constructive
17 possession of any corporation, partnership, or other entity directly or indirectly
18 owned, managed, or controlled by, or under common control with any
19 Defendant(s), and any assets held by, for, or under the name of any
20 Defendant(s) at any bank, savings and loan institution, or bank of any
21 Defendant(s), or with any broker-dealer, escrow agent, title company,
22 commodity trading company, precious metal dealer, or other financial
23 institution or depository of any kind;
- 24 2. Opening or causing to be opened any safe deposit boxes titled in the name
25 of any Defendant(s), or subject to access by any Defendant(s);
- 26 3. Incurring charges or cash advances on any credit card, debit card, or
27 checking card issued in the name, singly or jointly, of any Defendant(s);
- 28 4. Incurring liens or encumbrances on real property, personal property or other
assets in the name, singly or jointly, of any Defendant(s); and

1 5. Cashing any checks from consumers, clients, or customers of any
2 Defendant(s).

3 6. The funds, property, and assets affected by this Section shall include: (a)
4 all assets of each Defendant as of the time this Order is entered, and (b)
5 those assets obtained after entry of this Order that are obtained from any
6 activities relating to the subject matter of the Complaint that predate the
7 entry of this Order.

8 B. The asset freeze provisions of this Order shall not apply to Bank of America
9 account number XXXX [REDACTED] in the name of Stephen Remley.

10 C. Individual Defendant may retain and spend income received from activities or
11 employment performed after the date of entry of this Order and unrelated to the
12 subject matter of the Complaint, provided, however, that he shall first deposit such
13 income into the account identified in Section V.B above.

14 D. Individual Defendant may retain and spend assets acquired by loan or gift after the
15 date of entry of this Order only after identifying such assets to FTC counsel. This
16 notice provision does not apply to loans or gifts valued at less than \$500.

17 **RETENTION OF ASSETS AND RECORDS BY FINANCIAL INSTITUTIONS**
18 **AND OTHER THIRD PARTIES**

19 **VI. IT IS FURTHER ORDERED** that any financial or brokerage institution or
20 depository, escrow agent, title company, commodity trading company, trust,
21 entity, or person that holds, controls, or maintains custody of any account or asset
22 owned or controlled, directly or indirectly, by any Defendant(s), or has held,
23 controlled, or maintained any account or asset of, or on behalf of, any
24 Defendant(s), upon service with a copy of this Order, shall:

25 A. Hold and retain within its control and prohibit Defendants from
26 withdrawing, removing, assigning, transferring, pledging, encumbering,
27 disbursing, dissipating, converting, selling, gifting, or otherwise disposing
28 of any accounts, assets, funds, or other property that are owned by, held in
the name of, for the benefit of, or otherwise controlled by, directly or

1 indirectly, any Defendant(s), in whole or in part, except for those identified
2 in Section V.B, V.C, or V.D of this Order or as directed by further order of
3 the Court;

4 B. Deny the Defendants access to any safe deposit box titled in the name of
5 any Defendant(s), individually or jointly, or subject to access by any
6 Defendant(s), whether directly or indirectly.

7 C. Provide counsel for the FTC, within three (3) business days after being
8 served with a copy of this Order, a certified statement setting forth:

9 1. the identification number of each such account or asset titled (1) in
10 the name, individually or jointly, of any Defendant(s); (2) held on
11 behalf of, or for the benefit of, any Defendant(s); (3) owned or
12 controlled by any Defendant(s); or (4) otherwise subject to access by
13 any Defendant(s), directly or indirectly;

14 2. the balance of each such account, or a description of the nature and
15 value of such asset as of the close of business on the day on which
16 this Order is served, and, if the account or other asset has been
17 closed or removed, the date closed or removed, the total funds
18 removed in order to close the account, and the name of the person or
19 entity to whom such account or other asset was remitted;

20 3. the identification of any safe deposit box that is either titled in the
21 name of any Defendant(s), or is otherwise subject to access by any
22 Defendant(s); and

23 4. if an account, safe deposit box, or other asset has been closed or
24 removed, the date closed or removed, the balance on such date, and
25 the manner in which such account or asset was closed or removed.

26 D. Provide counsel for the FTC, within three (3) business days after being
27 served with a request, copies of all documents pertaining to such account or
28 asset, including but not limited to originals or copies of account
applications, account statements, signature cards, checks, drafts, deposit

1 tickets, transfers to and from the accounts, all other debit and credit
2 instruments or slips, currency transaction reports, 1099 forms, and safe
3 deposit box logs; provided that such institution or custodian may charge a
4 reasonable fee.

5 **FINANCIAL REPORTS AND ACCOUNTING**

6 **VII. IT IS FURTHER ORDERED** that each Defendant, within three (3) business
7 days of service of this Order, shall prepare and deliver to counsel for the FTC:

- 8 A. For the Individual Defendant, a completed financial statement accurate as
9 of the date of service of this Order upon such Defendant (unless otherwise
10 agreed upon with FTC counsel) on the form of **Attachment A** to this Order
11 captioned, "Form Re: Financial Statement for Individual Defendant."
12 B. For the Corporate Defendants, a completed financial statement accurate as
13 of the date of service of this Order upon such Defendant (unless otherwise
14 agreed upon with FTC counsel) in the form of **Attachment B** to this Order
15 captioned, "Form Re: Financial Statement for Business Entity Defendant."
16 C. For each Defendant, a completed statement, verified under oath, of all
17 payments, transfers or assignments of funds, assets, or property worth
18 \$1,000 or more since January 1, 2004. Such statement shall include: (a)
19 the amount transferred or assigned; (b) the name of each transferee or
20 assignee; (c) the date of the transfer or assignment; and (d) the type and
21 amount of consideration paid the Defendant. Each statement shall specify
22 the name and address of each financial institution and brokerage firm at
23 which the Defendant has accounts or safe deposit boxes. Said statements
24 shall include assets held in foreign as well as domestic accounts.

25 **CONSUMER CREDIT REPORTS**

26 **VIII. IT IS FURTHER ORDERED** that the FTC may obtain credit reports concerning
27 any Defendants pursuant to Section 604(a)(1) of the Fair Credit Reporting Act, 15
28 U.S.C. § 1681b(a)(1), and that, upon written request, any credit reporting agency
from which such reports are requested shall provide them to the FTC.

REPATRIATION OF FOREIGN ASSETS

IX. IT IS FURTHER ORDERED that, within five (5) business days following the service of this Order, each Defendant shall:

- A. Provide counsel for the FTC with a full accounting of all assets, accounts, funds, and documents outside of the territory of the United States that are held either: (1) by them; (2) for their benefit; (3) in trust by or for them, individually or jointly; or (4) under their direct or indirect control, individually or jointly;
- B. Transfer to the territory of the United States all assets, accounts, funds, and documents in foreign countries held either: (1) by them; (2) for their benefit; (3) in trust by or for them, individually or jointly; or (4) under their direct or indirect control, individually or jointly;
- C. Hold and retain all repatriated assets, accounts, funds, and documents, and prevent any transfer, disposition, or dissipation whatsoever of any such assets, accounts, funds, or documents; and
- D. Provide the FTC access to all records of accounts or assets of the Corporate Defendants and Individual Defendants held by financial institutions located outside the territorial United States by signing the Consent to Release of Financial Records attached to this Order as **Attachment C**.

NON-INTERFERENCE WITH REPATRIATION

X. IT IS FURTHER ORDERED that Defendants, their officers, agents, employees, and attorneys, and all other persons in active concert or participation with any of them who receive actual notice of this Order by personal service or otherwise, whether acting directly or indirectly, are hereby temporarily restrained and enjoined from taking any action, directly or indirectly, which may result in the encumbrance or dissipation of foreign assets, or in the hindrance of the repatriation required by Section IX of this Order, including but not limited to:

- A. Sending any statement, letter, fax, e-mail or wire transmission, telephoning or engaging in any other act, directly or indirectly, that results in a

1 determination by a foreign trustee or other entity that a “duress” event has
2 occurred under the terms of a foreign trust agreement, until such time that
3 all assets have been fully repatriated pursuant to Section IX of this Order;
4 and

- 5 B. Notifying any trustee, protector or other agent of any foreign trust or other
6 related entities of either the existence of this Order, or of the fact that
7 repatriation is required pursuant to a Court Order, until such time that all
8 assets have been fully repatriated pursuant to Section IX.

9 **FTC ACCESS TO BUSINESS PREMISES AND RECORDS**

10 **XI. IT IS FURTHER ORDERED** that:

- 11 A. The FTC and the FTC’s representatives, agents, contractors, or assistants, are
12 permitted and the Defendants shall allow immediate access to any business
13 premises and storage facilities of Defendants. Such locations may include, but
14 are not limited to, any location where Defendants conduct business, sales
15 operations, fulfillment or processing, or customer service operations.
16 Defendants shall allow the FTC into the premises and facilities described in
17 this Section and shall allow the FTC and its representatives, agents,
18 contractors, or assistants to inspect, inventory, and copy documents relevant to
19 any matter contained in this Order.
- 20 B. Counsel for the FTC may exclude Defendants and their agents and employees
21 from the business premises and facilities during the immediate access, but in
22 no event shall such exclusion exceed 48 hours.
- 23 C. Defendants and all agents or employees of Defendants shall provide counsel
24 for the FTC with any necessary means of access to documents, including,
25 without limitation, the locations of Defendants’ business premises, keys and
26 combinations to business premises locks, computer access codes of all
27 computers used to conduct Defendants’ business, and storage area access
28 information.

- 1 D. If any property, records, documents, or computer files relating to the
2 Defendants' finances or business practices are located in the residence of any
3 Defendant or are otherwise in the custody or control of any Defendant, then
4 such Defendant shall produce them to counsel for the FTC within twenty-four
5 (24) hours of service of this Order. In order to prevent the destruction of
6 computer data, upon service of this Order upon Defendants, any such
7 computers shall be powered down (turned off) in the normal course for the
8 operating systems used on such computers and shall not be powered up or used
9 again until produced for copying and inspection, along with any codes needed
10 for access. Defendants are precluded from introducing in any proceeding in
11 this case any document not so produced.
- 12 E. Counsel for the FTC shall have the right to remove any documents related to
13 Defendants' business practices from the premises in order that they may be
14 inspected, inventoried, and copied. The materials so removed shall be returned
15 within five (5) business days of completing said inventory and copying.
- 16 F. In order to prevent the destruction of computer data, the FTC and the FTC's
17 representatives, agents, contractors, or assistants, are permitted and the
18 Defendants shall allow the FTC and the FTC's representatives, agents,
19 contractors, or assistants to power down (turn off) any computer in the normal
20 course for the operating system used on such computer and/or take all
21 necessary steps to prevent remote access of any such computer. Any such
22 computer powered down (turned off) or removed from remote access shall not
23 be powered up (turned on) or have remote access restored except by the FTC
24 and the FTC's representatives, agents, contractors, or assistants after they have
25 inspected and copied the contents of such computer. The FTC shall ensure that
26 all such computers are powered up (turned back on) and any remote access
27 restored within three (3) business days.
- 28 G. In the event any of Defendants' documents have been removed from
Defendants' premises by, and are in the possession of another law enforcement

1 or investigative agency, the FTC may have immediate access to such
2 documents for purposes of inspection, indexing, and copying, subject to the
3 agency consenting to access by the FTC.

4 H. The FTC'S access to the Defendants' documents pursuant to this Section shall
5 not provide grounds for any Defendant to object to any subsequent request for
6 documents served by the FTC.

7 I. The FTC is authorized to employ the assistance of law enforcement officers,
8 including, but not limited to, the United States Postal Inspection Service,
9 Internal Revenue Service, and Federal Bureau of Investigation, to effect
10 service, to implement peacefully the provisions of this Order, and keep the
11 peace.

12 **PRESERVATION OF RECORDS**

13 **XII. IT IS FURTHER ORDERED** that Defendants, their officers, agents, employees,
14 and attorneys, and all other persons in active concert or participation with any of
15 them who receive actual notice of this Order by personal service or otherwise,
16 whether acting directly or indirectly, are hereby temporarily restrained and
17 enjoined from taking any action, directly or indirectly, are hereby temporarily
18 restrained and enjoined from destroying, erasing, mutilating, concealing, altering,
19 transferring, or otherwise disposing of, in any manner, directly or indirectly, any
20 documents that relate to the business practices, or business or personal finances, of
21 any Defendant.

22 **LIMITED EXPEDITED DISCOVERY**

23 **XIII. IT IS FURTHER ORDERED** that the FTC is granted leave to conduct certain
24 expedited discovery, and that, commencing with the time and date of this Order, in
25 lieu of the time periods, notice provisions, and other requirements of Rules 26, 30,
26 34, and 45 of the Federal Rules of Civil Procedure, expedited discovery as to
27 parties and non-parties shall proceed as follows:

28 A. The FTC may, upon three (3) calendar days' notice, take the deposition of
any person or entity, whether or not a party, in any judicial district, for the

1 purpose of discovering: (1) the assets of Defendants; (2) location of
2 documents; and (3) compliance with this Order. Depositions may be
3 conducted telephonically or in person. Deposition transcripts that have not
4 been signed by the witness may be used at the preliminary injunction
5 hearing in this matter. *Provided that*, notwithstanding Federal Rule of Civil
6 Procedure 30(a)(2), this Section shall not preclude any future depositions
7 by the FTC. *Provided further*, that any deposition taken pursuant to this
8 Section shall be in addition to, and not subject to, the presumptive limits on
9 depositions set forth in Federal Rule of Civil Procedure 30(a)(2)(A).

10 B. The FTC may serve interrogatories for the purpose of discovering: (1) the
11 assets of Defendants; (2) location of documents; and (3) compliance with
12 this Order. Defendants shall respond within five (5) calendar days after the
13 FTC serves such interrogatories. *Provided that*, notwithstanding Federal
14 Rule of Civil Procedure 33(a)(1), this Subsection shall not preclude any
15 future interrogatories by the FTC.

16 C. The FTC may, upon five (5) calendar days' notice, including through the
17 use of a Rule 45 Subpoena, demand the production of documents from any
18 person or entity, whether or not a Defendant, relating to: (1) the assets of
19 Defendants; (2) the location of documents; and (3) compliance with this
20 Order. *Provided that* two (2) calendar days' notice shall be deemed
21 sufficient for the production of any such documents that are maintained or
22 stored only as electronic data.

23 D. The FTC is granted leave to subpoena documents immediately from any
24 financial institution, account custodian, or other entity or person that holds,
25 controls, or maintains custody of any account or asset of any Defendant(s),
26 or has held, controlled or maintained custody of any account or asset of any
27 Defendant(s) concerning the nature, location, status, and extent of
28 Defendants' assets, and compliance with this Order, and such financial

institution, account custodian or other entity shall respond to such subpoena within five (5) business days after service.

E. For purposes of discovery pursuant to this Section, service shall be sufficient if made by facsimile or by overnight courier.

SERVICE OF THIS ORDER

XIV. IT IS FURTHER ORDERED that copies of this Order may be served by facsimile transmission, personal or overnight delivery, or U.S. Express Mail, by agents and employees of the FTC or any state or federal law enforcement agency or by private process server, on Defendants or any other persons or entities that may be subject to any provision of this Order.

DISTRIBUTION OF ORDER BY DEFENDANTS

XV. IT IS FURTHER ORDERED that within three (3) calendar days after service of this Order, Defendants shall provide a copy of this Order to each of their agents, employees, directors, officers, subsidiaries, affiliates, attorneys, independent contractors, representatives, franchisees, and all persons in active concert or participation with Defendants. Within five (5) calendar days following this Order, Defendants shall provide the FTC with an affidavit identifying the names, titles, addresses, and telephone numbers of the persons that Defendants have served with a copy of this Order in compliance with this provision.

(3) "in any (. . . statement under penalty of perjury as permitted under section 1746 of title 28, United States Code) in any proceeding before or ancillary to any court or grand jury of the United States knowingly makes any false material declaration or makes or uses any other information . . . knowing the same to contain any false material declaration" (18 U.S.C. § 1623).

For a felony conviction under the provisions cited above, federal law provides that the fine may be not more than the greater of (i) \$250,000 for an individual or \$500,000 for a corporation, or (ii) if the felony results in pecuniary gain to any person or pecuniary loss to any person other than the defendant, the greater of twice the gross gain or twice the gross loss. 18 U.S.C. § 3571.
