



27 Plaintiff, the Federal Trade Commission ("FTC"), having applied for an
28 order directing that all pleadings and other documents submitted to, or issued by,

[PROPOSED] ORDER SEALING FILE

1 the Court in the above-captioned case be temporarily filed under seal, and good
2 cause appearing therefor,

3 **IT IS HEREBY ORDERED** that the entire file in this action, including
4 Plaintiff's Complaint, *Ex Parte* Application for Temporary Restraining Order and
5 Other Equitable Relief, Supporting Memorandum of Points and Authorities,
6 exhibits, and proposed Temporary Restraining Order ("TRO"), and all other
7 materials filed by Plaintiff in connection with the TRO Application, and any order
8 issued by the Court, be filed under seal and that the file remain sealed for 72 hours
9 after the Court has ruled on the TRO or until Defendants are served, whichever
10 occurs first. No further order of the Court shall be necessary for the Clerk of Court
11 to unseal the file.

12 *Provided, however,* that this Order shall not be construed to prohibit Plaintiff
13 or its attorneys or agents from disclosing the existence of this lawsuit, its
14 application for a TRO, or the contents of documents filed or lodged in connection
15 therewith to process servers, law enforcement personnel, and other third parties to
16 the extent necessary to prepare for and effectuate service of process on the
17 Defendants.

18 **IT IS SO ORDERED.**
