Plaintiff, the Federal Trade Commission (the "Commission), by its designated attorneys, has filed this action seeking an order preliminarily enjoining the proposed acquisition between Defendants Wilhelm Wilhelmsen and Wilhelmsen Maritime Services AS (collectively "Wilhelmsen") and Resolute Fund II, L.P., Drew Marine Intermediate II B.V., and Drew Marine Group, Inc. (collectively "Drew") as a violation of Section 5 of the Federal Trade Commission Act, 15 U.S.C. § 45, and Section 7 of the Clayton Act, 15 U.S.C. § 18. The parties have stipulated to a temporary restraining order under which Defendant Wilhelmsen will not

consummate any acquisition of any stock, assets, or other interest, of Defendant Drew until after 11:59 PM Eastern Time on the third business day after the Court rules on Plaintiff's motion for a preliminary injunction. By this motion, Plaintiff respectfully moves the Court for an order entering the temporary restraining order stipulation on the record. Defendants have agreed to the stipulation and do not oppose the motion.
