**ORDER GRANTING UNOPPOSED MOTION OF NONPARTIES  
TO EXTEND THE TIME TO FILE A MOTION TO QUASH,  
OR IN THE ALTERNATIVE TO LIMIT, SUBPOENAS**

On October 22, 2014, nonparties Independent Doctors of Georgia, Inc., North Albany Medical Center, LLC, G. Edward Alexander, Dr. J. Price Corr, Jr., Albany Surgical PC, Dr. Joseph W. Stubbs, Albany Internal Medicine, PC, McGuireWoods, LLP, and Victor Moldovan (collectively “the nonparties”) filed an Unopposed Motion to Extend the Time to File a Motion to Quash, or in the Alternative to Limit, Subpoenas served on them (“Motion”). The subpoenas at issue were served by counsel for Respondents Phoebe Putney Memorial Hospital, Inc., Phoebe Putney Health System, Inc. (collectively, “Phoebe”) on October 3, 2014 (“Subpoenas”).

The Motion requests an extension of the applicable deadline to file a motion to quash and/or limit the Subpoena under FTC Rule 3.34 until October 31, 2014.<sup>1</sup> The nonparties state that they are in the process of negotiating with Respondents' counsel over the breadth of the Subpoena, and its objections thereto, in a good faith effort to comply with its obligations, while reducing the burden imposed by the Subpoena. Further, the nonparties state that Respondents' counsel does not oppose an extension of time through October 31, 2014, and that such extension will enable negotiations to continue and potentially avoid the necessity of filing a motion to quash or limit the Subpoenas.

Based on the foregoing, the Motion is GRANTED, and it is hereby ORDERED that the deadline for these nonparties to file a motion to quash, or to limit the Subpoena is extended through and including October 31, 2014.
