ORDER

AND NOW, this 8th day of December, 2017, the Court’s November 6, 2017 Order is **VACATED** and upon consideration of the Receiver’s Motion for Order Setting Claims Bar Date, Establishing Claims Procedure and Approving Notification Process (Docket No. 163), the FTC’s Objection to the Motion (Docket No. 168), and the Receiver’s Reply (Docket No. 170), it is **hereby ORDERED** that the Motion (Docket No. 163) is **DENIED**; and the Court finds and directs as follows:

1. Pennsylvania law determines the status of the assets in the receivership estate.
2. Consistent with the Court’s factual findings stated in the Court’s November 10, 2015 Memorandum (Docket No. 40), the Court finds that the assets in the receivership estate were acquired from consumer victims through fraud and other improper means.
3. In order to prevent unjust enrichment, the Court finds that the assets in the receivership estate are subject to constructive trust for consumer victims and should therefore be used for the benefit of consumer victims.
4. The Receiver shall promptly update the website maintained at www.c4sreceiver.com to include a copy of this Order and the following notification:

Click4Support, Ubertechsupport, and Click4Support Tech Services, and their affiliated businesses, including iSourceUSA, LLC, Click4Support, LLC, Spanning Source, LLC, and Innovazion, Inc., are currently in receivership pursuant to a Court Order issued by the Federal District Court for the Eastern District of Pennsylvania on

November 10, 2015 and amended November 24, 2015, in the case *Federal Trade Commission et al. v. Click4Support, LLC et al.*, Civil Action No. 15-5777.

On December 8, 2017, the Court issued an Order and determined the following:

1. Pennsylvania law determines the status of the assets in the receivership estate.
2. Consistent with the Court's factual findings stated in the Court's November 10, 2015 Memorandum (Docket No. 40), the Court finds that the assets in the receivership estate were acquired from consumer victims through fraud and other improper means.
3. In order to prevent unjust enrichment, the Court finds that the assets in the receivership estate are subject to constructive trust for consumer victims and should therefore be used for the benefit of consumer victims.
