## ORDER TO SHOW CAUSE WHY RESPONDENT COUNTRYWIDE PERIODICALS, LLC SHOULD NOT COMPLY WITH FEDERAL TRADE COMMISSION CIVIL INVESTIGATIVE DEMAND

Pursuant to the authority conferred by Sections 16 and 20 of the Federal

Trade Commission Act, 15 U.S.C. §§ 56 and 57b-1, the Federal Trade

Commission ("Commission") petitions this Court, pursuant to Fed. R. Civ. P.

81(a)(5), for an order requiring respondent Countrywide Periodicals, LLC

("Countrywide") to comply in full with the May 6, 2013, Civil Investigative

Demand ("CID") issued to it in aid of a law enforcement investigation being

conducted by the Commission (FTC File No. 0123145).

The Court has considered the Commission's Petition for an Order to Enforce Civil Investigative Demand and the papers filed in support thereof; and it appears to the Court that the Commission has shown good cause for the entry of this Order. It is by this Court hereby

ORDERED that Countrywide appear at 10:30 a.m. on June 24, 2014, in United States District Court for the District of Montana, Russell Smith Courthouse, 201 East Broadway in Missoula, Montana, and show cause, if any there be, why this Court should not grant said Petition and enter an Order enforcing the CID issued to Countrywide and directing it to produce all responsive documents and information in compliance with the CID within ten days of the receipt of the Court's enforcement order. Unless the Court determines otherwise, notwithstanding the filing or pendency of any procedural or other motions, all issues raised by the Petition and supporting papers, and any opposition to the Petition, will be considered at the hearing on the Petition, and the allegations of said Petition shall be deemed admitted unless controverted by a specific factual showing.

IT IS FURTHER ORDERED that, if Countrywide believes it necessary for the Court to hear live testimony, it shall on or before June 12, 2014, serve and file

the names of those witnesses it would call to testify, a summary of the substance of the witnesses anticipated testimony and explain why Countrywide believes live testimony is required.

IT IS FURTHER ORDERED that, if Countrywide intends to file pleadings, affidavits, exhibits, motions or other papers in opposition to said Petition or to the entry of the Order requested therein, such papers must be filed with the Court and received by Petitioner's counsel by 5:00 p.m. on June 12, 2014. Such submission shall include, in the case of any affidavits or exhibits not previously submitted, or objections not previously made to the Commission, an explanation as to why such objections were not made or such papers or information not submitted to the Commission. Any reply by the Commission shall be filed with the Court and received by Countrywide by 5:00 p.m. on June 17, 2014.

IT IS FURTHER ORDERED, pursuant to Fed. R. Civ. P. 26(a)(1)(B)(v) and 81(a)(5), that this is a summary proceeding and that no party shall be entitled to discovery without further order of the Court upon a specific showing of need; and that the dates for a hearing and the filing of papers established by this Order shall not be altered without prior order of the Court upon good cause shown; and

IT IS FURTHER ORDERED, pursuant to Fed. R. Civ. P. 81(a)(5), that a certified copy of this Order and copies of said Petition and Memorandum in

support thereof filed herein, be served forthwith by the Commission upon Countrywide or its counsel by personal service, or by certified or registered mail with return receipt requested, or by overnight express delivery service.
