ENFORCEMENT OF NONPARTY SUBPOENAS**

Respondent Axon Enterprise Inc. withdraws its request for the Commission to seek court enforcement of nonparty subpoenas. On August 21, 2020, Axon filed a Motion for Certification to the Commission of Request for Court Enforcement of Nonparty Subpoenas.
