**JOINT MOTION OF THIRD-PARTY PERELLA WEINBERG PARTNERS LP AND  
COMPLAINT COUNSEL TO EXTEND BRIEFING SCHEDULE ON  
MOTION TO LIMIT SUBPOENA**

Pursuant to Rule 4.3(b) of the FTC Miscellaneous Rules, third-party Perella Weinberg Partners LP (“PWP”) and Complaint Counsel jointly seek to extend by one week the briefing schedule deadlines on PWP’s motion to limit the Subpoena Duces Tecum issued by Complaint Counsel to PWP, dated September 17, 2020 (the “Subpoena”).

By order dated October 5, 2020, the Administrative Law Judge granted in part PWP and Complaint counsel’s joint motion for a briefing schedule and set October 9, 2020, as the date for PWP to move to limit the subpoena; October 16, 2020, as the date for Complaint Counsel’s response; and October 21, 2020, as the date for PWP to file any motion to request leave to file any reply and to file any such proposed reply. PWP’s counsel and Complaint Counsel have continued to meet and confer regarding the Subpoena and believe that continuing such discussions may obviate the need for motion practice.

WHEREFORE, PWP and Complaint Counsel respectfully request that the Administrative Law Judge enter the attached Proposed Order granting PWP an extension until October 16, 2020,

to file a motion to limit the Subpoena; setting October 23, 2020, as the deadline for Complaint Counsel's response; and setting October 28, 2020, as the deadline for PWP's motion to request leave to file a reply and reply, if any.
