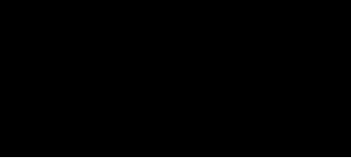

Jerk.com was the first website defining the category of anti-social networks on the internet. On facebook.com internet users were able to tell the world about themselves. Jerk.com search engine was the first web site to popularize posting about others without their consent. This created controversy by focusing on gossip, rumors, and rants related to colleges and [universities in the United States](http://en.wikipedia.org/wiki/University)

and quickly grew globally after a New York Times article about the use of the Internet to harass heating spouses in china. <http://www.nytimes.com/2006/06/03/world/asia/03china.html> As of Jan 1, 2009, it had grown to over 5 million profiles surpassing Juicy Campus who had shut down as the leading fastest growing site in the newly emerging online reputation space. As of Jan 1, 2010, it had grown to over 80 million profiles and had been adopted by Google as the number one site for reputation info on people search.

Jerk.com described itself as The worlds authority on who is or is not a jerk and relied heavily on the communications decency act and the right to post "online anonymous free speech on the web." Among the first sites on the internet to abandoned the notion of privacy it allowed users to post messages and comments without having to worry about identification or retribution. On the site users were able to post anything, and often did including photos, cell phone numbers, email addresses and very descriptive personal stories some might have preferred not published. These rights were further supported by the courts in several legal cases filed against "The ripoff report". In those cases the courts because awarding costs and damages against people who filed lawsuits against the ripoff report without regard to the immunity provisions of the communications decency act.

The creator of JuicyCampus, identified in an article in [The Chronicle of Higher Education](http://en.wikipedia.org/wiki/The_Chronicle_of_Higher_Education) as [Duke University](http://en.wikipedia.org/wiki/Duke_University) alumna named [REDACTED],^[3] described the website as within a trend of "gossip 2.0." The 2005 Duke graduate said that he sees the trend as "pretty entertaining."^[1] [REDACTED], chief information officer of Pepperdine University, described the purpose of JuicyCampus in a letter written to Google as to create a "virtual bathroom wall" for abusive, degrading, and hateful speech."^[3]

The website began operation in August 2007^[3], and was closed indefinitely on February 5, 2009 due to lack of revenue.

It was initially launched on just seven campuses (Duke University, Loyola Marymount University, UNC, USC, Pepperdine, UCLA and College of Charleston).

On December 8, 2007 from a computer at [Loyola Marymount University](http://en.wikipedia.org/wiki/December_8,_2007), a student allegedly posted a threat to "shoot random students on the campus' Alumni Mall". The quote read, "I am going to shoot and kill as many people as I can until which time I am incapacitated or killed by the police." The [Los Angeles Police Department](#) apprehended the suspect. The police released the suspect without filing charges. The message was originally posted on the website 4chan.^{[4][5][6]} In addition, in March 2008 an individual allegedly posted a message described by *The New York Times* as "wondering if he could get his classes canceled by starting a shooting spree." Police found [Colgate University](#) junior [REDACTED], arrested him, charged him with second-degree aggravated harassment, and released him on \$1,000 bail.^[7]

JuicyCampus has received much media attention for not censoring the content posted by its users. CNN released an article documenting the anonymous rumors on the website and the panic supposedly felt by some students.^[8]

██████████, the site's creator, has done numerous interviews defending the website.^[9] ██████████, the vice president for student affairs at Duke University said that when asked ██████████ to moderate the website ██████████ refused and indicated that he believes moderation is an unnecessary step toward censorship.^[3] *The Chronicle of Higher Education* said that "the site revels in the publicity it gets" and that the website keeps a list of websites, including those that are critical of *JuicyCampus* in a [blog](http://en.wikipedia.org/wiki/Blog).^[2] Ivester, a 2005 Duke graduate, said on this website's official blog that "Hate isn't juicy," encouraging users to think carefully about what they were writing and whether their posts were entertaining or just plain mean.^[1]

In January 2008 the undergraduate student government at [Pepperdine University](http://en.wikipedia.org/wiki/Pepperdine_University) passed a resolution asking for a block on the site.^[3] ^[10] The administration did not enact the block. ██████████, a Pepperdine senior who wrote the resolution, said that he felt that the move was "a mistake" as it increased awareness of the website.^[1] The administration of Pepperdine complained to [Google](http://en.wikipedia.org/wiki/Google); ██████████, a Google spokesman, said that Google removed *JuicyCampus* from its advertising network due to "excessive profanity." By January, 2008, *JuicyCampus* moved to another advertising network.^[3] [Texas Christian University](http://en.wikipedia.org/wiki/Texas_Christian_University) students asked advertisers to not buy space on the website.^[10] In November 2008, officials at [High Point University](http://en.wikipedia.org/wiki/High_Point_University) requested that the website remove the school from its servers. When JuicyCampus refused, the University blocked the site from its campus network.^[11] During the same month [Tennessee State University](http://en.wikipedia.org/wiki/Tennessee_State_University) (TSU) blocked JuicyCampus. ██████████ criticized the decision and compared it to [the People's Republic of China](http://en.wikipedia.org/wiki/Internet_censorship_in_the_People%27s_Republic_of_China)'s internet censorship.^[12] The [American Civil Liberties Union](http://en.wikipedia.org/wiki/American_Civil_Liberties_Union) criticized the decision. JuicyCampus filed a lawsuit against TSU and asked students to join the suit.^[13]

In October 2008, The GW Patriot and "The Colonialist," two student blogs at [The George Washington University](http://en.wikipedia.org/wiki/The_George_Washington_University) called for students to spam the university's JuicyCampus page in order to fill the site with irrelevant material. Their goal was to reduce the forum's popularity on campus.^{[14][15][16]}

Throughout its tumultuous life JuicyCampus itself was never sued for its content. Moreover, the site was never forced to reveal a user's IP address as a result of a claim of defamation.^[citation needed]

On February 4, 2009, JuicyCampus released a statement stating the website will no longer be able to operate due to economic conditions. Juicycampus ceased operations on February 5, 2009 because of financial problems, specifically an inability to turn a profit.^[17]

When you ask the user to login into their FaceBook account to find friends, auto sync FaceBook and auto create track me links between all the FaceBook friends. Auto generate profiles for FaceBook friends who are not in the system already.

Use the API's provided by FaceBook to accomplish this.

DO THE SAME THING FOR MYSPACE AND TWITTER

Using "People that I Know", then clicking on preferred social network you can import contacts from Facebook, Twitter, MySpace. For user's imported friends, the platform creates profiles with their names and pictures and they will be added to the user's friends list (if user is logged-in).

=====
Make suggestions to the user of who they might want to follow based upon who the people the user is following is following.

EXAMPLE:

USER1=====>USER2=====>USER3

User 1 is following user 2 and user 2 is following user 3. So the system will suggest to user 1 to follow user 3 and for user 3 to follow user 1, with user 2 being the common

denominator. This should provide infinite suggestions to user. Then also make suggestions to the user based upon another user not connected directly as a common denominator, but based upon having multiple "Tracked Followers" in common.

On user's following page it was created an additional box with "People that <user> may know" established based on above formulas. More than that, it will be added the users who interacted in any way with the logged-in user (those who commented on his profile, or those on whose profile he commented).

Attach a user's twitter, FaceBook, and Myspace account to their Jerk.com Profile. This way, when a post is made on the user's jerk.com profile it sends out a message to the user:

"Someone you know just posted something behind your back. See what they said (Link) www.jerk.com/user or say something public behind someone you knows back. (Link) www.jerk.com/search"

In addition, jerk.com should aggregate the posts being posted on the user's twitter, FaceBook, and Myspace and auto adding the information to Jerk.com user profile.

THIS CAN BE ACCOMPLISHED USING THE API'S FROM FACEBOOK AND MYSPACE AND TWITTER.

Not now, but later, all actual posts on jerk.com should be submitted to the user's Facebook and Myspace walls.

On the user's profile page, if he is logged-in, there are 3 buttons to connect to social networks.

For Facebook and Twitter, it is possible "one time log-in". It means that after first log-in, information from the walls of these 2 social networks will be automatically transferred on Jerk.com each time when the user will visit his profile.

For MySpace, due its particular API, the user needs to login each time in order to bring new posts from his MySpace wall on Jerk.com. After one import, the button becomes unavailable 24hours.

The voting should be an aggregated calculation vote across the board for Jerk of the day. So although 100% of the user's posters voted that user is a Jerk, that Jerk may have only received 2% of the total amount of votes in real time. Not yet!

NOTES:

Doing all of the above will create a snowball effect causing the users to continue to return. (It makes the site sticky).

We are still working on the getting the first real push.

ALSO!!! Implement SEO. Make the site as search engine friendly as possible. Plug in the bots for all of the major engines to crawl the site. In addition, we need to start the tweets. The more links back to Jerk.com will make the site more favorable for search engine results. Also, need to create a wikipedia page, linked page, FaceBook fan page, etc...
