

## Google Analytics Overview for Jerk.com

### Executive Summary


- Total visitation to Jerk.com has been experiencing exponential growth since April 2011.
- In the past few weeks there has been a huge increase in new visitors to the site.
- Although visitation has been increasing, people have consistently spent less than a minute on the Jerk.com website. It is not engaging them sufficiently to interact with the site for long periods of time.
- There are low levels of participant loyalty associated with Jerk.com.
- The vast majority of users only ever visit the site once.
- Bounce rates for the website are consistently relatively low. Users generally click through three or four times before leaving the interface.
- Most of the traffic for Jerk.com originates from search engines. It is therefore important for the website to incorporate more effective SEO strategies.

### Detailed Findings

#### Visitor Overview

In the past 12 months, visitation of Jerk.com has been relatively steady up until March 2011 when demand began to increase at an exponential rate.

- October 10 - 16 2010 - 13,332 visitors
- December 12 - 18 2010 - 13,635 visitors
- May 1 - 7 2011 - 20,571 visitors
- June 5 - 11 2011 - 35,633 visitors



Website footprint has grown enormously since April 2011. In the past 3 months average visitation has increased consistently and reached its peak in the week commencing June 5th.

In the past month, Jerk.com has experienced an increase in the absolute unique visitation to their website. The number of pages viewed has also increased, skyrocketing within the past week.

However, average time on the website has remained consistent throughout the past month. Although more people are accessing the website, but they are not interacting with it for any more time.





In the past month 131,852 people have visited the Jerk.com website. 88.56% of these individuals were new visitors, meaning the site has broadened its appeal to a massive degree (probably due to the new domain name and improved optimization).

## Bounce Rate

Since March 2011, when the Bounce Rate for Jerk.com was averaging over 80%, the figure has decreased and stabilized at around 9%. This means that 9% of people who visit the website navigate away immediately.

Almost 90% of people who visited the Jerk.com in the past month decided to never frequent the website again. Customer loyalty levels are clearly very low, which indicates that people have no reason to interact with the website on a regular basis. During this period, only 2.94% of visitors frequented the site more than 5 times.

It is important to note that customer loyalty has remained consistently low for Jerk.com over the course of their existence. Since 2009, more than 88% of visitations were one-off occurrences.

I, [REDACTED], declare and state as follows:

1) In approximately June or July 2010 John Fanning ("Fanning" or "John Fanning"), the named respondent in this action, approached me to work on NetCapital's project Reper and to generally consult around the future of reputation online technology. In or around June 2010, I received an email from Fanning from the email address of john [REDACTED]. In the email, John Fanning asked me to meet with him and his colleague to join his team or generally help with the project in some way. Before receiving that email I did not know Fanning. In response, I agreed to meet with Fanning. Fanning hired me to work on Reper under a consulting agreement. I produced a copy of that consulting agreement to the FTC in response to a subpoena the FTC served on me. The consulting agreement can be found at Bates range [REDACTED]001058 to 001062.

2) I worked for John Fanning on Reper and eventually Zelgor for approximately a year and a half. As part of my work I learned of Jerk.com, another project. According to Fanning, Jerk.com was intended to be a reputation website. It was a chance for people to review other individuals that they knew. Fanning appeared to be in charge of Reper.com and Jerk.com. For example, he seemed to make the hiring decisions as well as be generally in charge.

3) In the course of working for Fanning I communicated with him extensively by email. The email address that Fanning always used with me was john [REDACTED]. I sent numerous emails to Fanning at that address, and I received numerous emails from that address that I understood to have come from Fanning. Fanning and I occasionally discussed the contents of those emails by telephone and/or in person. Fanning never instructed me to call or otherwise alert him when I was sending him emails at the john [REDACTED] address.

5) Based on Fanning's representations to me I understood that john [REDACTED] was Fanning's email address; I have no reason, and never had any, to believe that any email I received from that address was sent by anyone other than John Fanning, and I have no reason, and never had any, to believe that any email sent to that email address would be received by anyone other than John Fanning.

6) The FTC sent me a subpoena in this action seeking documents relating to Jerk LLC, Reper LLC, Jerk.com, Reper.com, and John Fanning relating to reputation online

technology. In response to that subpoena, I produced true and accurate copies of emails sent to me from john [REDACTED] and sent by me to that address. I understand that all the emails sent by me to john [REDACTED] were being sent to Fanning, and that all the emails sent to me (or copying me) from john [REDACTED] were being sent by Fanning.





LEASE WITH OPTION TO PURCHASE AGREEMENT

This Lease with Option to Purchase Agreement ("Agreement") is entered into as of the 1st day of February 2011, by and between [REDACTED], with a place of business at [REDACTED], (the "Seller") and Jerk LLC, (the "Buyer").

WHEREAS, Seller is the owner/registrant of all rights, including trademark rights and annotated goodwill, of the registered domain name "Jerk.com" ("Domain Name"); and WHEREAS, Seller desires to sell all rights, title and interests in and to the Domain Name; and WHEREAS, Buyer desires to acquire any and all rights, including trademark rights and annotated goodwill, in and to the Domain Name; and

WHEREAS, Buyer desires to lease with an option to purchase the Domain Name; and NOW, THEREFORE, in consideration of the mutual covenants, and promises contained herein, the parties agree as follows:

1. Grant of Rights to Domain Name. Seller owns all rights, title and interests, including trademark rights and annotated good will, in and to the Domain Name. In accordance with this Agreement, and for good and valuable consideration specified below, Seller shall transfer all rights to the Domain Name to Buyer.
2. Lease. Buyer agrees to lease, for a minimum of 12 months, for a maximum of seventy (72) months, the use of the Domain Name. Buyer will pay to Seller the sum of twenty five hundred dollars (\$2,500) per month to the Seller for such use of the Domain Name on the first day of each month this Agreement is in effect. In the event payment is not made within (10) days of the date when due, Buyer shall pay seller a late fee of ten percent (10%). Buyer may terminate the lease at any time after 12 months, upon fifteen (15) days written notice to Seller. At any time after 12 months, during the seventy two (72) month period, Buyer in his sole discretion may elect to purchase the Domain Name. No sums paid pursuant to the lease provision of this Agreement will apply to the purchase price of the Domain Name, and title to the Domain Name shall remain with Seller.
3. Purchase. Within (3) days of notice of Buyer's election to purchase the Domain Name, Seller shall execute an assignment of the Domain Name in the form attached hereto as Exhibit A. Buyer will pay to Seller a fee of three hundred thousand dollars (\$300,000), at such time as the Domain Name is transferred from Assignor to Assignee by Enom Registrar in the Domain Name System. This payment will be made by company check, Money Order, or Cashier's Check and will be placed in an escrow, selected by Buyer, at such time as Buyer gives notice of Buyer's election. All escrow fees will be paid by Buyer and Seller equally.
4. Additional Fees. Buyer may be required to pay an additional fee to seventy dollars (\$70) to the domain registrar for changes to the registered domain name holder record.
5. Transfer. Within three (3) days of request by Buyer, Seller agrees to execute without further consideration, any and all further documents and instruments which may be necessary to effectuate the reassignment of the registered domain name, including a notice to Enom that conforms to Enom's requirements to effectuate the transfer of the Domain Name from Seller to Buyer.
6. Representations and Warranties. Seller hereby represents, warrants and covenants to Buyer as follows. Each of the statements contained in this Section 6 is true and correct in all respects of the date hereof and will be true and correct in all respects at the Closing with the same force and effect as if made at and as of such time. The Seller represents and warrants to the Buyer the following:
  - (a) Title to Domain Name. Seller owns and has good, valid and marketable title to all of the Domain Name, including all trademark rights and annotated goodwill. The Domain Name is owned by Seller free and clear of any and all encumbrances and rights and after Closing, Buyer will have good, valid and marketable title to them free and clear of any and all

Encumbrances and rights.

(b) Authorization. The seller has all necessary power and authority to execute, deliver and perform the Agreement and the other transaction documents to which it is a party.

7. Defaults. If either party fails to abide by the obligations of this Agreement, including but not limited to, any obligation to make payment or assign title, the other party shall have the option to cancel this Agreement by providing thirty (30) days written notice to such defaulting party. Each party shall have the option of preventing the termination of the Agreement by taking corrective action that cures the default, if such corrective action is taken prior to the end of the time period stated in the previous sentence, and if there are no other defaults during such time period.

8. Arbitration. All disputes under this Agreement that cannot be resolved by the parties shall be submitted to arbitration under the rules and regulations of the American Arbitration Association in Los Angeles. Either party may invoke this paragraph after providing thirty (30) days written notice to the other party. All costs of arbitration shall be divided equally between the parties. Any award may be enforced by a court of law.

9. Transfer Of Rights. This Agreement shall be binding on any successors of the parties.

10. Entire Agreement. This Agreement contains the entire agreement of the parties and there are no promises or conditions in any other agreement whether oral or written. This Agreement supersedes any prior written or oral agreements between the parties.

11. Amendment. This Agreement may be modified or amended, if the amendment is made in writing and is signed by both parties.


12. Severability. If any provision of this Agreement shall be held to be invalid or unenforceable for any reason, the remaining provisions shall continue to be valid and enforceable. If a court finds that any provision of this Agreement is invalid or unenforceable, but that by limiting such provision it would become valid or enforceable, then such provision shall be deemed to be written, construed, and enforced as so limited.

13. Waiver of Contractual Right. The failure of either party to enforce any provision of this Agreement shall not be construed as a waiver or limitation of that party's right to subsequently enforce and compel strict compliance with every provision of this Agreement.

14. Applicable Law. This Agreement shall be governed by the laws of the State of California.

Your email below is false. You have misrepresented the terms of the agreement.

Today, I learned that you have redirected the domain name [jerk.com](http://jerk.com) to content that you have apparently created. In October of 2012 I sent you written notice that I represent Jerk LLC and that you should direct all future communication under the agreement to me and no other parties. Jerk LLC requested a complete accounting of the payments made and the payments due under the agreement. Jerk LLC requested changes to the host records of Jerk.com which it was entitled to control under the agreement. Jerk LLC requested copies of all correspondence you intercepted regarding [jerk.com](http://jerk.com) and other correspondence to determine the severity of confidentiality and security breach.

You failed to act, follow up, or even respond for over 9 months, at which point you communicated with John Fanning instead of me. Your conduct today constitutes interference with business, misappropriation of intellectual property, and breach of contract.

Jerk, LLC demands that you take immediate steps to provide and restore full access and control as required under the agreement or it will file a lawsuit against you for damages, attorney fees and injunctive relief preventing your further interference. I will be calling you in the morning to propose a resolution and it is in your best interest to take my call.

Dear ██████████:

This is in response to your letter of December 27, 2012 which was received in my office on January 18, 2013 after being routed from the statutory agent of Jerk.com. You have requested that my client respond to a complaint filed by ██████████

Initially, I note that Jerk, LLC is a Delaware company and has no contacts with the state of Connecticut that would subject it to jurisdiction there.

Substantively, the complaint alleges that the photograph in a post on my client's website is copyright protected and that Jerk.com violated the Digital Millennium Copyright Act. Jerk.com is in compliance with the DMCA. I am its designated agent for notice and the website promptly removes material that is the subject of a valid DMCA notice. If I had received a valid DMCA notice from ██████████, the allegedly infringing content will be promptly removed. The statement in the complaint that Jerk.com does not reveal contact information is false. The designated DMCA contact information is listed with the Copyright Office, which is what is required by statute.

The complaint also states that the post damages ██████████'s reputation. Pursuant to the First Amendment of the United States Constitution, the post is protected free speech. Moreover, Jerk, LLC operates the forum, but the content is provided by users. The Communications Decency Act, 47 U.S.C. § 230(c)(1) (the "CDA"), which was passed by Congress with the intent to "promote unfettered speech" on the Internet, immunizes websites from liability for user generated content. The CDA preempts any inconsistent state law; "[n]o cause of action may be brought and no liability may be imposed under any State or local law that is inconsistent with this section."

Finally, the complaint states that the photograph was taken when [REDACTED] was 14 years old. Based on this representation, the website has removed the profile. If [REDACTED]'s parent had written directly to the website, the profile would have been removed based on her age.

I am in receipt of your letter of January 14, 2013 directed to Jerk.com. First, I note that Jerk, LLC is a Delaware company and has no contacts with the state of New York that would subject it to jurisdiction there.

As far as substance, it seems that the "consumer" is unhappy because someone posted on my client's website asking whether he was a jerk. Pursuant to the First Amendment of the United States Constitution, that is protected free speech. Moreover, Jerk, LLC operates the forum, but the content is provided by users. The Communications Decency Act, 47 U.S.C. § 230(c)(1) (the "CDA"), which was passed by Congress with the intent to "promote unfettered speech" on the Internet, immunizes websites from liability for user generated content. The CDA preempts any inconsistent state law; "[n]o cause of action may be brought and no liability may be imposed under any State or local law that is inconsistent with this section."

Based upon the First Amendment and the CDA, the complaint appears to be entirely without merit.
