Dear Mr. Mauro:

This is in response to your request dated March 24, 2015, under the Freedom of Information Act seeking access to documents created by Ted Cruz while he was at the Commission, as well as his personnel file or information relating to his hiring or departure from the agency. In accordance with the FOIA and agency policy, we have searched our records as of May 21, 2015, the date we received your request in our FOIA office.

The majority of the records responsive to your request are available on the Commission's frequently requested documents page: https://www.ftc.gov/about-ftc/foia/foia-reading-rooms/frequently-requested-records.

We have located seven additional pages of responsive records. I am granting partial access to the accessible records. I am denying access to Mr. Cruz' personal information, which is exempt from release under FOIA Exemption 6, 5 U.S.C. § 552(b)(6), because individuals' right to privacy outweighs the general public's interest in seeing personal identifying information. See The Lakin Law Firm v. FTC, 352 F.3d 1122 (7th Cir. 2003).

Your request also sought a waiver of all fees. The agency's Rules of Practice specify that news media requestors will only be charged for costs incurred reproducing records in excess of 100 pages. See 16 C.F.R. § 4.8. Because we are not producing any pages, there are no fees associated with your request and your fee waiver request is moot.

If you are not satisfied with this response to your request, you may appeal by writing to Freedom of Information Act Appeal, Office of the General Counsel, Federal Trade Commission, 600 Pennsylvania Avenue, N.W., Washington D.C. 20580, within 30 days of the date of this letter. Please enclose a copy of your original request and a copy of this response. If you believe that we should choose to disclose additional materials beyond what the FOIA requires, please explain why this would be in the public interest.
