This is in response to your request dated January 13, 2017, under the Freedom of Information Act seeking access to "a copy of the names and mailing addresses of the consumers that received the refunds referenced in the Federal Trade Commission's (FTC) press release, FTC Sends Checks to Nearly 350, 000 Victims of Herbalife 's Multi-Level Marketing Scheme, and the amount of the refund that each consumer received." In accordance with the FOIA and agency policy, we have searched our records as of January 30, 2017, the date we received your request in our FOIA office.

We have located one spreadsheet responsive to your request. I am granting partial access to the responsive record, portions of which are exempt from release under FOIA Exemption 6. 5 U.S.C. § 552(b)(6). I am denying access to consumers' names and addresses and any other identifying information because individuals' right to privacy outweighs the general public's interest in seeing personal identifying information. See The Lakin Law Firm v. FTC, 352 F.3d 1122 (7th Cir. 2003).

Based on the fee provisions of the FOIA, 5 U.S.C. § 552(a)(4)(A), and the Commission's Rules of Practice, 16 CFR § 4.8 et seq., as amended, I am also enclosing an invoice for the charges we incurred for this response to your request. Failure to pay this bill promptly will result in our refusal to provide copies of accessible documents in response to future requests. If not paid within 30 days, this bill will accrue interest penalties as provided by Federal Claims Collection Standards, 31 C.F.R. § 900-904, as amended.
